[Passed March 8, 2024; in effect from passage]

1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated balance in the State Fund,
3 General Revenue, to the Department of Commerce, Division of Forestry, fund 0250, fiscal
4 year 2024, organization 0305, and the Department of Commerce, Geological and
5 Economic Survey, fund 0253, fiscal year 2024, organization 0306, by supplementing and
6 amending the appropriations for the fiscal year ending June 30, 2024.

1 WHEREAS, The Governor submitted the Executive Budget Document to the Legislature
2 on January 10, 2024, containing a statement of the State Fund, General Revenue, setting forth
3 therein the cash balance as of July 1, 2023, and further included the estimate of revenue for the
4 fiscal year 2024, less net appropriation balances forwarded and regular and surplus
5 appropriations for the fiscal year 2024, and further included recommended expirations to the
6 unappropriated surplus balance of the State Fund, General Revenue; and

1 WHEREAS, It appears from the Governor's Statement of the State Fund, General
2 Revenue, there now remains an unappropriated balance in the Treasury which is available for
3 appropriation during the fiscal year ending June 30, 2024; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2024, to fund 0250, fiscal
2 year 2024, organization 0305, be supplemented and amended by increasing an item of
3 appropriation as follows:
