AN ACT making a supplementary appropriation from the balance of moneys remaining unappropriated for the fiscal year ending the thirtieth day of June, two thousand seven, to a new item of appropriation designated to Miscellaneous Boards and Commissions - Board of Pharmacy, fund 8857, fiscal year 2007, organization 0913, supplementing and amending chapter six, Acts of the Legislature, regular session, two thousand six, known as the Budget Bill.

WHEREAS, The Governor has established that there remains an unappropriated balance in the Miscellaneous Boards and

Commissions - Board of Pharmacy, fund 8857, fiscal year 2007, organization 0913, available for expenditure during the fiscal year ending the thirtieth day of June, two thousand seven, which is hereby appropriated by the terms of this supplementary appropriation bill; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That chapter six, Acts of the Legislature, regular  
2 session, two thousand six, known as the Budget Bill, be  
3 supplemented and amended by adding to Title II,  
4 section six thereof, the following:






