23	Be it enacted by the Legislature of West Virginia:

- 8 CHAPTER 5. GENERAL POWERS AND AUTHORITY OF THE GOVERNOR,
- 9 SECRETARY OF STATE AND ATTORNEY GENERAL; BOARD
- OF PUBLIC WORKS; MISCELLANEOUS AGENCIES, COMMISSIONS,
- 11 OFFICES, PROGRAMS, ETC.
- 12 ARTICLE 16. WEST VIRGINIA PUBLIC EMPLOYEES INSURANCE ACT.
- 13 §5-16-7. Authorization to establish group hospital and surgical 14 insurance plan, group major medical insurance plan, 15 group prescription drug plan and group life and 16 accidental death insurance plan; rules for administration of plans; mandated benefits; what plans 17 may provide; optional plans; separate rating for 18 19 claims experience purposes.
- (a) The agency shall establish a group hospital and surgical insurance plan or plans, a group prescription drug insurance plan or plans, a group major medical insurance plan or plans and a group life and accidental death insurance plan or plans for those employees herein made eligible, and to establish and promulgate rules for the administration of these plans, subject to the

- 1 limitations contained in this article. Those plans shall include:
- 2 (1) Coverages and benefits for X ray and laboratory services
- 3 in connection with mammograms when medically appropriate and
- 4 consistent with current guidelines from the United States
- 5 Preventive Services Task Force; pap smears, either conventional or

- 15 (2) Annual checkups for prostate cancer in men age fifty and 16 over:
- 17 (3) Annual screening for kidney disease as determined to be
- 18 medically necessary by a physician using any combination of blood
- 19 pressure testing, urine albumin or urine protein testing and serum
- 20 creatinine testing as recommended by the National Kidney
- 21 Foundation:
- 22 (4) For plans that include maternity benefits, coverage for
- 23 inpatient care in a duly licensed health care facility for a mother
- 24 and her newly born infant for the length of time which the
- 25 attending physician considers medically necessary for the mother or
- 26 her newly born child: Provided, That no plan may deny payment for

- 1 a mother or her newborn child prior to forty-eight hours following 2 a vaginal delivery, or prior to ninety-six hours following a 3 caesarean section delivery, if the attending physician considers
- 4 discharge medically inappropriate;
- 5 (5) For plans which provide coverages for post-delivery care 6 to a mother and her newly born child in the home, coverage for 7 inpatient care following childbirth as provided in subdivision (4) 8 of this subsection if inpatient care is determined to be medically 9 necessary by the attending physician. Those plans may also 10 include, among other things, medicines, medical equipment, 11 prosthetic appliances and any other inpatient and outpatient 12 services and expenses considered appropriate and desirable by the 13 agency; and
- 14 (6) Coverage for treatment of serious mental illness.
- 15 (A) The coverage does not include custodial care, residential 16 care or schooling. For purposes of this section, "serious mental 17 illness" means an illness included in the American Psychiatric 18 Association's diagnostic and statistical manual of mental 19 disorders, as periodically revised, under the diagnostic categories 20 or subclassifications of: (i) Schizophrenia and other psychotic 21 disorders; (ii) bipolar disorders; (iii) depressive disorders; (iv) 22 substance-related disorders with the exception of caffeine-related 23 disorders and nicotine-related disorders; (v) anxiety disorders; 24 and (vi) anorexia and bulimia. With regard to any covered 25 individual who has not yet attained the age of nineteen years, 26 "serious mental illness" also includes attention deficit

- 1 hyperactivity disorder, separation anxiety disorder and conduct 2 disorder.
- (B) Notwithstanding any other provision in this section to the contrary, in the event that the agency can demonstrate that its total costs for the treatment of mental illness for any plan exceeded two percent of the total costs for such plan in any experience period, then the agency may apply whatever additional cost-containment measures may be necessary, including, but not limited to, limitations on inpatient and outpatient benefits, to maintain costs below two percent of the total costs for the plan for the next experience period.
- (C) The agency shall not discriminate between medical-surgical 12 13 benefits and mental health benefits in the administration of its With regard to both medical-surgical and mental health 15 benefits, it may make determinations of medical necessity and 16 appropriateness, and it may use recognized health care quality and 17 cost management tools, including, but not limited to, limitations 18 on inpatient and outpatient benefits, utilization review, case 19 management, implementation of cost-containment 20 preauthorization for certain treatments, setting coverage levels, 21 setting maximum number of visits within certain time periods, using 22 capitated benefit arrangements, using fee-for-service arrangements, 23 using third-party administrators, using provider networks and using 24 patient cost sharing in the form of copayments, deductibles and 25 coinsurance.
