15 **CLAIMS AGAINST THE STATE.**

16 **§1. Finding and declaring certain claims against the Attorney**
17 **General; Department of Environmental Protection; Department**
18 **of Health and Human Resources; Department of Health and**
19 **Human Resources/Bureau for Public Health; Division of**
20 **Corrections; Division of Highways; Educational Broadcasting**
21 **Authority; Public Service Commission; Regional Jail and**
22 **Correctional Facility Authority and the State Tax**
23 **Department to be moral obligations of the state and**

1 **directing payment thereof.**

2 The Legislature has considered the findings of fact and
