11 A BILL to amend and reenact §19-20-24 of the Code of West Virginia,
12 1931, as amended; and to amend and reenact §61-3E-6 of said
13 code; all relating to penalties for causing injury or death to
14 certain animals used by law enforcement or in law enforcement
15 duties.

16 *Be it enacted by the Legislature of West Virginia:*

17 That §19-20-24 of the Code of West Virginia, 1931, as amended,
18 be amended and reenacted; and that §61-3E-6 of said code be amended
19 and reenacted, all to read as follows:

CHAPTER 19. AGRICULTURE.

21 **ARTICLE 20. DOGS AND CATS.**

22 **§19-20-24. Causing death or injury to animals used by law-**
23 **enforcement officials or by fire prevention or**
24 **investigation officials; criminal penalties.**

25 Any person who, without justification, and with the unlawful
26 intent to inflict serious physical injury or death, causes the
27 death of any trained dog or horse used by law-enforcement
28 officials, the Department of Military Affairs and Public Safety or

1 by fire prevention or investigation officials in the performance of
2 their official duties is guilty of a felony and, upon conviction
3 thereof, shall be fined not less than \$500 nor more than ~~one~~
4 ~~thousand dollars~~ \$5,000 and imprisoned in a correctional facility
5 ~~the penitentiary~~ for a definite term of not less than one year nor
6 more than three years.

7 Any person who, without justification, willfully and
8 unlawfully causes physical injury to any trained dog or horse used
9 by law-enforcement officials, the Department of Military Affairs
10 and Public Safety or by fire prevention or investigation officials
11 in the performance of their official duties is guilty of a
12 misdemeanor and, upon conviction thereof, shall be fined not more
13 than \$500 or confined in the ~~county~~ jail not more than six months,
14 or both.

15 Any person convicted of a violation of this section shall be
16 ordered to make restitution to the law-enforcement agency, the
17 Department of Military Affairs and Public Safety or to the State
18 Fire Marshal or other fire prevention or investigation department
19 or agency owning the animal for any veterinary bills, and
20 replacement costs of any disabled or killed animal.

21 **CHAPTER 61. CRIMES AND THEIR PUNISHMENT.**

22 **ARTICLE 3E. OFFENSES INVOLVING EXPLOSIVES.**

23 **§61-3E-6. Causing death or injury to an explosives detection**
24 **animal; penalty.**

25 Any person who violates the provisions of this article which
26 violation causes death, serious or debilitating bodily injury to an
27 explosives detection animal owned or used by a law-enforcement
28 agency, shall be guilty of a felony and, upon conviction thereof,

1 be committed to the custody of the Division of Corrections for not
2 less than one year nor more than five years or fined not more than
3 \$5,000 or both. Any person convicted of a violation of this section
4 shall be ordered to make restitution to the law-enforcement agency,
5 the Department of Military Affairs and Public Safety or to the
6 State Fire Marshal or other fire prevention or investigation
7 department or agency owning the animal for any veterinary bills,
8 and replacement costs of any disabled or killed animal.
