12 AN ACT to amend and reenact §5B-1-1a and §5B-1-2 of the Code of
13 West Virginia, 1931, as amended; to amend and reenact §5B-2-8
14 and §5B-2-9 of said code; to amend said code by adding thereto
15 a new section designated §5B-2-8a; and to amend and reenact
16 §5F-2-1 of said code, all relating to the organization and
17 authority of state agencies generally; continuing the
18 Marketing and Communications Office of the Department of
19 Commerce; authorizing the Marketing and Communications Office
20 to sell partnerships, sponsorships or advertising in certain
21 circumstances; providing that Division of Tourism and the
22 Tourism Commission are separate entities within Department of
23 Commerce; continuing the Division of Tourism and the Tourism
24 Commission; providing qualifications for the commissioner;
25 providing powers of the commissioner; modifying the
26 composition of the Tourism Commission; modifying the Tourism

1 Commission's annual reporting requirement; providing that the
2 Educational Broadcasting Authority is part of the Department
3 of Education and the Arts for administrative support and
4 liaison with the office of the Governor; and providing that
5 the Veterans' Council and its allied, advisory, affiliated or
6 related entities and funds are part of the Department of
7 Veteran's Assistance.

8 *Be it enacted by the Legislature of West Virginia:*

9 That §5B-1-1a and §5B-1-2 of the Code of West Virginia, 1931,
10 as amended, be amended and reenacted; that §5B-2-8 and §5B-2-9 of
11 said code be amended and reenacted; that said code be amended by
12 adding thereto a new section, designated §5B-2-8a; and that §5F-2-1
13 of said code be amended and reenacted, all to read as follows:

14 **CHAPTER 5B. ECONOMIC DEVELOPMENT ACT OF 1985.**

15 **ARTICLE 5B. DEPARTMENT OF COMMERCE.**

16 **§5B-1-1a. Marketing and Communications Office.**

17 (a) There is continued in the Department of Commerce the
18 Marketing and Communications Office. The office is created to
19 provide marketing and communications goods and services to other
20 state agencies, departments, units of state or local government or
21 other entity or person.

22 (b) The office is authorized to charge for goods and services
23 it provides to other state agencies. The Secretary of the
24 Department of Commerce shall approve a fee schedule determining the
25 amounts that may be charged for goods and services provided by the
26 office to other state agencies. At the discretion of and with the

1 approval of the Secretary of the Department of Commerce, the office
2 may also sell partnerships, sponsorships or advertising in its
3 publications, events or promotions to help offset the cost of
4 producing and distributing its products and services.

5 (c) All moneys collected shall be deposited in a special
6 account in the State Treasury to be known as the Department of
7 Commerce Marketing and Communications Operating Fund. Expenditures
8 from the fund shall be for the operation of the office and are not
9 authorized from collections but are to be made only in accordance
10 with appropriation by the Legislature and in accordance with the
11 provisions of article two, chapter eleven-b of this code.

12 (d) Any balance remaining at the end of any fiscal year shall
13 not revert to the General Revenue Fund, but shall remain in the
14 fund for expenditures in accordance with the purposes set forth in
15 this section.

16 (e) The Department of Commerce shall develop and maintain a
17 system of annual or more frequent performance measures useful in
18 gauging the efficiency and effectiveness of the office's marketing
19 and communications activities. The measures shall also reflect the
20 office's efficiency and effectiveness with respect to commercially
21 available marketing and communications services and any private
22 sector benchmarks which might be identified or created. For the
23 purposes of this section, "performance measures" means income,
24 output, quality, self-sufficiency and outcome metrics.

25 (f) On January 1 of each year the Secretary of the Department
26 of Commerce shall report to the Joint Committee on Government and

1 Finance, the Joint Standing Committee on Finance and the Joint
2 Commission on Economic Development on the performance of the
3 office. This report is to include a statement of the performance
4 measurements for the office developed by the Secretary of the
5 Department of Commerce and an analysis of the office's performance.

6 **§5B-1-2. Agencies, boards, commissions, divisions and offices**
7 **comprising the Department of Commerce.**

8 The Department of Commerce consists of the following agencies,
9 boards, commissions, divisions and offices, including all of the
10 allied, advisory, affiliated or related entities, which are
11 incorporated in and administered as part of the Department of
12 Commerce:

13 (1) Division of Labor provided in article one, chapter
14 twenty-one of this code, which includes:

15 (A) Occupational Safety and Health Review Commission provided
16 in article three-a, chapter twenty-one of this code; and

17 (B) Board of Manufactured Housing Construction and Safety
18 provided in article nine, chapter twenty-one of this code;

19 (2) Office of Miners' Health, Safety and Training provided in
20 article one, chapter twenty-two-a of this code. The following
21 boards are transferred to the Office of Miners' Health, Safety and
22 Training for purposes of administrative support and liaison with
23 the Office of the Governor:

24 (A) Board of Coal Mine Health and Safety and Coal Mine Safety
25 and Technical Review Committee provided in article six, chapter
26 twenty-two-a of this code;

1 (B) Board of Miner Training, Education and Certification
2 provided in article seven, chapter twenty-two-a of this code; and

3 (C) Mine Inspectors' Examining Board provided in article nine,
4 chapter twenty-two-a of this code;

5 (3) The West Virginia Development Office provided in article
6 two, chapter five-b of this code;

7 (4) Division of Natural Resources and Natural Resources
8 Commission provided in article one, chapter twenty of this code;

9 (5) Division of Forestry provided in article one-a, chapter
10 nineteen of this code;

11 (6) Geological and Economic Survey provided in article two,
12 chapter twenty-nine of this code;

13 (7) Workforce West Virginia provided in chapter twenty-one-a
14 of this code, which includes:

15 (A) Division of Unemployment Compensation;

16 (B) Division of Employment Service;

17 (C) Division of Workforce Development; and

18 (D) Division of Research, Information and Analysis;

19 (8) Division of Energy provided in article two-f, chapter
20 five-b of this code; and

21 (9) Division of Tourism and the Tourism Commission provided in
22 article two, chapter five-b of this code.

23 **ARTICLE 2. WEST VIRGINIA DEVELOPMENT OFFICE AND THE DIVISION OF**
24 **TOURISM.**

25 **§5B-2-8. Division of Tourism and Tourism Commission continued;**
26 **members, appointment and expenses.**

1 (a) There is hereby continued within the Department of
2 Commerce the Division of Tourism and an independent Tourism
3 Commission, which is a body corporate and politic, constituting a
4 public corporation and government instrumentality.

5 (b) Prior to July 1, 2011, the Governor, by and with the
6 advice and consent of the Senate, shall appoint to the Tourism
7 Commission three members from the private sector to represent
8 participants in the state's tourism industry, one for a term of
9 four years, one for a term of three years and one for a term of two
10 years.

11 (c) Commencing July 1, 2011, the Tourism Commission shall
12 consist of the following fifteen members with staggered terms:

13 (1) Twelve members appointed by the Governor, with the advice
14 and consent of the Senate, representing participants in the state's
15 tourism industry. Ten of the members shall be from the private
16 sector, one shall be a director employed by a convention and
17 visitors bureau and one shall be a member of a convention and
18 visitors bureau. In making the appointments the Governor may
19 select from a list provided by the West Virginia Hospitality and
20 Travel Association of qualified applicants. Of the twelve members
21 so appointed, no less than three shall be from each congressional
22 district within the state and shall be appointed to provide the
23 broadest geographic distribution which is feasible;

24 (2) One member to be appointed by the Governor to
25 represent public sector nonstate participants in the tourism
26 industry within the state;

1 (3) The Secretary of Transportation or his or her designee, ex
2 officio; and

3 (4) The Director of the Division of Natural Resources or his
4 or her designee, ex officio.

5 (d) Each member appointed by the Governor shall serve
6 staggered terms of four years. Any member whose term has expired
7 shall serve until his or her successor has been appointed. Any
8 person appointed to fill a vacancy shall serve only for the
9 unexpired term. Any member shall be eligible for reappointment.
10 In cases of vacancy in the office of member, such vacancy shall be
11 filled by the Governor in the same manner as the original
12 appointment.

13 (e) Members of the commission shall not be entitled to
14 compensation for services performed as members. A majority of
15 these members shall constitute a quorum for the purpose of
16 conducting business. The Governor shall appoint a chair of the
17 commission for a term to run concurrent with the term of the office
18 of the member appointed to be the chair. The chair is eligible for
19 successive terms in that position.

20 **§5B-2-8a. Commissioner of Tourism.**

21 (a) The division of tourism is under the direction and charge
22 of the Commissioner of Tourism.

23 (b) The commissioner shall be appointed by the Governor:
24 *Provided*, That the person serving as commissioner at the time of
25 the enactment of this section in 2011, shall continue to serve in
26 that capacity at the will and pleasure of the Governor. The

1 commissioner's salary shall be set the Governor. The commissioner
2 shall be a competent person, having executive ability and knowledge
3 of publicity, advertising and tourist promotion.

4 (c) In addition to other duties required of the division by
5 other provisions of this code, the division shall:

6 (1) Coordinate media events to promote a positive image of
7 West Virginia and new investment in the tourist industry;

8 (2) Provide comprehensive strategic planning services to
9 existing tourism enterprises;

10 (3) Promote attractions of West Virginia in other states; and

11 (4) Distribute West Virginia informational publications and
12 manage the West Virginia Welcome Centers.

13 **§5B-2-9. Powers and duties of tourism commission.**

14 (a) The commission shall develop a comprehensive tourism
15 promotion and development strategy for West Virginia.

16 "Comprehensive tourism promotion and development strategy" means a
17 plan that outlines strategies and activities designed to continue,
18 diversify or expand the tourism base of the state as a whole;
19 create tourism jobs; develop a highly skilled tourism work force;
20 facilitate business access to capital for tourism; advertise and
21 market the resources offered by the state with respect to tourism
22 promotion and development; facilitate cooperation among local,
23 regional and private tourism enterprises; improve infrastructure on
24 a state, regional and community level in order to facilitate
25 tourism development; improve the tourism business climate
26 generally; and leverage funding from sources other than the state,

1 including local, federal and private sources.

2 (b) In developing its strategies, the commission shall
3 consider the following:

4 (1) Improvement and expansion of existing tourism marketing
5 and promotion activities;

6 (2) Promotion of cooperation among municipalities, counties,
7 and the West Virginia Infrastructure and Jobs Development Council
8 in funding physical infrastructure to enhance the potential for
9 tourism development.

10 (c) The tourism commission shall have the power and duty:

11 (1) To acquire for the state in the name of the commission by
12 purchase, lease or agreement, or accept or reject for the state, in
13 the name of the commission, gifts, donations, contributions,
14 bequests or devises of money, security or property, both real and
15 personal, and any interest in such property, to effectuate or
16 support the purposes of this article;

17 (2) To make recommendations to the Governor and the
18 Legislature of any legislation deemed necessary to facilitate the
19 carrying out of any of the foregoing powers and duties and to
20 exercise any other power that may be necessary or proper for the
21 orderly conduct of the business of the commission and the effective
22 discharge of the duties of the commission;

23 (3) To cooperate and assist in the production of motion
24 pictures and television and other communications;

25 (4) To purchase advertising time or space in or upon any
26 medium generally engaged or employed for said purpose to advertise

1 and market the resources of the state or to inform the public at
2 large or any specifically targeted group or industry about the
3 benefits of living in, investing in, producing in, buying from,
4 contracting with, or in any other way related to, the state of West
5 Virginia or any business, industry, agency, institution or other
6 entity therein: *Provided*, That of any funds appropriated and
7 allocated for purposes of advertising and marketing expenses for
8 the promotion and development of tourism, not less than twenty
9 percent of the funds shall be expended with the approval of the
10 Director of the Division of Natural Resources to advertise, promote
11 and market state parks, state forests, state recreation areas and
12 wildlife recreational resources;

13 (5) To promote and disseminate information related to the
14 attractions of the state through the operation of the state's
15 telemarketing initiative, which telemarketing initiative shall
16 include a centralized reservation and information system for state
17 parks and recreational facilities; and

18 (6) To take such additional actions as may be necessary to
19 carry out the duties and programs described in this article.

20 (d) The commission shall submit a report annually to the
21 Secretary of Commerce, the Governor and the Legislature about the
22 development of the tourism industry in the state and the necessary
23 funding required by the state to continue the development of the
24 tourism industry.

25 (e) The Commissioner of the Division of Tourism shall assist
26 the commission in the performance of its powers and duties and the

1 commissioner is hereby authorized in providing this assistance to
2 employ necessary personnel, contract with professional or technical
3 experts or consultants and to purchase or contract for the
4 necessary equipment or supplies.

5 (f) The commission shall promulgate legislative rules pursuant
6 to the provisions of chapter twenty-nine-a of this code to carry
7 out its purposes and programs, to include generally the programs
8 available, the procedure and eligibility of applications relating
9 to assistance under such programs and the staff structure necessary
10 to support such programs, which structure shall include the
11 qualifications for a professional staff person qualified by reason
12 of exceptional training and experience in the field of advertising
13 to supervise the advertising and promotion functions of the
14 commission, and shall further include provision for the management
15 of West Virginia welcome centers. The commission is further
16 authorized to promulgate procedural rules pursuant to said chapter
17 to include instructions and forms for applications relating to
18 assistance.

19 **CHAPTER 5F. REORGANIZATION OF THE EXECUTIVE**

20 **BRANCH OF STATE GOVERNMENT.**

21 **ARTICLE 2. TRANSFER OF AGENCIES AND BOARDS.**

22 **§5F-2-1. Transfer and incorporation of agencies and boards; funds.**

23

24 (a) The following agencies and boards, including all of the
25 allied, advisory, affiliated or related entities and funds
26 associated with any agency or board, are incorporated in and

1 administered as a part of the Department of Administration:

2 (1) Building Commission provided in article six, chapter five
3 of this code;

4 (2) Public Employees Insurance Agency provided in article
5 sixteen, chapter five of this code;

6 (3) Governor's Mansion Advisory Committee provided in article
7 five, chapter five-a of this code;

8 (4) Commission on Uniform State Laws provided in article
9 one-a, chapter twenty-nine of this code;

10 (5) West Virginia Public Employees Grievance Board provided in
11 article three, chapter six-c of this code;

12 (6) Board of Risk and Insurance Management provided in article
13 twelve, chapter twenty-nine of this code;

14 (7) Boundary Commission provided in article twenty-three,
15 chapter twenty-nine of this code;

16 (8) Public Defender Services provided in article twenty-one,

20 executive branch.

20 (l) The Veterans' Council provided in article one, chapter

23 incorporated in and administered as part of the Department of
24 Veterans' Assistance.

25 (m) Except for powers, authority and duties that have been
26 delegated to the secretaries of the departments by the provisions

1 of section two of this article, the position of administrator and
2 the powers, authority and duties of each administrator and agency
3 are not affected by the enactment of this chapter.

4 (n) Except for powers, authority and duties that have been
5 delegated to the secretaries of the departments by the provisions
6 of section two of this article, the existence, powers, authority
7 and duties of boards and the membership, terms and qualifications
8 of members of the boards are not affected by the enactment of this
9 chapter. All boards that are appellate bodies or are independent
10 decision makers shall not have their appellate or independent
11 decision-making status affected by the enactment of this chapter.

12 (o) Any department previously transferred to and incorporated
13 in a department by prior enactment of this section means a division
14 of the appropriate department. Wherever reference is made to any
15 department transferred to and incorporated in a department created
16 in section two, article one of this chapter, the reference means a
17 division of the appropriate department and any reference to a
18 division of a department so transferred and incorporated means a
19 section of the appropriate division of the department.

20 (p) When an agency, board or commission is transferred under
21 a bureau or agency other than a department headed by a secretary
22 pursuant to this section, that transfer is solely for purposes of
23 administrative support and liaison with the office of the Governor,
24 a department secretary or a bureau. Nothing in this section
25 extends the powers of department secretaries under section two of
26 this article to any person other than a department secretary and

1 nothing limits or abridges the statutory powers and duties of
2 statutory commissioners or officers pursuant to this code.
