11	1931, as amended, relating to authorizing the issuance of
12	special license plates for pharmacists; and assessing a
13	special initial application fee and a special annual fee for

15	Be it enacted by the Legislature of West Virginia:
16	That §17A-3-14 of the Code of West Virginia, 1931, as amended,
17	be amended and reenacted to read as follows:
18	ARTICLE 3. ORIGINAL AND RENEWAL OF REGISTRATION; ISSUANCE OF
19	CERTIFICATES OF TITLE.
20	§17A-3-14. Registration plates generally; description of plates;
21	issuance of special numbers and plates;
22	registration fees; special application fees;
23	exemptions; commissioner to promulgate forms;

suspension and nonrenewal.

- 2 (a) The division upon registering a vehicle shall issue to the 3 owner one registration plate for a motorcycle, trailer, semitrailer 4 or other motor vehicle.
- 5 (b) Registration plates issued by the division shall meet the 6 following requirements:
- 7 (1) Every registration plate shall be of reflectorized 8 material and have displayed upon it the registration number 9 assigned to the vehicle for which it is issued; the name of this 10 state, which may be abbreviated; and the year number for which it 11 is issued or the date of expiration of the plate.
- 12 (2) Every registration plate and the required letters and 13 numerals on the plate shall be of sufficient size to be plainly 14 readable from a distance of one hundred feet during daylight: 15 *Provided*, That the requirements of this subdivision shall not apply 16 to the year number for which the plate is issued or the date of 17 expiration.
- 18 (3) Registration numbering for registration plates shall begin 19 with number two.
- 20 (c) The division may not issue, permit to be issued or 21 distribute any special registration plates except as follows:
- 22 (1) The Governor shall be issued two registration plates, on 23 one of which shall be imprinted the numeral one and on the other 24 the word one.

- 1 (2) State officials and judges may be issued special 2 registration plates as follows:
- 3 (A) Upon appropriate application, the division shall issue to 4 the Secretary of State, State Superintendent of Schools, Auditor, 5 Treasurer, Commissioner of Agriculture and the Attorney General, 6 the members of both houses of the Legislature, including the 7 elected officials of both houses of the Legislature, the justices Appeals of Supreme Court of West Virginia, the 9 representatives and senators of the state in the Congress of the 10 United States, the judges of the West Virginia circuit courts, 11 active and retired on senior status, the judges of the United 12 States district courts for the State of West Virginia and the 13 judges of the United States Court of Appeals for the fourth 14 circuit, if any of the judges are residents of West Virginia, a 15 special registration plate for a Class A motor vehicle and a 16 special registration plate for a Class G motorcycle owned by the 17 official or his or her spouse: Provided, That the division may 18 issue a Class A special registration plate for each vehicle titled 19 to the official and a Class G special registration plate for each 20 motorcycle titled to the official.
- 21 (B) Each plate issued pursuant to this subdivision shall bear 22 any combination of letters and numbers not to exceed an amount 23 determined by the commissioner and a designation of the office. 24 Each plate shall supersede the regular numbered plate assigned to

- 1 the official or his or her spouse during the official's term of 2 office and while the motor vehicle is owned by the official or his 3 or her spouse.
- 4 (C) The division shall charge an annual fee of \$15 for every 5 registration plate issued pursuant to this subdivision, which is in 6 addition to all other fees required by this chapter.
- 7 (3) The division may issue members of the National Guard 8 forces special registration plates as follows:
- (A) Upon receipt of an application on a form prescribed by the division and receipt of written evidence from the chief executive officer of the Army National Guard or Air National Guard, as appropriate, or the commanding officer of any United States Armed Forces reserve unit that the applicant is a member thereof, the division shall issue to any member of the National Guard of this state or a member of any reserve unit of the United States Armed Forces a special registration plate designed by the commissioner for any number of Class A motor vehicles owned by the member. Upon presentation of written evidence of retirement status, retired members of this state's Army or Air National Guard, or retired members of any reserve unit of the United States Armed Forces, are eligible to purchase the special registration plate issued pursuant to this subdivision.
- 23 (B) The division shall charge an initial application fee of 24 \$10 for each special registration plate issued pursuant to this

- 1 subdivision, which is in addition to all other fees required by
- 2 this chapter. Except as otherwise provided herein, effective July
- 3 1, 2007, all fees currently held in the special revolving fund used
- 4 in the administration of this section and all fees collected by the
- 5 division shall be deposited in the State Road Fund.
- 6 (C) A surviving spouse may continue to use his or her deceased
- 7 spouse's National Guard forces license plate until the surviving
- 8 spouse dies, remarries or does not renew the license plate.
- 9 (4) Specially arranged registration plates may be issued as
- 10 follows:
- 11 (A) Upon appropriate application, any owner of a motor vehicle
- 12 subject to Class A registration, or a motorcycle subject to Class
- 13 G registration, as defined by this article, may request that the
- 14 division issue a registration plate bearing specially arranged
- 15 letters or numbers with the maximum number of letters or numbers to
- 16 be determined by the commissioner. The division shall attempt to
- 17 comply with the request wherever possible.
- 18 (B) The commissioner shall propose rules for legislative
- 19 approval in accordance with the provisions of chapter twenty-nine-a
- 20 of this code regarding the orderly distribution of the plates:
- 21 Provided, That for purposes of this subdivision, the registration
- 22 plates requested and issued shall include all plates bearing the
- 23 numbers two through two thousand.
- 24 (C) An annual fee of \$15 shall be charged for each special

- 1 registration plate issued pursuant to this subdivision, which is in
- 2 addition to all other fees required by this chapter.
- 3 (5) The division may issue honorably discharged veterans 4 special registration plates as follows:
- 5 (A) Upon appropriate application, the division shall issue to 6 any honorably discharged veteran of any branch of the armed 7 services of the United States a special registration plate for any 8 number of vehicles titled in the name of the qualified applicant 9 with an insignia designed by the Commissioner of the Division of 10 Motor Vehicles.
- 11 (B) The division shall charge a special initial application 12 fee of \$10 in addition to all other fees required by law. This 13 special fee is to compensate the Division of Motor Vehicles for 14 additional costs and services required in the issuing of the 15 special registration. All fees collected by the division shall be 16 deposited in the State Road Fund: *Provided*, That nothing in this 17 section may be construed to exempt any veteran from any other 18 provision of this chapter.
- 19 (C) A surviving spouse may continue to use his or her deceased 20 spouse's honorably discharged veterans license plate until the 21 surviving spouse dies, remarries or does not renew the license 22 plate.
- 23 (6) The division may issue disabled veterans special 24 registration plates as follows:

- 1 (A) Upon appropriate application, the division shall issue to 2 any disabled veteran who is exempt from the payment of registration 3 fees under the provisions of this chapter a registration plate for 4 a vehicle titled in the name of the qualified applicant which bears 5 the letters "DV" in red and also the regular identification 6 numerals in red.
- 7 (B) A surviving spouse may continue to use his or her deceased 8 spouse's disabled veterans license plate until the surviving spouse 9 dies, remarries or does not renew the license plate.
- (C) A qualified disabled veteran may obtain a second disabled 11 veterans license plate as described in this section for use on a 12 passenger vehicle titled in the name of the qualified applicant.

 13 The division shall charge a one-time fee of \$10 to be deposited
- 14 into the State Road Fund, in addition to all other fees required by 15 this chapter, for the second plate.
- 16 (7) The division may issue recipients of the distinguished 17 Purple Heart medal special registration plates as follows:
- (A) Upon appropriate application, there shall be issued to any armed service person holding the distinguished Purple Heart medal for persons wounded in combat a registration plate for a vehicle titled in the name of the qualified applicant bearing letters or numbers. The registration plate shall be designed by the Commissioner of Motor Vehicles and shall denote that those individuals who are granted this special registration plate are

- 1 recipients of the Purple Heart. All letterings shall be in purple 2 where practical.
- 3 (B) Registration plates issued pursuant to this subdivision 4 are exempt from all registration fees otherwise required by the 5 provisions of this chapter.
- 6 (C) A surviving spouse may continue to use his or her deceased 7 spouse's Purple Heart medal license plate until the surviving 8 spouse dies, remarries or does not renew the license plate.
- 9 (D) A recipient of the Purple Heart medal may obtain a second 10 Purple Heart medal license plate as described in this section for 11 use on a passenger vehicle titled in the name of the qualified 12 applicant. The division shall charge a one-time fee of \$10 to be 13 deposited into the State Road Fund, in addition to all other fees 14 required by this chapter, for the second plate.
- 15 (8) The division may issue survivors of the attack on Pearl 16 Harbor special registration plates as follows:
- (A) Upon appropriate application, the owner of a motor vehicle who was enlisted in any branch of the armed services that 19 participated in and survived the attack on Pearl Harbor on December 20 7, 1941, the division shall issue a special registration plate for 21 a vehicle titled in the name of the qualified applicant. The 22 registration plate shall be designed by the Commissioner of Motor 23 Vehicles.
- 24 (B) Registration plates issued pursuant to this subdivision

- 1 are exempt from the payment of all registration fees otherwise 2 required by the provisions of this chapter.
- 3 (C) A surviving spouse may continue to use his or her deceased 4 spouse's survivors of the attack on Pearl Harbor license plate 5 until the surviving spouse dies, remarries or does not renew the 6 license plate.
- 7 (D) A survivor of the attack on Pearl Harbor may obtain a 8 second survivors of the attack on Pearl Harbor license plate as 9 described in this section for use on a passenger vehicle titled in 10 the name of the qualified applicant. The division shall charge a 11 one-time fee of \$10 to be deposited into the State Road Fund, in 12 addition to all other fees required by this chapter, for the second 13 plate.
- 14 (9) The division may issue special registration plates to 15 nonprofit charitable and educational organizations authorized under 16 prior enactment of this subdivision as follows:
- 17 (A) Approved nonprofit charitable and educational 18 organizations previously authorized under the prior enactment of 19 this subdivision may accept and collect applications for special 20 registration plates from owners of Class A motor vehicles together 21 with a special annual fee of \$15, which is in addition to all other 22 fees required by this chapter. The applications and fees shall be 23 submitted to the Division of Motor Vehicles with the request that 24 the division issue a registration plate bearing a combination of

- 1 letters or numbers with the organizations' logo or emblem, with the
- 2 maximum number of letters or numbers to be determined by the
- 3 commissioner.
- 4 (B) The commissioner shall propose rules for legislative
- 5 approval in accordance with the provisions of article three,
- 6 chapter twenty-nine-a of this code regarding the procedures for and
- 7 approval of special registration plates issued pursuant to this
- 8 subdivision.
- 9 (C) The commissioner shall set an appropriate fee to defray
- 10 the administrative costs associated with designing and
- 11 manufacturing special registration plates for a nonprofit
- 12 charitable or educational organization. The nonprofit charitable
- 13 or educational organization shall collect this fee and forward it
- 14 to the division for deposit in the State Road Fund. The nonprofit
- 15 charitable or educational organization may also collect a fee for
- 16 marketing the special registration plates.
- 17 (10) The division may issue specified emergency or volunteer
- 18 registration plates as follows:
- 19 (A) Any owner of a motor vehicle who is a resident of the
- 20 State of West Virginia and who is a certified paramedic or
- 21 emergency medical technician, a member of a paid fire department,
- 22 a member of the state Fire Commission, the State Fire Marshal, the
- 23 State Fire Marshal's assistants, the State Fire Administrator and
- 24 voluntary rescue squad members may apply for a special license

1 plate for any number of Class A vehicles titled in the name of the 2 qualified applicant which bears the insignia of the profession, 3 group or commission. Any insignia shall be designed by the 4 commissioner. License plates issued pursuant to this subdivision 5 shall bear the requested insignia in addition to the registration 6 number issued to the applicant pursuant to the provisions of this

7 article.

- 8 (B) Each application submitted pursuant to this subdivision 9 shall be accompanied by an affidavit signed by the fire chief or 10 department head of the applicant stating that the applicant is 11 justified in having a registration with the requested insignia; 12 proof of compliance with all laws of this state regarding 13 registration and licensure of motor vehicles; and payment of all 14 required fees.
- (C) Each application submitted pursuant to this subdivision shall be accompanied by payment of a special initial application fee of \$10, which is in addition to any other registration or license fee required by this chapter. All special fees shall be collected by the division and deposited into the state Road Fund.
- 20 (11) The division may issue specified certified firefighter 21 registration plates as follows:
- 22 (A) Any owner of a motor vehicle who is a resident of the 23 State of West Virginia and who is a certified firefighter may apply 24 for a special license plate which bears the insignia of the

- 1 profession, for any number of Class A vehicles titled in the name 2 of the qualified applicant. Any insignia shall be designed by the 3 commissioner. License plates issued pursuant to this subdivision 4 shall bear the requested insignia pursuant to the provisions of 5 this article. Upon presentation of written evidence of 6 certification as a certified firefighter, certified firefighters 7 are eligible to purchase the special registration plate issued 8 pursuant to this subdivision.
- 9 (B) Each application submitted pursuant to this subdivision
 10 shall be accompanied by an affidavit stating that the applicant is
 11 justified in having a registration with the requested insignia;
 12 proof of compliance with all laws of this state regarding
 13 registration and licensure of motor vehicles; and payment of all
 14 required fees. The firefighter certification department, section
 15 or division of the West Virginia University fire service extension
 16 shall notify the commissioner in writing immediately when a
 17 firefighter loses his or her certification. If a firefighter loses
 18 his or her certification, the commissioner may not issue him or her
 19 a license plate under this subsection.
- (C) Each application submitted pursuant to this subdivision shall be accompanied by payment of a special initial application fee of \$10, which is in addition to any other registration or license fee required by this chapter. All special fees shall be collected by the division and deposited into the State Road Fund.

- 1 (12) The division may issue special scenic registration plates 2 as follows:
- 3 (A) Upon appropriate application, the commissioner shall issue 4 a special registration plate displaying a scenic design of West 5 Virginia which displays the words "Wild Wonderful" as a slogan.
- 6 (B) The division shall charge a special one-time initial 7 application fee of \$10 in addition to all other fees required by 8 this chapter. All initial application fees collected by the 9 division shall be deposited into the State Road Fund.
- 10 (13) The division may issue honorably discharged Marine Corps
 11 league members special registration plates as follows:
- (A) Upon appropriate application, the division shall issue to 13 any honorably discharged Marine Corps league member a special 14 registration plate for any number of vehicles titled in the name of 15 the qualified applicant with an insignia designed by the 16 Commissioner of the Division of Motor Vehicles.
- 17 (B) The division may charge a special one-time initial 18 application fee of \$10 in addition to all other fees required by 19 this chapter. This special fee is to compensate the Division of 20 Motor Vehicles for additional costs and services required in the 21 issuing of the special registration and shall be collected by the 22 division and deposited in the State Road Fund: *Provided*, That 23 nothing in this section may be construed to exempt any veteran from 24 any other provision of this chapter.

- 1 (C) A surviving spouse may continue to use his or her deceased
- 2 spouse's honorably discharged Marine Corps League license plate
- 3 until the surviving spouse dies, remarries or does not renew the
- 4 license plate.
- 5 (14) The division may issue military organization registration
- 6 plates as follows:
- 7 (A) The division may issue a special registration plate for
- 8 the members of any military organization chartered by the United
- 9 States Congress upon receipt of a guarantee from the organization
- 10 of a minimum of one hundred applicants. The insignia on the plate
- 11 shall be designed by the commissioner.
- 12 (B) Upon appropriate application, the division may issue
- 13 members of the chartered organization in good standing, as
- 14 determined by the governing body of the chartered organization, a
- 15 special registration plate for any number of vehicles titled in the
- 16 name of the qualified applicant.
- 17 (C) The division shall charge a special one-time initial
- 18 application fee of \$10 for each special license plate in addition
- 19 to all other fees required by this chapter. All initial
- 20 application fees collected by the division shall be deposited into
- 21 the State Road Fund: Provided, That nothing in this section may be
- 22 construed to exempt any veteran from any other provision of this
- 23 chapter.
- 24 (D) A surviving spouse may continue to use his or her deceased

- 1 spouse's military organization registration plate until the
- 2 surviving spouse dies, remarries or does not renew the special
- 3 military organization registration plate.
- 4 (15) The division may issue special nongame wildlife
- 5 registration plates and special wildlife registration plates as
- 6 follows:
- 7 (A) Upon appropriate application, the division shall issue a
- 8 special registration plate displaying a species of West Virginia
- 9 wildlife which shall display a species of wildlife native to West
- 10 Virginia as prescribed and designated by the commissioner and the
- 11 Director of the Division of Natural Resources.
- 12 (B) The division shall charge an annual fee of \$15 for each
- 13 special nongame wildlife registration plate and each special
- 14 wildlife registration plate in addition to all other fees required
- 15 by this chapter. All annual fees collected for nongame wildlife
- 16 registration plates and wildlife registration plates shall be
- 17 deposited in a special revenue account designated the Nongame
- 18 Wildlife Fund and credited to the Division of Natural Resources.
- 19 (C) The division shall charge a special one-time initial
- 20 application fee of \$10 in addition to all other fees required by

- 6 to be collected by the division and deposited in the State Road
- 7 Fund: Provided, That nothing in this section may be construed to
- 8 exempt any veteran from any other provision of this chapter.
- 9 (C) A surviving spouse may continue to use his or her deceased
- 10 spouse's honorably discharged veterans license plate until the

- 13 (19) Racing theme special registration plates:
- 14 (A) The division may issue a series of special registration
- 15 plates displaying National Association for Stock Car Auto Racing

- 17 (B) An annual fee of \$25 shall be charged for each special
- 18 racing theme registration plate in addition to all other fees
- 19 required by this chapter. All annual fees collected for each
- 20 special racing theme registration plate shall be deposited into the
- 21 State Road Fund.
- 22 (C) A special application fee of \$10 shall be charged at the
- 23 time of initial application as well as upon application for any
- 24 duplicate or replacement registration plate, in addition to all

- 1 other fees required by this chapter. All application fees shall be
- 2 deposited into the State Road Fund.
- 3 (20) The division may issue recipients of the Navy Cross,

- 22 the applicant for a special registration plate under this
- 23 subdivision from any other provision of this chapter.
- 24 (C) A surviving spouse may continue to use his or her deceased

- 1 spouse's Navy Cross, Distinguished Service Cross, Distinguished
- 2 Flying Cross, Air Force Cross, Silver Star, Bronze Star or Air
- 3 Medal special registration plate until the surviving spouse dies,
- 4 remarries or does not renew the special registration plate.
- 5 (21) The division may issue honorably discharged veterans
- 6 special registration plates as follows:
- 7 (A) Upon appropriate application, the division shall issue to
- 8 any honorably discharged veteran of any branch of the armed
- 9 services of the United States with verifiable service during World
- 10 War II, the Korean War, the Vietnam War, the Persian Gulf War or
- 11 the War Against Terrorism a special registration plate for any
- 12 number of vehicles titled in the name of the qualified applicant
- 13 with an insignia designed by the commissioner denoting service in
- 14 the applicable conflict.
- 15 (B) The division shall charge a special one-time initial
- 16 application fee of \$10 in addition to all other fees required by
- 17 law. This special fee shall be collected by the division and
- 18 deposited in the State Road Fund: Provided, That nothing contained
- 19 in this section may be construed to exempt any veteran from any
- 20 other provision of this chapter.
- 21 (C) A surviving spouse may continue to use his or her deceased
- 22 spouse's honorably discharged veterans registration plate until the
- 23 surviving spouse dies, remarries or does not renew the special
- 24 registration plate.

- 1 (22) The division may issue special volunteer firefighter 2 registration plates as follows:
- 3 (A) Any owner of a motor vehicle who is a resident of West
 4 Virginia and who is a volunteer firefighter may apply for a special
 5 license plate for any Class A vehicle titled in the name of the
 6 qualified applicant which bears the insignia of the profession in
 7 white letters on a red background. The insignia shall be designed
 8 by the commissioner and shall contain a fireman's helmet insignia
 9 on the left side of the license plate.
- (B) Each application submitted pursuant to this subdivision shall be accompanied by an affidavit signed by the applicant's fire chief, stating that the applicant is a volunteer firefighter and justified in having a registration plate with the requested insignia. The applicant must comply with all other laws of this state regarding registration and licensure of motor vehicles and must pay all required fees.
- (C) Each application submitted pursuant to this subdivision shall be accompanied by payment of a special one-time initial application fee of \$10, which is in addition to any other registration or license fee required by this chapter. All application fees shall be deposited into the State Road Fund.
- (23) The division may issue special registration plates which 23 reflect patriotic themes, including the display of any United 24 States symbol, icon, phrase or expression which evokes patriotic

1 pride or recognition.

- 2 (A) Upon appropriate application, the division shall issue to 3 an applicant a registration plate of the applicant's choice, 4 displaying a patriotic theme as provided in this subdivision, for 5 a vehicle titled in the name of the applicant. A series of 6 registration plates displaying patriotic themes shall be designed 7 by the Commissioner of Motor Vehicles for distribution to 8 applicants.
- 9 (B) The division shall charge a special one-time initial 10 application fee of \$10 in addition to all other fees required by 11 law. This special fee shall be collected by the division and 12 deposited in the State Road Fund.
- 13 (24) Special license plates bearing the American flag and the 14 logo "9/11/01".
- 15 (A) Upon appropriate application, the division shall issue 16 special registration plates which shall display the American flag 17 and the logo "9/11/01".
- 18 (B) An annual fee of \$15 shall be charged for each plate in 19 addition to all other fees required by this chapter.
- (C) A special application fee of \$10 shall be charged at the 21 time of initial application as well as upon application for any 22 duplicate or replacement registration plate, in addition to all 23 other fees required by this chapter. All application fees shall be 24 deposited into the State Road Fund.

- 17 Department of Defense in accordance with Public Law 534, 89th
- 18 Congress, and criteria established by the United States Department
- 19 of Defense, including criteria to determine next of kin.
- 20 (C) The division shall charge a special initial application
- 21 fee of \$10 in addition to all other fees required by law. This
- 22 special fee shall be collected by the division and deposited in the
- 23 State Road Fund.
- 24 (D) The provisions of subsection (d) of this section are not

- 1 applicable for the issuance of the special license plates
- 2 designated by this subdivision.
- 3 (59) The commissioner may issue special registration plates
- 4 for retired or former Justices of the Supreme Court of Appeals of
- 5 West Virginia as follows:
- 6 (A) Upon appropriate application, the division may issue a
- 7 special registration plate designed by the commissioner for any
- 8 number of vehicles titled in the name of the qualified applicant.
- 9 (B) The division shall charge a special initial application
- 10 fee of \$10 in addition to all other fees required by law. This
- 11 special fee shall be collected by the division and deposited in the
- 12 State Road Fund.
- 13 (C) The division shall charge an annual fee of \$15 for each
- 14 special registration plate in addition to all other fees required
- 15 by this chapter.
- 16 (D) The provisions of subsection (d) of this section are not
- 17 applicable for the issuance of the special license plates
- 18 designated by this subdivision.
- 19 (60) The division may issue special registration plates to
- 20 pharmacists as follows:
- 21 (A) Upon appropriate application, the division may issue a
- 22 special registration plate designed by the commissioner in
- 23 consultation with the West Virginia State Board of Pharmacy for any
- 24 number of vehicles titled in the name of the qualified applicant.

- 1 Persons desiring the special registration plate shall offer
- 2 sufficient proof of licensure as a pharmacist.
- 3 (B) The division shall charge a special initial application
- 4 fee of \$10 in addition to all other fees required by law. This
- 5 special fee is to compensate the Division of Motor Vehicles for
- 6 additional costs and services required in the issuing of the
- 7 special registration and shall be collected by the division and
- 8 deposited in a special revolving fund to be used for the
- 9 administration of this section.
- 10 (C) An annual fee of \$15 shall be charged for each plate in
- 11 addition to all other fees required by this chapter.
- (60) (61) Upon approval by the commissioner of an appropriate
- 13 application, and upon all requirements of this subdivision being
- 14 satisfied, the division may issue special registration plates for
- 15 class A and class G motor vehicles to members of an organization
- 16 for which a special registration plate has not been issued pursuant
- 17 to any other subdivision in this subsection prior to January 1,
- 18 2010, in accordance with the provisions of this subdivision.
- 19 (A) An organization desiring to create a special registration
- 20 plate must comply with the following requirements to be eligible
- 21 to apply for the creation and issuance of a special registration
- 22 plate:
- 23 (i) The organization must be a nonprofit organization
- 24 organized and existing under Section 501(c)(3) of Title 26 of the

- 1 Internal Revenue Code and based, headquartered or have a chapter in
- 2 West Virginia;
- 3 (ii) The organization may be organized for, but may not be
- 4 restricted to, social, civic, higher education or entertainment
- 5 purposes;
- 6 (iii) The organization may not be a political party and may
- 7 not have been created or exist primarily to promote a specific
- 8 political or social belief, as determined by the commissioner in
- 9 his or her sole discretion;
- 10 (iv) The organization may not have as its primary purpose the
- 11 promotion of any specific faith, religion, religious belief or
- 12 antireligion;
- 13 (v) The name of the organization may not be the name of a
- 14 special product or brand name, and may not be construed, as
- 15 determined by the commissioner, as promoting a product or brand
- 16 name; and
- 17 (vi) The organization's lettering, logo, image or message to
- 18 be placed on the registration plate, if created, may not be
- 19 obscene, offensive or objectionable as determined by the
- 20 commissioner in his or her sole discretion.
- 21 (B) Beginning July 1, 2010, an organization requesting the
- 22 creation and issuance of a special registration plate may make
- 23 application with the division. The application shall include
- 24 sufficient information, as determined by the commissioner, to

- 1 determine whether the special registration plate requested and the 2 organization making the application meet all of the requirements 3 set forth in this subdivision (60)(61). The application shall also 4 include a proposed design, including lettering, logo, image or 5 message to be placed on the registration plate. The commissioner 6 shall notify the organization of the commissioner's approval or 7 disapproval of the application.
- 8 (C)(i) The commissioner may not begin the design or production 9 of any license plates authorized and approved pursuant to this 10 subdivision (60)(61), subsection (c) of this section until the 11 organization which applied for the special registration plate has 12 collected and submitted collectively to the division applications 13 completed by at least two hundred fifty persons and collectively 14 deposited with the division all fees necessary to cover the first 15 year's basic registration, one-time design and manufacturing costs 16 and to cover the first year additional annual fee for all of the 17 applications submitted.
- (ii) If the organization fails to submit the required number of applications and fees within six months of the effective date of the approval of the application for the plate by the commissioner, the plate will not be produced until a new application is submitted and is approved by the commissioner: *Provided*, That an organization that is unsuccessful in obtaining the minimum number of applications may not make a new application for a special plate

- 1 until at least two years have passed since the approval of the 2 previous application of the organization.
- 3 (D) The division shall charge a special initial application
- 4 fee of \$25 for each special license plate in addition to all other
- 5 fees required by law. This special fee shall be collected by the
- 6 division and deposited in the State Road Fund.
- 7 (E) The division shall charge an annual fee of \$15 for each
- 8 special registration plate in addition to all other fees required
- 9 by this chapter.
- 10 (F) Upon appropriate application, the division may issue a
- 11 special registration plate designed by the commissioner in
- 12 consultation with the organization for any number of vehicles
- 13 titled in the name of a qualified registration plate applicant.
- 14 Persons desiring the special registration plate shall offer
- 15 sufficient proof of membership in the organization.
- 16 (G) The commissioner shall discontinue the issuance or renewal
- 17 of the registration of any special plate issued pursuant to this
- 18 subdivision $\frac{(60)}{(61)}$ if:
- 19 (i) The number of valid registrations for the specialty plate
- 20 falls below two hundred fifty plates for at least twelve
- 21 consecutive months; or
- (ii) The organization no longer exists or no longer meets the
- 23 requirements of this subdivision.
- 24 (d) The minimum number of applications required prior to

1 design and production of a special license plate shall be as 2 follows:

- (1) The commissioner may not begin the design or production of 4 any license plates for which eligibility is based on membership or 5 affiliation with a particular private organization until at least 6 one hundred persons complete an application and deposit with the 7 organization a check to cover the first year's basic registration, 8 one-time design and manufacturing costs and to cover the first year 9 additional annual fee. If the organization fails to submit the 10 required number of applications with attached checks within six 11 months of the effective date of the original authorizing 12 legislation, the plate will not be produced and will require 13 legislative reauthorization: Provided, That an organization or 14 group that is unsuccessful in obtaining the minimum number of 15 applications may not request reconsideration of a special plate 16 until at least two years have passed since the effective date of 17 the original authorization: Provided, however, That the provisions 18 of this subdivision (1) are not applicable to the issuance of 19 plates authorized pursuant to subdivision $\frac{(60)}{(61)}$, subsection (c) 20 of this section.
- (2) The commissioner may not begin the design or production of 22 any license plates authorized by this section for which membership 23 or affiliation with a particular organization is not required until 24 at least two hundred fifty registrants complete an application and

- 1 deposit a fee with the division to cover the first year's basic 2 registration fee, one-time design and manufacturing fee and 3 additional annual fee if applicable. If the commissioner fails to 4 receive the required number of applications within six months of 5 the effective date of the original authorizing legislation, the 6 plate will not be produced and will require legislative 7 reauthorization: *Provided*, That if the minimum number of 8 applications is not satisfied within the six months of the 9 effective date of the original authorizing legislation, a person 10 may not request reconsideration of a special plate until at least 11 two years have passed since the effective date of the original 2 authorization.
- (e) (1) Nothing in this section requires a charge for a free 14 prisoner of war license plate or a free recipient of the 15 Congressional Medal of Honor license plate for a vehicle titled in 16 the name of the qualified applicant as authorized by other 17 provisions of this code.
- 18 (2) A surviving spouse may continue to use his or her deceased 19 spouse's prisoner of war license plate or Congressional Medal of 20 Honor license plate until the surviving spouse dies, remarries or 21 does not renew the license plate.
- 22 (3) Qualified former prisoners of war and recipients of the 23 Congressional Medal of Honor may obtain a second special 24 registration plate for use on a passenger vehicle titled in the

- 1 name of the qualified applicant. The division shall charge a 2 one-time fee of \$10 to be deposited into the State Road Fund, in 3 addition to all other fees required by this chapter, for the second
- 4 special plate.
- 5 (f) The division may issue special ten-year registration 6 plates as follows:
- 7 (1) The commissioner may issue or renew for a period of no 8 more than ten years any registration plate exempted from 9 registration fees pursuant to any provision of this code or any 10 restricted use antique motor vehicle license plate authorized by 11 section three-a, article ten of this chapter: *Provided*, That the 12 provisions of this subsection do not apply to any person who has 13 had a special registration suspended for failure to maintain motor 14 vehicle liability insurance as required by section three, article 15 two-a, chapter seventeen-d of this code or failure to pay personal 16 property taxes as required by section three-a of this article.
- (2) An initial nonrefundable fee shall be charged for each special registration plate issued pursuant to this subsection, which is the total amount of fees required by section fifteen, article ten of this chapter, section three, article three of this chapter or section three-a, article ten of this chapter for the period requested.
- 23 (g) The provisions of this section may not be construed to 24 exempt any registrant from maintaining motor vehicle liability

1 insurance as required by section three, article two-a, chapter

2 seventeen-d of this code or from paying personal property taxes on

3 any motor vehicle as required by section three-a of this article.

- (h) The commissioner may, in his or her discretion, issue a 5 registration plate of reflectorized material suitable for permanent 6 use on motor vehicles, trailers and semitrailers, together with 7 appropriate devices to be attached to the registration to indicate 8 the year for which the vehicles have been properly registered or 9 the date of expiration of the registration. The design and 10 expiration of the plates shall be determined by the commissioner. 11 The commissioner shall, whenever possible and cost effective, 12 implement the latest technology in the design, production and 13 issuance of registration plates, indices of registration renewal 14 and vehicle ownership documents, including, but not limited to, 15 offering Internet renewal of vehicle registration and the use of 16 bar codes for instant identification of vehicles by scanning 17 equipment to promote the efficient and effective coordination and 18 communication of data for improving highway safety, aiding law 19 enforcement and enhancing revenue collection.
- 20 (i) Any license plate issued or renewed pursuant to this 21 chapter which is paid for by a check that is returned for 22 nonsufficient funds is void without further notice to the 23 applicant. The applicant may not reinstate the registration until 24 the returned check is paid by the applicant in cash, money order or

- 1 certified check and all applicable fees assessed as a result
- 2 thereof have been paid.

NOTE: The purpose of this bill is to authorize the issuance of special license plates for pharmacists.
