EQUIPMENT. 19 §17C-15-26. Special restrictions on lamps. 20 (a) Any lighted lamp or illuminating device upon a motor 21 vehicle other than head lamps, spot lamps, auxiliary lamps or 22 flashing front-direction signals which projects a beam of light of 23 an intensity greater than three hundred candlepower shall be so

- 1 directed that no part of the beam will strike the level of the
- 2 roadway on which the vehicle stands at a distance of more than
- 3 seventy-five feet from the vehicle.
- 4 (b) No person may drive or move any vehicle or equipment upon
- 5 any highway with any lamp or device on the vehicle displaying other
- 6 than a white or amber light visible from directly in front of the
- 7 center of the vehicle except as authorized by subsection (d) of
- 8 this section.
- 9 (c) Except as authorized in subsections (d) and (f) of this
- 10 section and authorized in section nineteen of this article,
- 11 flashing lights are prohibited on motor vehicles: Provided, That
- 12 any vehicle as a means for indicating right or left turn or any
- 13 vehicle as a means of indicating the same is disabled or otherwise
- 14 stopped for an emergency may have blinking or flashing lights.
- 15 (d) Notwithstanding any other provisions of this chapter, the
- 16 following colors of flashing warning lights are restricted for the
- 17 use of the type of vehicle designated:
- 18 (1) Blue flashing warning lights are restricted to police
- 19 vehicles. Authorization for police vehicles shall be designated by

- 15 (J) Class A vehicles of out-of-state residents who are active

- 2 (M) Class A vehicles of emergency response, or emergency
- 3 management personnel or police reserves as designated by the
- 4 Secretary of the Department of Military Affairs and Public Safety
- 5 and the county commission of the county of residence.
- 6 Red flashing warning lights attached to a Class A vehicle may
- 7 be operated only when responding to or engaged in handling an
- 8 emergency requiring the attention of the firefighters, members of
- 9 the ambulance services or chartered rescue squads.
- 10 (3) The use of red flashing warning lights is authorized as
- 11 follows:
- 12 (A) Authorization for all ambulances shall be designated by
- 13 the Department of Health and Human Resources and the sheriff of the

- 15 (B) Authorization for all fire department vehicles shall be
- 16 designated by the fire chief and the State Fire Marshal's office.

- 10 (H) Authorization for members of duly chartered rescue squads
- 11 not operating out of a fire department to operate Class A vehicles
- 12 shall be designated by their squad chiefs, the sheriff of the

- 20 emergency response vehicles shall be designated by the Commissioner

- 24 and Correctional Facility Authority, Division of Juvenile Services

- 4 (L) Authorization for Class A vehicles of emergency response,
- 5 or emergency management personnel or police reserves as designated
- 6 by the Secretary of the Department of Military Affairs and Public
- 7 Safety and the county commission of the county of residence.
- 8 (4) Yellow or amber flashing warning lights are restricted to
- 9 the following:
- 10 (A) All other emergency vehicles, including tow trucks and
- 11 wreckers, authorized by this chapter and by section twenty-seven of
- 12 this article;
- 13 (B) Postal service vehicles and rural mail carriers, as
- 14 authorized in section nineteen of this article;
- 15 (C) Rural newspaper delivery vehicles;
- 16 (D) Flag car services;
- 17 (E) Vehicles providing road service to disabled vehicles;
- 18 (F) Service vehicles of a public service corporation;
- 19 (G) Snow removal equipment;
- 20 (H) School buses; and
- 21 (I) Automotive fire apparatus owned by a municipality or other
- 22 political subdivision, by a volunteer or part-volunteer fire
- 23 company or department or by an industrial fire brigade.
- 24 (5) The use of yellow or amber flashing warning lights shall

1 be authorized as follows:

- 2 (A) Authorization for tow trucks, wreckers, rural newspaper 3 delivery vehicles, flag car services, vehicles providing road 4 service to disabled vehicles, service vehicles of a public service 5 corporation and postal service vehicles shall be designated by the 6 sheriff of the county of residence.
- 7 (B) Authorization for snow removal equipment shall be 8 designated by the Commissioner of the Division of Highways.
- 9 (C) Authorization for school buses shall be designated as set 10 out in section twelve, article fourteen of this chapter.
- (D) Authorization for automotive fire apparatus shall be designated by the fire chief in conformity with the NFPA 1901 Standard for Automotive Fire Apparatus as published by the National Fire Protection Association (NFPA) on July 18, 2003, and adopted by the State Fire Commission by legislative rule (87 CSR 1, et seq.), 6 except as follows:
- 17 (i) With the approval of the State Fire Marshal, used 18 automotive fire apparatus may be conformed to the NFPA standard in 19 effect on the date of its manufacture or conformed to a later NFPA 20 standard; and
- 21 (ii) Automotive fire apparatus may be equipped with blinking 22 or flashing headlamps.
- (e) Notwithstanding the foregoing provisions of this section, 24 any vehicle belonging to a county board of education, an

1 organization receiving funding from the state or Federal Transit
2 Administration for the purpose of providing general public
3 transportation or hauling solid waste may be equipped with a white
4 flashing strobotron warning light. This strobe light may be
5 installed on the roof of a school bus, a public transportation
6 vehicle or a vehicle hauling solid waste not to exceed one-third
7 the body length forward from the rear of the roof edge. The light
8 shall have a single clear lens emitting light three hundred sixty
9 degrees around its vertical axis and may not extend above the roof
10 more than six and one-half inches. A manual switch and a pilot
11 light must be included to indicate the light is in operation.

12 (f) It is unlawful for flashing warning lights of an 13 unauthorized color to be installed or used on a vehicle other than 14 as specified in this section, except that a police vehicle may be 15 equipped with either or both blue or red warning lights.

NOTE: The purpose of this bill is to allow vehicles designated by the Secretary of the Department of Military Affairs and Public Safety for emergency response by West Virginia police reserves to use red flashing lights.
