10	A BILL to amend the Code of West Virginia, 1931, as amended by
11	adding thereto a new article designated §30-1B-1, §30-1B-2,
12	\$30-1B-3 and $$30-1B-4$, all relating to requiring certain
13	boards to combine administrative functions.
14	Be it enacted by the Legislature of West Virginia:
15	That said Code of West Virginia, 1931, as amended, be amended
16	by adding thereto a new article designated §30-1B-1, §30-1B-2, §30-
17	1B-3 and §30-1B-4, all to read as follows:
18	ARTICLE 1B. COMBINATION OF BOARD'S ADMINISTRATIVE FUNCTIONS.
19	§30-1B-1. Legislative findings.
20	The Legislature finds that the Performance Evaluation and
21	Review Division has recommended that Legislature consider creating
22	an umbrella board. In considering PERD's recommendation, the
23	Legislature finds that the creation of an umbrella for all
24	professional boards would be difficult considering the required
25	space and employees that it would effect. Therefore, the

- 1 Legislature finds that it shall require certain professional board
- 2 to combine administration functions and monitor and study the
- 3 process. The majority of boards selected for this process have
- 4 been identified by PERD as not having any employees and lack access
- 5 to the public. These were the main factors in deciding which
- 6 boards should be required to participate. Additionally, the
- 7 selected boards have a small number of licensees, therefore by
- 8 combining functions it is anticipated that licensure fees would
- 9 ultimately decrease.
- 10 §30-1B-2. Participating boards.
- 11 The following boards shall combine administrative functions:
- 12 (1) The Board of Acupuncture;
- 13 (2) The Board of Licensed Dietitians;
- 14 (3) The Board of Foresters;
- 15 (4) The Board of Hearing Aid Dealers; and
- 16 <u>(5) The Board of Massage Therapy.</u>
- 17 §30-1B-3. Process to combine functions.
- 18 (a) The boards shall enter into a memorandum of understanding
- 19 to combine administration functions by June 30, 2012.
- 20 (b) The boards shall provide the Joint Committee on Government
- 21 Organization with updates every three months on its process.
- 22 (c) The boards shall combine administrative functions
- 23 including, but not limited to:
- 24 (1) Location;
- 25 <u>(2) Employees;</u>

- 1 (3) Disciplinary functions; and
- 2 (4) Investigative functions.
- 3 §30-1B-4. Authority to combine administrative functions.
- In completing the combination process, the boards and the
- 5 Executive Director of the Board of Massage Therapy and the Board of
- 6 Acupuncture have all authority necessary to complete the process.
- 7 Each board referenced in section may promulgate emergency rules
- 8 pursuant to section fifteen, article three, chapter twenty-nine-a
- 9 of this code.

NOTE: The purpose of this bill is to require the combination of administrative functions of the Board of Acupuncture, the Board of Licensed Dietitians, the Board of Foresters, the Board of Hearing Aid Dealers and the Board of Massage Therapy.

This article is new; therefore, it has been completely underscored.
