10	A BILL to amend and reenact $\$30-27-5$ of the Code of West Virginia,
11	1931, as amended, relating to licensure requirements;
12	requiring a licensee to submit his or her government issued
13	identification; and permitting the board to keep and use that
14	information.
15	Be it enacted by the Legislature of West Virginia:
16	That $\$30-27-5$ of the Code of West Virginia, 1931, as amended,
17	be amended and reenacted to read as follows:
18	ARTICLE 27. BOARD OF BARBERS AND COSMETOLOGISTS.
19	§30-27-5. Powers and duties of the board.
20	(a) The board has all the powers and duties set forth in this
21	article, by rule, in article one of this chapter and elsewhere in
22	law.
23	(b) The board shall:
24	(1) Hold meetings, conduct hearings and administer

- 3 and registrations;
- 4 (3) Establish procedures for submitting, approving and

- 11 (5) Require licensees to submit his or her government issued
- 12 identification to determine its validity and verify information.
- 13 The board may retain a copy of the government issued identification
- 14 and for creation of its license.

NOTE: The purpose of this bill is to require licensees from the Board of Barbers and Cosmetologists to submit his or her government issued identification to determine its validity and verify information. The board may retain a copy of the government issued identification and for creation of its license.
