10	A BILL to amend and reenact $\$46A-6J-2$ , $\$46A-6J-3$ and $\$46A-6J-6$ of
11	the Code of West Virginia, 1931, as amended, all relating to
12	protection of consumers from price gouging and unfair pricing
13	practices; the sales of gasoline or other motor fuels during
14	a state of emergency; amending definition of state of
15	emergency; creating an alternative pricing formula for fuel
16	suppliers; and updating the preemption provisions.
17	Be it enacted by the Legislature of West Virginia:
18	That $\$46A-6J-2$ , $\$46A-6J-3$ and $\$46A-6J-6$ of the Code of West
19	Virginia, 1931, as amended, be amended and reenacted, all to read
20	as follows:
21	ARTICLE 6J. PROTECTION OF CONSUMERS FROM PRICE GOUGING AND UNFAIR
22	PRICING PRACTICES DURING AND SHORTLY AFTER A STATE
23	OF EMERGENCY.
24	§46A-6J-2. Definitions.

- 1 (a) "Building materials" means lumber, construction tools,
- 2 windows and any other item used in the building or rebuilding of
- 3 property.
- 4 (b) "Consumer food item" means any article that is used or
- 5 intended for use for food or drink by a person or animal.
- 6 (c) "Disaster" means the occurrence or imminent threat of
- 7 widespread or severe damage, injury, or loss of life or property
- 8 resulting from any natural or man-made cause, including fire,
- 9 flood, earthquake, wind, snow, storm, chemical or oil spill or
- 10 other water or soil contamination, epidemic, air contamination,

- 18 §46A-6J-3. Prohibited unfair pricing practices.
- 19 (a) Upon the declaration of a state of emergency and
- 20 continuing for the existence of the state of emergency or for
- 21 thirty days following the declaration, whichever period is longer,
- 22 it is unlawful for any person, contractor, business, or other
- 23 entity to sell or offer to sell to any person in the area subject
- 24 to the declaration any consumer food items, essential consumer

1 items, goods used for emergency cleanup, emergency supplies, 2 medical supplies, home heating oil, building materials, housing, 3 transportation, freight and storage services, or gasoline or other 4 motor fuels for a price greater than ten percent above the price 5 charged by that person for those goods or services on the tenth day 6 immediately preceding the declaration of emergency, unless the 7 increase in price was is directly attributable to additional costs 8 imposed on the seller by the supplier of the goods or directly 9 attributable to additional costs for labor or materials used to 10 provide the services: Provided, That in those situations where the 11 increase in price is attributable to additional costs imposed by 12 the seller's supplier or additional costs of providing the good or 13 service during the state of emergency, the price is no greater than 14 ten percent above the total of the cost to the seller plus the 15 markup customarily applied by the seller for that good or service 16 in the usual course of business on the tenth day immediately Provided, however, That where a 17 preceding the declaration: 18 supplier of gasoline or other motor fuels cannot determine their 19 daily costs, the supplier may sell gasoline or other motor fuels to 20 distributers on any day at a rate not to exceed the average of the 21 Oil Price Information Service's average wholesale rack price for 22 that product at the Montvale/Roanoke, Virginia, Fairfax, Virginia 23 and Pittsburgh, Pennsylvania wholesale racks for the previous day. (b) Upon the declaration of a state of emergency, and for a 24

1 period of one hundred eighty days following that declaration, it is 2 unlawful for any contractor to sell or offer to sell any repair or 3 reconstruction services or any services used in emergency cleanup 4 in the area subject to the declaration for a price greater than ten 5 percent above the price charged by that person for those services 6 on the tenth day immediately preceding the declaration, unless the 7 increase in price was directly attributable to additional costs 8 imposed on it by the supplier of the goods or directly attributable 9 to additional costs for labor or materials used to provide the 10 services: Provided, That in those situations where the increase in 11 price is attributable to the additional costs imposed by the 12 contractor's supplier or additional costs of providing the service, 13 the price is no greater than ten percent above the total of the 14 cost to the contractor plus the markup customarily applied by the 15 contractor for that good or service in the usual course of business 16 on the tenth day immediately preceding to the declaration of the 17 state of emergency.

- 18 (c) Any business offering an item for sale at a reduced price
  19 ten days immediately prior to the declaration of the state of
  20 emergency may use the price at which it usually sells the item to
  21 calculate the price pursuant to subsection (a) or (b) of this
  22 section.
- 23 (d) The price restrictions imposed by this article may be 24 limited or terminated by proclamation of the Governor.

## 1 §46A-6J-6. Preemption.

- 2 Nothing in this section preempts any local ordinance
- 3 prohibiting the same or similar conduct or imposing a more severe
- 4 penalty for the same conduct prohibited in this section. This
- 5 article preempts any local ordinance prohibiting the same or
- 6 similar conduct.

NOTE: The bill includes a special rule permitting suppliers of gasoline or other motor fuels to sell product to distributers at a price not to exceed the average of the Oil Price Information Service's average wholesale rack price for that product at the Montvale/Roanoke, Virginia, Fairfax, Virginia and Pittsburgh, Pennsylvania wholesale racks for the previous day during a state of emergency.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.

This bill was recommended for introduction and passage during the Regular Session of the Legislature by the Joint Committee on the Judiciary.
