18	(a) Notwithstanding any provision of this code to the
19	contrary, the Commissioner of the West Virginia Division of
20	Highways may continue with the pilot program to expedite the
21	construction of no more than ten special projects, in addition to
22	the three projects authorized by prior enactment of this section,
23	by combining the design and construction elements of a highway or
24	bridge project into a single contract.

- 1 (b) A design-build project may not be let to contract after
- 2 June 30, 2011 <u>2013.</u> The Division of Highways may expend no more
- 3 than \$50 million in each of the three years remaining in the pilot
