- 1 may pertain to a driver, commercial motor vehicle or a motor
- 2 carrier operation; providing that the licensed driver
- 3 accompanying a driver holding an instruction permit must be
- 4 alert and unimpaired; adding additional certifications to the
- 5 application and the face of a commercial driver's license;
- 6 providing for additional requirements related to maintenance
- 7 and verification of medical certification status; and
- 8 prohibiting the division from issuing or renewing a commercial
- 9 driver's license to a person who does not possess a valid
- 10 medical certification status.
- 11 Be it enacted by the Legislature of West Virginia:
- 12 That \$17E-1-3, \$17E-1-6, \$17E-1-9, \$17E-1-10, \$17E-1-11, \$17E-
- 13 1-12, §17E-1-13, §17E-1-17 and §17E-1-20 of the Code of West
- 14 Virginia, 1931, as amended, be amended and reenacted; and to amend
- 15 said code by adding thereto a new section, designated §17E-1-14a,
- 16 all to read as follows:
- 17 ARTICLE 1. COMMERCIAL DRIVER'S LICENSE.
- 18 \$17E-1-3. Definitions.
- 19 Notwithstanding any other provision of this code, the
- 20 following definitions apply to this article:
- 21 (1) "Alcohol" means:
- 22 (A) Any substance containing any form of alcohol, including,
- 23 but not limited to, ethanol, methanol, propenyl and isopropanol;
- 24 (B) Beer, ale, port or stout and other similar fermented

- 1 beverages, including sake or similar products, of any name or
- 2 description containing one half of one percent or more of alcohol
- 3 by volume, brewed or produced from malt, wholly or in part, or from
- 4 any substitute for malt;
- 5 (C) Distilled spirits or that substance known as ethyl
- 6 alcohol, ethanol or spirits of wine in any form including all
- 7 dilutions and mixtures thereof from whatever source or by whatever
- 8 process produced; or
- 9 (D) Wine of not less than one half of one percent of alcohol 10 by volume.
- 11 (2) "Alcohol concentration" means:
- 12 (A) The number of grams of alcohol per one hundred milliliters
 13 of blood;
- 14 (B) The number of grams of alcohol per two hundred ten liters
 15 of breath; or
- 16 (C) The number of grams of alcohol per sixty-seven milliliters
 17 of urine; or
- 18 (D) The number of grams of alcohol per eighty-six milliliters
 19 of serum.
- 20 (3) "At fault traffic accident" means, for the purposes of
- 21 waiving the road test, a determination of fault by the official
- 22 filing the accident report $\frac{\text{of fault}}{\text{of accident}}$ as evidenced by an indication
- 23 of contributing circumstances in the accident report.
- 24 (4) "Commercial driver's license" means a license or an

- 1 instruction permit issued in accordance with the requirements of
- 2 this article to an individual which authorizes the individual to
- 3 drive a class of commercial motor vehicle.
- 4 (5) "Commercial driver's license information system" is the
- 5 information system established pursuant to the Federal Commercial
- 6 Motor Vehicle Safety Act to serve as a clearinghouse for locating
- 7 information related to the licensing and identification of
- 8 commercial motor vehicle drivers.
- 9 (6) "Commercial driver instruction permit" means a permit
- 10 issued pursuant to subsection (d), section nine of this article.
- 11 (7) "Commercial motor vehicle" means a motor vehicle designed
- 12 or used to transport passengers or property:
- 13 (A) If the vehicle has a gross combination vehicle weight
- 14 rating of twenty-six thousand one pounds or more inclusive of a
- 15 towed unit(s) with a gross vehicle weight rating of more than ten
- 16 thousand pounds;
- 17 (B) If the vehicle has a gross vehicle weight rating of more
- 18 than twenty-six thousand one pounds or more;
- 19 (C) If the vehicle is designed to transport sixteen or more
- 20 passengers, including the driver; or
- 21 (D) If the vehicle is of any size <u>and</u> transporting hazardous
- 22 materials as defined in this section.
- 23 (8) "Commissioner" means the Commissioner of Motor Vehicles of
- 24 this state.

1 (9) "Controlled substance" means any substance classified
2 under the provisions of chapter sixty-a of this code, the Uniform
3 Controlled Substances Act, and includes all substances listed on
4 Schedules I through V, inclusive, of article two of said chapter,
5 sixty-a, as they are as revised. The term "controlled substance"
6 also has the meaning such term has under 21 U.S.C. §802.6 and
7 includes all substances listed on Schedules I through V of 21

8 C.F.R. §1308 as they may be amended by the United States

9 Department of Justice.

- (10) "Conviction" means an unvacated adjudication of guilt; a

 11 determination that a person has violated or failed to comply with

 12 the law in a court of original jurisdiction or by an authorized

 13 administrative tribunal or proceeding; an unvacated forfeiture of

 14 bail or collateral deposited to secure the persons appearance in

 15 court; a plea of guilty or nolo contendere accepted by the court or

 16 the payment of a fine or court cost or violation of a condition of

 17 release without bail regardless of whether or not the penalty is

 18 rebated, suspended, or probated.
- 19 (11) "Division" means the Division of Motor Vehicles.
- 20 (12) "Disqualification" means any of the following three 21 actions:
- 22 (A) The suspension, revocation, or cancellation of a driver's 23 license by the state or jurisdiction of issuance.
- 24 (B) Any withdrawal of a person's privilege to drive a

- 1 commercial motor vehicle by a state or other jurisdiction as the
- 2 result of a violation of state or local law relating to motor
- 3 vehicle traffic control other than parking or vehicle weight except
- 4 as to violations committed by a special permittee on the coal
- 5 resource transportation system or vehicle defect violations.
- 6 (C) A determination by the Federal Motor Carrier Safety
- 7 Administration that a person is not qualified to operate a
- 8 commercial motor vehicle under 49 C.F.R. Part §391 (2004).
- 9 (13) "Drive" means to drive, operate or be in physical control
- 10 of a motor vehicle in any place open to the general public for
- 11 purposes of vehicular traffic. For the purposes of sections
- 12 twelve, thirteen and fourteen of this article, "drive" includes
- 13 operation or physical control of a motor vehicle anywhere in this
- 14 state.
- 15 (14) "Driver" means any a person who drives, operates or is in
- 16 physical control of a commercial motor vehicle in any place open to
- 17 the general public for purposes of vehicular traffic or who is
- 18 required to hold a commercial driver's license.
- 19 (15) "Driver's license" means a license issued by a state to
- 20 an individual which authorizes the individual to drive a motor
- 21 vehicle of a specific class.
- 22 (16) "Electronic device" includes, but is not limited to, a
- 23 <u>cellular telephone</u>, <u>personal digital assistant</u>, <u>pager or any other</u>
- 24 device used to input, write, send, receive, or read text.

- 1 (16) (17) "Employee" means any an operator of a commercial
- 2 motor vehicle, including full time, regularly employed drivers,
- 3 casual, intermittent or occasional drivers, leased drivers and
- 4 independent, owner-operator contractors (while in the course of
- 5 when operating a commercial motor vehicle, who are either directly
- 6 employed by or under lease to drive a commercial motor vehicle for
- 7 an employer.
- 8 $\frac{(17)}{(18)}$ "Employer" means $\frac{1}{2}$ person, including the United
- 9 States, a state or a political subdivision of a state, who owns or
- 10 leases a commercial motor vehicle or assigns a person to drive a
- 11 commercial motor vehicle.
- 12 $\frac{(18)}{(19)}$ "Endorsement" means an authorization to a person to
- 13 operate certain types of commercial motor vehicles.
- 14 (19) (20) "Farm vehicle" includes a motor vehicle or
- 15 combination vehicle registered to the a farm owner or entity
- 16 operating the farm and used exclusively in the transportation of
- 17 agricultural or horticultural products, livestock, poultry and
- 18 dairy products from the farm or orchard on which they are raised or
- 19 produced to markets, processing plants, packing houses, canneries,
- 20 railway shipping points and cold storage plants and in the
- 21 transportation of agricultural or horticultural supplies and
- 22 machinery to the farms or orchards to be used on the farms or
- 23 orchards.
- 24 (20) (21) "Farmer" includes an owner, tenant, lessee, occupant

- 1 or person in control of the premises used substantially for
- 2 agricultural or horticultural pursuits who is at least eighteen
- 3 years of age with two years licensed driving experience.
- 4 (21) (22) "Farmer vehicle driver" means the person employed
- 5 and designated by the "farmer" to drive a "farm vehicle" as long as
- 6 driving is not his or her sole or principal function on the farm
- 7 and who is at least eighteen years of age with two years licensed
- 8 driving experience.
- 9 (22) "Felony" means an offense under state or federal law
- 10 that is punishable by death or imprisonment for a term exceeding
- 11 one year.
- 12 (24) "Gross combination weight rating (GCWR)" means the
- 13 value specified by the manufacturer as the loaded weight of a
- 14 combination, articulated vehicle. In the absence of a value
- 15 specified by the manufacturer, GCWR will be determined by adding
- 16 the GVWR gross vehicle weight rating (GVWR) of the power unit and
- 17 the total weight of the towed unit and any load thereon. load, if
- 18 <u>any</u>.
- 19 (24) (25) "Gross vehicle weight rating (GVWR)" means the value
- 20 specified by the manufacturer as the loaded weight of a single
- 21 vehicle. In the absence of a value specified by the manufacturer,
- 22 the GVWR will be determined by the total weight of the vehicle and
- 23 any load thereon. load, if any.
- 24 (25) (26) "Hazardous materials" means any material that has

- 1 been designated as hazardous under 49 U.S.C. §5103 and is required
- 2 to be placarded under subpart F of 49 C.F.R., Part §172 or any
- 3 quantity of a material listed as a select agent or toxin in 42
- 4 C.F.R., Part §73.
- 5 $\frac{(26)}{(27)}$ "Imminent hazard" means existence of a condition
- 6 that presents a substantial likelihood that death, serious illness,
- 7 severe personal injury or a substantial endangerment to health,
- 8 property or the environment may occur before the reasonably
- 9 foreseeable completion date of a formal proceeding begun to lessen
- 10 the risk of that death, illness, injury or endangerment.
- 11 $\frac{(27)}{(28)}$ "Issuance of a license" means the completion of a
- 12 transaction signifying that the applicant has met all the
- 13 requirements incumbent in qualifying to qualify for, including, but
- 14 not limited to: The initial issuance of a driver's license, the
- 15 renewal of a driver's license, the issuance of a duplicate license
- 16 as a replacement to a lost or stolen driver's license, the transfer
- 17 of any level of driving privileges including the privilege of
- 18 operating a commercial motor vehicle from another state or
- 19 jurisdiction, the changing of driver's license class, restrictions
- 20 or endorsements or the change of any other information pertaining
- 21 to an applicant either appearing on the face of a driver's license
- 22 or within the driver record of the licensee maintained by the
- 23 division.
- 24 (28) (29) "Motor vehicle" means every vehicle which is self-

- 1 propelled and every vehicle which is propelled by electric power
- 2 obtained from overhead trolley wires but not operated upon rails.
- 3 (29) (30) "Noncommercial motor vehicle" means a motor vehicle
- 4 or combination of motor vehicles not defined by the term
- 5 "commercial motor vehicle".
- 6 (30) (31) "Out-of-service order" means a temporary prohibition
- 7 against driving a commercial motor vehicle as a result of a
- 8 determination by a law-enforcement officer, a declaration by an
- 9 authorized enforcement officer of a federal, state, Canadian,
- 10 Mexican, county or local jurisdiction including any special agent
- 11 of the Federal Motor Carrier Safety Administration that a driver,
- 12 <u>a commercial motor vehicle</u>, or a motor carrier operation is out of
- 13 service pursuant to 49 C.F.R. §§386.72, 392.5, 395.13, 396.9 or
- 14 compatible laws or the North American uniform out-of-service
- 15 criteria that an imminent hazard exists.
- 16 (31) (32) "Violation of an out-of-service order" means:
- 17 (A) The operation of a commercial motor vehicle during the
- 18 period the driver was placed out-of-service; or
- 19 (B) The operation of a commercial motor vehicle by a driver
- 20 after the vehicle was placed out-of-service and before the required
- 21 repairs are made; or
- (C) The operation of any commercial vehicle by a motor carrier
- 23 operation after the carrier has been placed out of service.
- 24 (32) (33) "School bus" means a commercial motor vehicle used to

- 1 transport preprimary, preprimary, primary or secondary school
- 2 students from home-to-school, from school-to-home or to and from
- 3 school sponsored events. School bus does not include a bus used as
- 4 a common carrier.
- 5 (33) (34) "Serious traffic violation" means conviction for any
- 6 of the following offenses when operating a commercial motor
- 7 vehicle:
- 8 (A) Excessive speeding involving any single offense for any
- 9 speed of fifteen miles per hour or more above the posted limits;
- 10 (B) Reckless driving as defined in section three, article
- 11 five, chapter seventeen-c of this code and careless or negligent
- 12 driving, including, but not limited to, the offenses of driving a
- 13 commercial motor vehicle in willful or wanton disregard for the
- 14 safety of persons or property;
- 15 (C) Erratic or improper traffic lane changes including, but
- 16 not limited to, passing a school bus when prohibited, improper lane
- 17 changes and other passing violations;
- 18 (D) Following the vehicle ahead too closely;
- 19 (E) Driving a commercial motor vehicle without obtaining a
- 20 commercial driver's license;
- 21 (F) Driving a commercial motor vehicle without a commercial
- 22 driver's license in the driver's possession. However, any person
- 23 who provides proof to the law-enforcement agency that issued the
- 24 citation, by the date the person must appear in court or pay any

- 1 fine for such violation, that the person held a valid commercial
- 2 driver's license on the date the citation was issued, shall not be
- 3 guilty of this offense;
- 4 (G) Driving a commercial motor vehicle without the proper
- 5 class of commercial driver's license and/ or endorsements for the
- 6 specific vehicle group being operated or for the passengers or type
- 7 of cargo being transported;
- 8 (H) A violation of state or local law relating to motor
- 9 vehicle traffic control, other than a parking violation, arising in
- 10 connection with a fatal traffic accident; or
- 11 (I) Any other serious violations determined by the United
- 12 States Secretary of Transportation.
- 13 (J) Vehicle defects are excluded as serious traffic violations
- 14 except as to violations committed by a special permittee on the
- 15 coal resource transportation road system.
- (34) (35) "State" means a state of the United States and the
- 17 District of Columbia or a province or territory of Canada or a
- 18 state or federal agency of the United Mexican States.
- 19 (35) (36) "State of domicile" means the state where a person
- 20 has his or her true, fixed and permanent home and principle
- 21 residence and to which he or she has the intention of returning
- 22 whenever absent in accordance with chapter seventeen-a, article
- 23 three, section one-a.
- 24 (36) "Suspension, revocation or cancellation" of a

- 1 driver's license or a commercial driver's license means the
- 2 privilege to operate any type of motor vehicle on the roads and
- 3 highways of this state is withdrawn.
- 4 (37) (38) "Tank vehicle" means any commercial motor vehicle
- 5 that is designed to transport any liquid or gaseous materials
- 6 within a tank that is either permanently or temporarily attached to
- 7 the vehicle or the chassis. These vehicles include, but are not
- 8 limited to, cargo tanks and portable tanks as defined in 49 C. F.
- 9 R. Part 171 (1998). However, This definition does not include
- 10 portable tanks having a rated capacity under one thousand gallons.
- 11 (39) "Texting" means manually entering alphanumeric text into
- 12 or reading text from an electronic device.
- 13 (A) This action includes, but is not limited to, short
- 14 messaging service, e-mailing, instant messaging and a command or
- 15 request to access a World Wide Web page or engaging in any other
- 16 form of electronic text retrieval or entry for present or future
- 17 communication.
- 18 (B) Texting does not include:
- 19 (i) Reading, selecting or entering a telephone number, an
- 20 extension number or voicemail retrieval codes and commands into an
- 21 <u>electronic device for the purpose of initiating or receiving a</u>
- 22 phone call or using voice commands to initiate or receive a
- 23 telephone call;
- 24 (ii) Inputting, selecting or reading information on a global

- 1 positioning system or navigation system; or
- 2 (iii) Using a device capable of performing multiple functions
- 3 including, but not limited to, fleet management systems,
- 4 dispatching devices, smart phones, citizen band radios or music
- 5 players for a purpose that is not otherwise prohibited by this
- 6 section
- 7 (38) (40) "Transportation Security Administration" means the
- 8 United States Department of Homeland Security Transportation
- 9 Security Administration.
- 10 $\frac{(39)}{(41)}$ "United States" means the fifty states and the
- 11 District of Columbia.
- 12 (42) "Valid or Certified Medical Certification Status" means
- 13 that an applicant or driver has a current medical evaluation or
- 14 determination by a licensed physician that the applicant or driver
- 15 meets the minimum federal motor carrier safety administration
- 16 physical qualifications within the prescribed time frames pursuant
- 17 49 CFR Part §391. Not-certified means that an applicant or driver
- 18 does not have a current medical evaluation or has not been
- 19 certified by a <u>licensed physician as meeting the minimum federal</u>
- 20 motor carrier safety administration physical qualifications
- 21 pursuant 49 CFR Part §391.
- 22 (40) "Vehicle Group" means a class or type of vehicle with
- 23 certain operating characteristics.
- 24 §17E-1-6. Employer responsibilities.

- 1 (a) Each employer shall require the applicant to provide the 2 information specified in section five of this article.
- 3 (b) No employer may knowingly allow, permit, require or 4 authorize a driver to drive a commercial motor vehicle during any 5 period in which the driver:
- 6 (1) Has a driver's license suspended, revoked or canceled by 7 a state; has lost the privilege to drive a commercial motor vehicle 8 in a state or has been disqualified from driving a commercial motor 9 vehicle;
- 10 (2) Has more than one driver's license at one time;
- 11 (3) $\frac{\partial \mathbf{r}}{\partial \mathbf{r}}$ The commercial motor vehicle he or she is driving or
- 12 the motor carrier operation is subject to an out-of-service order;
- 13 (4) Is in violation of federal, state or local law or 14 regulation pertaining to railroad highway grade crossings; or
- 15 (5) Is in violation of any provision of 49 C.F.R., Part § 382 16 related to controlled substances and alcohol use and testing.
- 17 <u>(c) No employer may require or allow a driver to operate a</u>
 18 commercial motor vehicle while texting.
- (c) (d) The division shall impose a civil penalty in addition to any penalty required under the provisions of section twenty-five of this article on any employer who knowingly allows, permits, requires or authorizes a driver to drive a commercial motor vehicle in violation of subdivision (3) or (4) of subsection (b) or subsection (c) of this section.

- 1 (1) If the conviction is for a violation of subdivision (3), 2 of subsection (b) of this section, the penalty is \$2,750.
- 3 (2) If the conviction is for a violation of subdivision (4), 4 of subsection (b) of this section, the penalty shall be no more 5 than \$25,000.

6 §17E-1-9. Commercial driver license qualification standards.

- (a) No person may be issued a commercial driver's license unless that person is a resident of this state and has passed a knowledge and skills test for driving a commercial motor vehicle which complies with minimum federal standards established by federal regulations enumerated in 49 C.F.R. Part § 383, Subparts G and H (2004) and has satisfied all other requirements of the Federal Motor Carrier Safety Improvement Act of 1999 in addition to other requirements imposed by state law or federal regulations.
- 15 (b) Third party testing. The commissioner may authorize a 16 person, including an agency of this or another state, an employer, 17 private individual or institution, department, agency or 18 instrumentality of local government, to administer the skills test 19 specified by this section *Provided*, That: so long as:
- 20 (1) The test is the same which would otherwise be administered 21 by the state; and
- 22 (2) The party has entered into an agreement with the state 23 which that complies with the requirements of 49 C.F.R., part \$ 24 383.75.

- 1 (c) Indemnification of driver examiners. No person who has
 2 been officially trained and certified by the state as a driver
 3 examiner, who administers a driving test, and no other person, firm
 4 or corporation by whom or with which that person is employed or is
 5 in any way associated, may be criminally liable for the
 6 administration of the tests or civilly liable in damages to the
 7 person tested or other persons or property unless for gross
 8 negligence or willful or wanton injury.
- 9 (d) The commissioner may waive the skills test specified in 10 this section for a commercial driver license applicant who meets 11 the requirements of 49 C.F.R. part § 383.77 and those the 12 requirements specified by the commissioner.
- (e) A commercial driver's license or commercial driver's 14 instruction permit may not be issued to a person while the person 15 is subject to a disqualification from driving a commercial motor 16 vehicle, when the person does not possess a valid or current 17 medical certification status or while the person's driver's license 18 is suspended, revoked or canceled in any state. Nor may A 19 commercial driver's license may not be issued by any other state 20 unless the person first surrenders all such licenses to the 21 division.
- 22 (f) Commercial driver's instruction permit may be issued as 23 follows:
- 24 (1) A commercial driver's instruction permit may be issued To

- 1 an individual who holds a valid Class E or Class D driver's license
- 2 who and has passed the vision and written tests required for
- 3 issuance of a commercial driver's license.
- 4 (2) The commercial instruction permit may not be issued for a
- 5 period to exceed six months. Only one renewal or reissuance may be
- 6 granted within a two-year period. The holder of a commercial
- 7 driver's instruction permit may drive a commercial motor vehicle on
- 8 a highway only when accompanied by the holder of a commercial
- 9 driver's license valid for the type of vehicle driven, who is
- 10 twenty-one years of age or older, who is alert and unimpaired and
- 11 who occupies a seat beside the individual for the purpose of giving
- 12 instruction or testing.
- 13 (3) A commercial driver's instruction permit may only be
- 14 issued Only to a person who is at least eighteen years of age and
- 15 has held a graduated Class E, Class E or Class D license for at
- 16 least two years.
- 17 (4) The applicant for a commercial driver's instruction permit
- 18 shall also be otherwise qualified to hold a commercial driver's
- 19 license.
- 20 §17E-1-10. Application for commercial driver's license.
- 21 (a) The application for a commercial driver's license or
- 22 commercial driver's instruction permit must include at least the
- 23 following:
- 24 (1) The full name and current mailing and residential address

- 1 of the person;
- 2 (2) A physical description of the person including sex,
- 3 height, weight and eye color;
- 4 (3) Date of birth;
- 5 (4) The applicant's social security number;
- 6 (5) The person's signature;
- 7 (6) The person's color photograph;
- 8 (7) Certifications including those required by 49 C.F.R. Part
- 9 \$ 383.71(a)(2004);
- 10 (8) Any other information required by the commissioner; and
- 11 (9) A consent to release driving record information; and
- 12 (10) Certification stating that the applicant is:
- 13 (A) Engaged in interstate commerce and subject to 49 C.F.R.
- 14 Part §391 standards;
- 15 (B) Engaged in interstate commerce but excepted from 49 C.F.R.
- 16 Part §391 standards;
- 17 (C) Engaged in intrastate commerce and subject to state
- 18 medical standards; or
- 19 (D) Engaged in intrastate commerce but not subject to state
- 20 medical standards.
- 21 (b) When a licensee changes his or her name, mailing address
- 22 or residence, or when a licensee's classifications, endorsements,
- 23 or restrictions or medical certification status changes; the
- 24 licensee shall submit an application for a duplicate license and

- 1 obtain a duplicate driver's license displaying the updated
- 2 information.
- 3 (c) No person who has been a resident of this state for thirty
- 4 days or more may drive a commercial motor vehicle under the
- 5 authority of a commercial driver's license issued by another

NOTE: The purpose of this bill is to conform West Virginia law concerning the issuance and maintenance of commercial driver's licenses with federal law and rule. The focus of these changes is to codifying requirements that CDL drivers maintain current medical certification that they meet minimum federal medical standards for operating commercial motor vehicles as well as prohibit drivers from texting when operating a commercial motor vehicle.
