10	A BILL to amend and reenact $\$18A-4-2b$ of the Code of West Virginia,
11	1931, as amended, relating to minimum salary supplement and
12	educational expense reimbursement for professional personnel
13	with recognized national certification.
14	Be it enacted by the Legislature of West Virginia:
15	That \$18A-4-2b of the Code of West Virginia, 1931, as amended,
16	be amended and reenacted to read as follows:
17	ARTICLE 4. SALARIES, WAGES AND OTHER BENEFITS.
18	§18A-4-2b. State minimum salary supplement and educational
19	expense reimbursement for professional personnel
20	with recognized national certification in speech-
21	language pathology, audiology, counseling, school
22	psychology or school nursing.
23	(a) (1) The Legislature finds that achieving a nationally
24	recognized professional certification in speech-language pathology
25	or audiology involves a rigorous process of demonstrating both
26	knowledge and skills and results in highly trained and capable

Individuals attain national professional 2 certification by the American Speech-Language-Hearing Association 3 provide needed and essential services to the school students of Individuals should be encouraged to achieve and 4 this state. 5 maintain the national professional certification 6 reimbursement of expenses and a salary bonus which reflects their 7 additional certification.
- 8 (2) The Legislature finds that the rigorous standards and 9 processes for advanced certification by either the National Board 10 of Certified Counselors or the West Virginia Board of Examiners in 11 Counseling helps to promote the quality of counseling in schools. 12 Counselors in the public schools of West Virginia should be 13 encouraged to achieve and maintain the advanced certification 14 through reimbursement of expenses and a salary bonus that reflects 15 their additional certification.
- 16 (3) The Legislature finds that achieving a nationally 17 recognized professional certification in school psychology involves 18 a rigorous process of demonstrating competencies in scientific 19 research-based knowledge and skills. School psychologists provide 20 assessment, counseling and consultation to students, teachers, 21 school administrators and parents. Individuals who attain national 22 professional certification by the National Association of School 23 Psychologists provide services to students, families and school 24 systems in this state. School psychologists should be encouraged 25 to achieve and maintain this national professional certification 26 through reimbursement of expenses and a salary bonus which reflects

1 their additional certification.

- 2 (4) The Legislature finds that achieving a nationally 3 recognized professional certification in school nursing involves a 4 rigorous process of demonstrating competencies in health care and 5 nursing applications, knowledge and skills. School nurses provide 6 assessment, counseling and consultation to students, teachers, 7 school administrators and parents. School nurses who attain 8 national professional certification by the National Board for 9 Certification of School Nurses provide services to students, 10 families and school systems in this state. School nurses should be 11 encouraged to achieve and maintain this national professional 12 certification through reimbursement of expenses and a salary bonus 13 which reflects their additional certification.
- 14 (5) The Legislature finds that achieving a nationally
 15 recognized professional certification in school social work helps
 16 promote the quality of social work services in schools. School
 17 social workers provide psychosocial assessment, counseling,
 18 conflict resolution, case management, community resource
 19 development, referral services and consultation to students,
 20 teachers, school administrators and parents. School social workers
 21 who achieve certification are better equipped to address the
 22 negative psycho-social, socio-economic, human relationship, family
 23 and systemic factors which impair student attendance and success.
 24 Individuals who attain the National Association of Social Workers'
 25 Certified School Social Work Specialist certification provide
 26 services to students, families and school systems in this state.

- 1 School social workers should be encouraged to achieve and maintain
- 2 this national professional certification through reimbursement of
- 3 expenses and a salary bonus which reflects their additional
- 4 certification.
- 5 <u>(6)</u> Therefore, the purpose of this section is:
- 6 (A) To provide a statewide salary supplement for certain
- 7 professional personnel employed in the public schools who hold
- 8 nationally recognized professional certification in speech-language
- 9 pathology, audiology, counseling, school psychology, or school
- 10 nursing or social work;
- 11 (B) To treat these professional certifications equally;
- 12 (C) To encourage others to attain such a certification; and
- 13 (D) To help school systems recruit these highly qualified 14 professionals.
- 15 (b) In addition to any amounts prescribed in the applicable
- 16 state minimum salary schedule, any professional personnel who hold
- 17 national certification or other credential as provided in this
- 18 section shall be paid an annual salary supplement of \$2,500. The
- 19 payment is:
- 20 (1) To be made in equal monthly installments;
- 21 (2) To be considered a part of the state minimum salaries for
- 22 teachers; and
- 23 (3) To continue for the life of the certification, or for ten
- 24 years for any one certification, whichever first expires.
- 25 (c) Professional personnel employed as speech-language
- 26 pathologists, audiologists, counselors, school psychologists, or

- 1 school nurses or social workers are eligible upon enrollment for 2 reimbursement for one half of the fee for certification in 3 accordance with this section. In addition, these personnel are 4 eligible upon attainment of the certification for reimbursement of 5 the remainder of the application fee plus other expenses actually 6 incurred toward attainment of the certification, not exceeding 7 \$600, upon approval by the Department of Education. Not more than 8 one hundred fifteen speech-language pathologists, audiologists, 9 counselors, school psychologists, and school nurses and social 10 workers, combined total, are eligible for reimbursement in any one 11 fiscal year.
- (d) Notwithstanding subsection (b) of this section, for the school year beginning July 1, 2008 2011, the number of speech-language pathologists, audiologists, counselors, school psychologists, and school nurses and social workers paid the annual salary supplement provided for in said subsection may not exceed the number of speech-language pathologists, audiologists, and counselors, school psychologists, school nurses or social workers eligible to be paid the annual salary supplement under the provisions of this section in effect during the school year beginning July 1, 2007, by more than one hundred fifteen qualified recipients, and the total amount of qualified recipients may not increase thereafter by more than one hundred fifteen in each subsequent fiscal year.
- 25 (e) The state board shall promulgate a legislative rule 26 establishing criteria for selection of the individuals eligible for

- 1 reimbursement and a salary supplement in accordance with this
- 2 section. The selection criteria shall prioritize the length of
- 3 time the certification has been held and the years of experience of
- 4 the holder in determining eligibility.
- 5 (f) The state board shall report the rule to the Legislative
- 6 Oversight Commission on Education Accountability by the January,
- 7 2009, legislative interim meeting period and shall report on its
- 8 progress in developing the rule to the commission during prior
- 9 interim meetings as requested.
- 10 (g) No provision of this section may be construed to require
- 11 any appropriation, or any specific level of appropriation, by the
- 12 Legislature, or payment of any supplement or reimbursement
- 13 described in this section for which a specific appropriation has
- 14 not been made.
- 15 (h) Notwithstanding any other provision of this section or the
- 16 provisions of section two-a of this article, professional personnel
- 17 may not be paid a salary supplement pursuant to the provisions of
- 18 both said sections.

NOTE: The purpose of this bill is to add school social workers to the list of professional personnel who may receive salary supplement and educational expense reimbursement for achieving recognized national certification. The maximum number of professional personnel eligible to receive salary supplement and educational expense reimbursement remains unchanged.
