That Executive Order 4-93 23 recognized the West Virginia Geographical Information System Policy 24 Council to oversee the implementation of the State GIS Development

- 3 plan, the development of a GIS users group to educate, train and

- 7 (a) "GIS Plan" means the Geographical Information System Plan.

- 5 The Chief Technology Officer shall ensure the security of all

- 8 §5A-6B-5. Legislative rules.
- 9 The Statewide GIS Coordinator in consultation with the Chief
- 10 Technology Officer shall propose legislative rules for legislative
- 11 promulgation, in accordance with the provisions of article three,
- 12 chapter twenty-nine-a of this code, as may be necessary to
- 13 standardize and make effective the provisions of this article.
