  11 other provision of this code to the contrary, The annual salary of

Secretaries of the departments shall be 3 paid an annual salary as follows: Health and Human Resources, 4 \$95,000; Transportation, \$95,000: Provided, That if the same 5 person is serving as both the Secretary of Transportation and the 6 Commissioner of Highways, he or she shall be paid \$120,000; 7 Revenue, \$95,000; Military Affairs and Public Safety, \$95,000; 8 Administration, \$95,000; Education and the Arts, \$95,000; Commerce, Veterans' Assistance, \$95,000; and Environmental 9 \$95,000; 10 Protection, \$95,000; Provided, however, That any increase in the 11 salary of any current appointive state officer named in this 12 subsection pursuant to the reenactment of this subsection during 13 the regular session of the Legislature in 2006 that exceeds \$5,000 14 shall be paid to such officer or his or her successor beginning on 15 July 1, 2006, in annual increments of \$5,000 per fiscal year, up to 16 the maximum salary provided in this subsection: Provided further, 17 That if the same person is serving as both the Secretary of 18 Transportation and the Commissioner of Highways, then the annual 19 increments of \$5,000 per fiscal year do not apply.

Each of the appointive state officers are subject to the existing qualifications for holding each respective office and each has and is hereby granted all of the powers and authority and shall perform all of the functions and services heretofore vested in and performed by virtue of existing law respecting each office.
- Prior to July 1, 2006, each such named appointive state officer shall continue to receive the annual salaries they were receiving as of the effective date of the enactment of this section in 2006 and thereafter, notwithstanding any other provision of this code to the contrary, the annual salary of each named appointive state officer shall be as follows:
- Commissioner, State Tax Division, \$92,500; <u>Insurance</u>
  Commissioner, <u>Insurance Commission</u>, \$92,500; Director, Lottery

- 2 therefrom has been other than dishonorable.

- 6 and the Secretary of the Department of Veteran's Assistance,
- 7 respectively.
- 8 §9A-1-1a. Department of Veterans' Assistance; office of Secretary
- 9 of Department of Veterans' Assistance.
- 10 (a) The Secretary of the Department of Veterans' Assistance is 11 the chief executive officer of the department. Subject to the 12 requirements for the qualification and appointment of the 13 secretary provided in section four of this article, the Governor 14 shall appoint the secretary, by and with the advice and consent of 15 the Senate, for the term for which the Governor is elected and 16 until a successor shall have been appointed and qualified. 17 Secretary shall serve at the will and pleasure of the Governor. Any 18 reference in this code to the Division of Veterans Affairs or to 19 the Department of Veterans Affairs means the Department of 20 Veterans' Assistance. Any reference in this code to the Director 21 of the Division of Veterans Affairs means the Secretary of the 22 Department of Veterans' Assistance. As used in this chapter, 23 "secretary" means the Secretary of Veterans' Assistance and 24 "division" means Department of Veterans' Assistance.

- 1 (b) The department may receive federal funds.
- 2 (c) The secretary serves at the will and pleasure of the
- 3 Governor. The annual compensation of the secretary shall be as
- 4 specified in §6-7-2a of this code.

## 5 §9A-1-1b. Powers and duties of the secretary.

- 6 (a) The secretary controls and supervises the department and 7 is responsible for the work of each department employee.
- 8 (b) The secretary has the power and authority specified in 9 this article, in article two, chapter five-f of this code and as 10 otherwise specified in this chapter.
- 11 (c) The secretary may employ staff, assistants and employees 12 as necessary for the efficient operation of the department.
- 13 (d) The secretary may delegate his or her powers and duties to 14 assistants and employees, but the secretary is responsible for all 15 official acts of the department.

## 16 §9A-1-1c. Reports by secretary.

- The secretary shall report annually to the Governor concerning 18 the conduct of the department and make other reports as the 19 Governor may require.
- 20 §9A-1-1d. Right of appeal from interference with functioning of
- 21 agency.
- 22 Any governmental entity may appeal to the Governor for review 23 upon a showing that application of the secretary's authority may 24 interfere with the successful functioning of that entity. The

1 Governor's decision controls on appeal.

## 2 §9A-1-2. Veterans' Council; administration of department.

3 There is continued the "Veterans' Council" consisting of nine 4 members who must be citizens and residents of this state and who 5 have served in and been honorably discharged or separated under 6 honorable conditions from the Armed Forces of the United States and 7 whose service was within a time of war as defined by the laws of 8 the United States, either Public Law No. 2 -- 73rd Congress, or 9 Public Law No. 346 -- 78th Congress, and amendments thereto. 10 Where feasible, at least one member of the council must shall be a 11 veteran of World War II, at least one member of the council must 12 shall be a veteran of the Korean Conflict, at least two members of 13 the council must shall be veterans of the Vietnam era, at least one 14 member must shall be a veteran of the first Gulf War and at least 15 one member must shall be a veteran of the Afghanistan or Iraqi 16 Conflicts. The members of the veterans' council must shall be 17 selected with special reference to their ability and fitness to 18 effectuate the purposes of this article. If an eligible veteran is 19 not available or cannot be selected, members may be selected from 20 those veterans who served during a peacetime period provided all 21 other conditions are met.

A director secretary and such veterans' affairs officers,
assistants and employees as may be deemed the secretary considers
advisable, shall administer the West Virginia division of veterans'

- 1 affairs Department of Veteran's Assistance.
- 2 §9A-1-4. Duties and functions of Veterans' Council; appointment of
- 3 secretary; honoring academic achievement at military
- 4 academies.
- (a) It is the duty and function of the Veterans' Council to 5 6 advise the director secretary on the general administrative 7 policies of the division department, to select, at their first 8 meeting in each fiscal year commencing on July 1, a chairman 9 chairperson to serve one year, to advise the director secretary on 10 rules as may be necessary, to advise the Governor and the 11 Legislature with respect to legislation affecting the interests of 12 veterans, their widows, dependents and orphans and to make annual 13 reports to the Governor respecting the service of the division 14 department. The director secretary has the same eligibility and 15 qualifications prescribed for members of the Veterans' Council. 16 The Governor shall appoint a director for a term of six years, by 17 and with the advice and consent of the Senate. Before making the 18 appointment the Governor shall request the council of the West 19 Virginia division of veterans' affairs to furnish a full and 20 complete report concerning the qualifications and suitability of 21 the proposed appointee. The director may only be removed by the 22 Governor for cause, but shall have upon his or her own request an 23 open hearing before the Governor on the complaints or charges 24 lodged against him or her. The action of the Governor shall be

- 1 final. The director secretary ex officio shall be the executive
- 2 secretary of the Veterans' Council, keep the minutes of each
- 3 meeting and be in charge of maintain all records of the division
- 4 veterans' council.
- 5 (b) The Veterans' Council may annually honor each West
- 6 Virginian graduating from the U.S. Military Academy, the U.S. Naval
- 7 Academy, the U.S. Air Force Academy and the U.S. Coast Guard
- 8 Academy with the highest grade point average by bestowing upon him
- 9 or her the "West Augusta Award." The award shall be in a design
- 10 and form established by the council and include the famous
- 11 Revolutionary War phrase from which the award's name is derived:
- 12 "Once again our brethren from West Augusta have answered the call
- 13 to duty." The council shall coordinate the manner of recognition
- 14 of the recipient at graduation ceremonies with each academy.
