9 AN ACT making a supplementary appropriation of federal funds from
10 the balance of moneys remaining unappropriated for the fiscal
11 year ending June 30, 2011, to a new item of appropriation
12 designated to the Governor's Office, fund 8742, fiscal year
13 2011, organization 0100, to the Department of Education and
14 the Arts - State Board of Rehabilitation - Division of
15 Rehabilitation Services, fund 8734, fiscal year 2011,
16 organization 0932, to the Department of Health and Human
17 Resources - West Virginia Health Care Authority, fund 8851,
18 fiscal year 2011, organization 0507, to the Department of
19 Health and Human Resources - Division of Human Services, fund
20 8722, fiscal year 2011, organization 0511, and to the
21 Department of Transportation - Public Port Authority, fund
22 8830, fiscal year 2011, organization 0806, by supplementing
23 and amending Chapter 8, Acts of the Legislature, Regular
24 Session, 2010, known as the Budget Bill.

1 WHEREAS, The Governor has established the availability of
2 federal funds now available for expenditure in the fiscal year
