A BILL finding and declaring certain claims against the state and its agencies to be moral obligations of the state; and directing the Auditor to issue warrants for the payment thereof.

Be it enacted by the Legislature of West Virginia:

CLAIMS AGAINST THE STATE.

§1. Finding and declaring certain claims against the Attorney General; Department of Environmental Protection; Department of Health and Human Resources;

Department of Health and Human Resources/ Bureau for Public Health; Division of Corrections; Division of Highways; Educational Broadcasting Authority; Public Service Commission; Regional Jail and Correctional Facility Authority and the State Tax Department to be moral obligations of the state and directing payment thereof.

1 The Legislature has considered the findings of fact and
2 recommendations reported to it by the Court of Claims
3 concerning various claims against the state and agencies
4 thereof and in respect to each of the following claims, the
5 Legislature adopts those findings of fact as its own and in
6 respect of certain claims herein, the Legislature has

8 award and hereby declares it to be the moral obligation of the

10 and directs the Auditor to issue warrants for the payment
11 thereof out of any fund appropriated and available for the
