

AN ACT to amend and reenact §4-10-8 of the Code of West Virginia, 1931, as amended; to amend and reenact §5F-1-2 of said code; to amend and reenact §5F-2-1 of said code; to amend and reenact §6-7-2a of said code; to amend and reenact §9A-1-1, §9A-1-2 and §9A-1-4 of said code; and to amend said code by adding thereto four new sections, designated §9A-1-1a, §9A-1-1b, §9A-1-1c and §9A-1-1d, all relating to redesignating the Division of Veterans' Affairs as the Department of Veterans' Assistance within the executive branch: establishing the time period for review of the Department of Veterans' Assistance by the Joint Standing Committee on Government Organization and the Joint Committee on Government Operations; providing that the Veterans' Council be part of the Department of Veterans' Assistance; providing that the department be supervised by a secretary-level administrator; establishing the salary of the secretary; providing an effective date for redesignation; clarifying the purpose of the Department of Veterans' Assistance; making other changes to the code to comport with the amendment; and providing technical and clerical cleanup.

Be it enacted by the Legislature of West Virginia:

That §4-10-8 of the Code of West Virginia, 1931, as amended, be amended and reenacted; that §5F-1-2 of said code be amended and reenacted; that §5F-2-1 of said code be amended and reenacted; that §6-7-2a of said code be amended and reenacted; that §9A-1-1, §9A-1-2 and §9A-1-4 of said code be amended and reenacted; and that said code be amended by adding thereto four new sections, designated §9A-1-1a, §9A-1-1b, §9A-1-1c and §9A-1-1d, all to read as follows:

#### CHAPTER 4. THE LEGISLATURE.

#### ARTICLE 10. PERFORMANCE REVIEW ACT.

#### §4-10-8. Schedule of departments for agency review.

- 1 (a) Each department shall make a presentation pursuant to
- 2 the provisions of this article, to the Joint Standing Commit-
- 3 tee and the committee during the first interim meeting after
- 4 the regular session of the year in which the department is to
- 5 be reviewed pursuant to the schedule set forth in subsection
- 6 (b) of this section.
- 7 (b) An agency review shall be performed on one or more
- 8 agencies under the purview of each department at least once
- 9 every six years, commencing as follows:
- 10 (1) 2008, the Department of Administration;
- 11 (2) 2009, the Department of Education and the Arts, and
- 12 the Department of Education, including the Higher Educa-
- 13 tion Policy Commission and the West Virginia Council for
- 14 Community and Technical College Education;
- 15 (3) 2010, the Department of Revenue and the Department
- 16 of Commerce;
- 17 (4) 2011, the Department of Environmental Protection and
- 18 the Department of Military Affairs and Public Safety;
- 19 (5) 2012, the Department of Health and Human Resources,
- 20 including the Bureau of Senior Services:

- 21 (6) 2013, the Department of Transportation; and
- 22 (7) 2016, the Department of Veterans' Assistance.

- 16 Governor.

- 222 (m) Except for powers, authority and duties that have been 223 delegated to the secretaries of the departments by the 224 provisions of section two of this article, the existence, 225 powers, authority and duties of boards and the membership, 226 terms and qualifications of members of the boards are not 227 affected by the enactment of this chapter. All boards that are 228 appellate bodies or are independent decision makers shall 229 not have their appellate or independent decision-making 230 status affected by the enactment of this chapter.
- 231 (n) Any department previously transferred to and incorpo-232 rated in a department by prior enactment of this section 233 means a division of the appropriate department. Wherever 234 reference is made to any department transferred to and 235 incorporated in a department created in section two, article 236 one of this chapter, the reference means a division of the 237 appropriate department and any reference to a division of a 238 department so transferred and incorporated means a section 239 of the appropriate division of the department.
- 240 (o) When an agency, board or commission is transferred 241 under a bureau or agency other than a department headed by 242 a secretary pursuant to this section, that transfer is solely for 243 purposes of administrative support and liaison with the 244 Office of the Governor, a department secretary or a bureau. 245 Nothing in this section extends the powers of department 246 secretaries under section two of this article to any person 247 other than a department secretary and nothing limits or 248 abridges the statutory powers and duties of statutory 249 commissioners or officers pursuant to this code.

# CHAPTER 6. GENERAL PROVISIONS RESPECTING OFFICERS.

#### ARTICLE 7. COMPENSATION AND ALLOWANCES.

- §6-7-2a. Terms of certain appointive state officers; appointment; qualifications; powers and salaries of such officers.
  - 1 (a) Each of the following appointive state officers named in
  - 2 this subsection shall be appointed by the Governor, by and
  - 3 with the advice and consent of the Senate. Each of the

- 4 appointive state officers serves at the will and pleasure of the
- 5 Governor for the term for which the Governor was elected
- 6 and until the respective state officers' successors have been
- 7 appointed and qualified. Each of the appointive state officers
- 8 are subject to the existing qualifications for holding each
- 9 respective office and each has and is hereby granted all of
- 10 the powers and authority and shall perform all of the
- 11 functions and services heretofore vested in and performed by
- 12 virtue of existing law respecting each office.
- 13 The annual salary of each named appointive state officer
- 14 is as follows:
- 15 Commissioner, Division of Highways,\$92,500; Commis-
- 16 sioner, Division of Corrections, \$80,000; Director, Division of
- 17 Natural Resources, \$75,000; Superintendent, State Police.
- 18 \$85,000; Commissioner, Division of Banking,\$75,000;
- 19 Commissioner, Division of Culture and History, \$65,000;
- 20 Commissioner, Alcohol Beverage Control Commission,
- 21 \$75,000; Commissioner, Division of Motor Vehicles, \$75,000;
- 22 Chairman, Health Care Authority, \$80,000; members, Health
- 23 Care Authority, \$70,000; Director, Human Rights Commis-
- 24 sion, \$55,000; Commissioner, Division of Labor, \$70,000;
- 25 Chairperson, Board of Parole, \$55,000; members, Board of
- 26 Parole, \$50,000; members, Employment Security Review
- 27 Board,\$17,000; and Commissioner, Workforce West Virginia,
- Doura, Fry Continue Commissioner, Worklorde West Virginia,
- 28 \$75,000. Secretaries of the departments shall be paid an
- 29 annual salary as follows: Health and Human Re-
- 30 sources,\$95,000; Transportation, \$95,000: Provided, That if
- 31 the same person is serving as both the Secretary of Transpor-
- 32 tation and the Commissioner of Highways, he or she shall be
- 33 paid \$120,000; Revenue, \$95,000; Military Affairs and Public
- 34 Safety, \$95,000; Administration, \$95,000; Education and the
- 35 Arts, \$95,000; Commerce,\$95,000; Veterans' Assistance,
- 36 \$95,000; and Environmental Protection,\$95,000; Provided,
- 37 however, That, any officer whose salary is increased by the
- 38 reenactment of this subsection during the regular session of
- 39 the Legislature in 2011 by more than \$5,000 shall be paid the
- 40 salary increase in increments of \$5,000 per fiscal year
- 41 beginning July 1, 2011, up to the maximum salary provided
- 42 in this subsection.

- 43 (b) Each of the state officers named in this subsection shall
- 44 continue to be appointed in the manner prescribed in this
- 45 code, and shall be paid an annual salary as follows:
- 46 Director, Board of Risk and Insurance Management,
- 47 \$80,000; Director, Division of Rehabilitation Services,
- 48 \$70,000; Director, Division of Personnel, \$70,000; Executive
- 49 Director, Educational Broadcasting Authority, \$75,000;

- 51 cal and Economic Survey, \$75,000; Executive Director,

- 63 (c) Each of the following appointive state officers named in
- 64 this subsection shall be appointed by the Governor, by and
- 65 with the advice and consent of the Senate. Each of the
- 66 appointive state officers serves at the will and pleasure of the
- 67 Governor for the term for which the Governor was elected
- and until the respective state officers' successors have been
- 69 appointed and qualified. Each of the appointive state officers
- 70 are subject to the existing qualifications for holding each
- 71 respective office and each has and is hereby granted all of
- 72 the powers and authority and shall perform all of the
- 73 functions and services heretofore vested in and performed by
- 74 virtue of existing law respecting each office.
- 75 The annual salary of each named appointive state officer
- 76 shall be as follows:
- 77 Commissioner, State Tax Division, \$92,500; Insurance
- 78 Commissioner, \$92,500; Director, Lottery Commission,
- 79 \$92,500; Director, Division of Homeland Security and

- 80 Emergency Management, \$65,000; and Adjutant General,
- 81 \$92,500.
- 82 (d) No increase in the salary of any appointive state officer
- 83 pursuant to this section may be paid until and unless the
- 84 appointive state officer has first filed with the State Auditor
- 85 and the Legislative Auditor a sworn statement, on a form to
- 86 be prescribed by the Attorney General, certifying that his or
- 87 her spending unit is in compliance with any general law
- 88 providing for a salary increase for his or her employees. The
- 89 Attorney General shall prepare and distribute the form to
- 90 the affected spending units.

#### CHAPTER 9A. VETERANS' AFFAIRS.

#### ARTICLE 1. DEPARTMENT OF VETERANS' ASSISTANCE.

#### §9A-1-1. Creation and general purposes.

- 1 (a) Effective July 1, 2011, the West Virginia Division of
- 2 Veterans' Affairs is redesignated the Department of Veter-
- 3 ans' Assistance.
- 4 (b) The purpose of the department is to aid, assist, counsel
- 5 and advise, and to encourage competition among counties
- 6 and municipalities to develop, improve and enhance veteran-
- 7 friendly services, benefits and assistance to, veterans who
- 8 have served in and been honorably discharged or separated
- 9 under honorable conditions from the Armed Forces of the
- 10 United States and their widows, widowers and dependents,
- 11 including populations of veterans who may have special
- 12 needs as a result of homelessness, incarceration or physical
- 13 or mental disabilities.
- 14 (c) All references in this code to the West Virginia Division
- 15 of Veterans' Affairs and the Director of the West Virginia
- 16 Division of Veterans' Affairs shall mean the Department of
- 17 Veterans' Assistance and the Secretary of the Department of
- 18 Veterans' Assistance, respectively.

# §9A-1-1a. Department of Veterans' Assistance; office of Secretary of Department of Veterans' Assistance.

- 1 (a) The Secretary of the Department of Veterans' Assis-
- 2 tance is the chief executive officer of the department.
- 3 Subject to the requirements for the qualification and
- 4 appointment of the secretary provided in section four of this
- 5 article, the Governor shall appoint the secretary, by and with
- 6 the advice and consent of the Senate, for the term for which
- 7 the Governor is elected and until a successor shall have been
- 8 appointed and qualified. The Secretary shall serve at the will
- 9 and pleasure of the Governor. Any reference in this code to
- 10 the Division of Veterans' Affairs or to the Department of
- 11 Veterans' Affairs means the Department of Veterans'
- 12 Assistance. Any reference in this code to the Director of the
- 13 Division of Veterans' Affairs means the Secretary of the
- 14 Department of Veterans' Assistance. As used in this chapter,
- 15 "secretary" means the Secretary of Veterans' Assistance and
- 16 "division" means Department of Veterans' Assistance.
- 17 (b) The department may receive federal funds.
- 18 (c) The secretary serves at the will and pleasure of the
- 19 Governor. The annual compensation of the secretary shall be
- 20 as specified in section two-a, article seven, chapter six of this
- 21 code.

#### §9A-1-1b. Powers and duties of the secretary.

- 1 (a) The secretary controls and supervises the department
- 2 and is responsible for the work of each department employee.
- 3 (b) The secretary has the power and authority specified in
- 4 this article, in article two, chapter five-f of this code and as
- 5 otherwise specified in this chapter.
- 6 (c) The secretary may employ staff, assistants and employ-
- 7 ees as necessary for the efficient operation of the department.
- 8 (d) The secretary may delegate his or her powers and duties
- 9 to assistants and employees, but the secretary is responsible
- 10 for all official acts of the department.

#### §9A-1-1c. Reports by secretary.

- 1 The secretary shall report annually to the Governor
- 2 concerning the conduct of the department and make other
- 3 reports as the Governor may require.

# §9A-1-1d. Right of appeal from interference with functioning of agency.

- 1 Any governmental entity may appeal to the Governor for
- 2 review upon a showing that application of the secretary's
- 3 authority may interfere with the successful functioning of
- 4 that entity. The Governor's decision controls on appeal.

#### §9A-1-2. Veterans' Council; administration of department.

- There is continued the "Veterans' Council" consisting of
- 2 nine members who must be citizens and residents of this
- 3 state and who have served in and been honorably discharged
- 4 or separated under honorable conditions from the Armed
- 5 Forces of the United States and whose service was within a
- 6 time of war as defined by the laws of the United States,
- 7 either Public Law No. 2 73rd Congress, or Public Law No.
- 8 346 78th Congress, and amendments thereto. Where
- 9 feasible, two members of the council shall be veterans of
- 10 either World War II or the Korean Conflict, at least two
- 11 members of the council shall be veterans of the Vietnam era.
- 11 members of the council shall be veterans of the vietnam era
- 12 at least one member shall be a veteran of the first Gulf War
- 13 and at least one member shall be a veteran of the Afghani-
- 14 stan or Iraqi Conflicts. The members of the veterans' council
- 15 shall be selected with special reference to their ability and
- 16 fitness to effectuate the purposes of this article. If an eligible
- 17 veteran is not available or cannot be selected, a veteran who
- 18 is a citizen and resident of this state, who served in and was
- 19 honorably discharged or separated under honorable condi-
- 20 tions from the Armed Forces of the United States and who
- 21 served during any time of war or peace may be selected.
- 22 A secretary and such veterans' affairs officers, assistants
- 23 and employees as the secretary considers advisable, shall
- 24 administer the West Virginia Department of Veterans'
- 25 Assistance.

# §9A-1-4. Duties and functions of Veterans' Council; appointment of secretary; honoring academic achievement at military academies.

- 1 (a) It is the duty and function of the Veterans' Council to
- 2 advise the secretary on the general administrative policies of

- 3 the department, to select, at their first meeting in each fiscal
- 4 year commencing on July 1, a chairperson to serve one year,
- 5 to advise the secretary on rules as may be necessary, to
- 6 advise the Governor and the Legislature with respect to
- 7 legislation affecting the interests of veterans, their widows,
- 8 dependents and orphans and to make annual reports to the
- 9 Governor respecting the service of the department. The
- 10 secretary has the same eligibility and qualifications pre-
- 11 scribed for members of the Veterans' Council. The secretary
- 12 ex officio shall maintain all records of the Veterans' Council.
- 13 (b) The Veterans' Council may annually honor each West
- 14 Virginian graduating from the U.S. Military Academy, the
- 15 U.S. Naval Academy, the U.S. Air Force Academy and the
- 16 U.S. Coast Guard Academy with the highest grade point
- 17 average by bestowing upon him or her the "West Augusta
- 18 Award." The award shall be in a design and form established
- 19 by the council and include the famous Revolutionary War
- 20 phrase from which the award's name is derived: "Once again
- 21 our brethren from West Augusta have answered the call to
- 22 duty." The council shall coordinate the manner of recogni-
- 23 tion of the recipient at graduation ceremonies with each
- 24 academy.
