AN ACT making a supplementary appropriation from the balance of moneys remaining unappropriated for the fiscal year ending June 30, 2011, to the Department of Military Affairs and Public Safety - West Virginia Division of Corrections - Parolee Supervision Fees, fund 6362, fiscal year 2011, organization 0608, to the Department of Military Affairs and Public Safety - West Virginia State Police - Motor Vehicle Inspection Fund, fund 6501, fiscal year 2011, organization 0612, to the Department of Revenue - Office of the Secretary - State Debt Reduction Fund, fund 7007, fiscal year 2011, organization 0701, and to the Department of Transportation - Public Port Authority - Special Railroad and Intermodal Enhancement Fund, fund 8254, fiscal year 2011, organization 0806, by supplementing and amending the appropriation for the fiscal year ending June 30, 2011.

WHEREAS, The Governor has established that there now remains an unappropriated balance in the Department of Military Affairs and Public Safety - West Virginia Division of Corrections - Parolee Supervision Fees, fund 6362, fiscal year 2011, organization 0608, in the Department of Military Affairs and Public Safety - West Virginia State Police - Motor Vehicle Inspection Fund, fund

6501, fiscal year 2011, organization 0612, in the Department of Revenue - Office of the Secretary - State Debt Reduction Fund, fund 7007, fiscal year 2011, organization 0701, and in the Department of Transportation - Public Port Authority - Special Railroad and Intermodal Enhancement Fund, fund 8254, fiscal year 2011, organization 0806, available for expenditure during the fiscal year ending June 30, 2011 which is hereby appropriated by the terms of this supplementary appropriation bill; therefore






