9 AN ACT expiring funds to the unappropriated surplus balance in the
10 State Fund, General Revenue, for the fiscal year ending June
11 30, 2012, in the amount of \$10,000,000 from the Governor's
12 Office - Civil Contingent Fund, fund 0105, fiscal year 2009,
13 organization 0100, activity 236, and making a supplementary
14 appropriation of public moneys out of the Treasury from the
15 balance of moneys remaining as an unappropriated surplus
16 balance in the State Fund, General Revenue, to the Governor's
17 Office - Civil Contingent Fund, fund 0105, fiscal year 2012,
18 organization 0100, by supplementing and amending the
19 appropriations for the fiscal year ending June 30, 2012.

20 WHEREAS, The Governor finds that the account balance in the
21 Governor's Office - Civil Contingent Fund, fund 0105, fiscal year
22 2009, organization 0100, activity 236, exceeds that which is
23 necessary for the purpose for which the account was established;
24 and

1 WHEREAS, The Governor submitted to the Legislature the
2 Executive Budget Documents on January 11, 2012, which included a
3 Statement of the State Fund, General Revenue, setting forth therein
4 the cash balance as of July 1, 2011, and further included the
5 estimate of revenues for the fiscal year 2012, less net
6 appropriation balances forwarded and regular appropriations for the
7 fiscal year 2012; and

8 WHEREAS, It appears from the Executive Budget Document
9 Statement of the State Fund, General Revenue, and this legislation
10 there now remains an unappropriated surplus balance in the State
11 Treasury which is available for appropriation during the fiscal
12 year ending June 30, 2012; therefore

13 *Be it enacted by the Legislature of West Virginia:*

14 That the balance of the funds available for expenditure in the
15 fiscal year ending June 30, 2012, in the Governor's Office - Civil
16 Contingent Fund, fund 0105, fiscal year 2009, organization 0100,
17 activity 236, be decreased by expiring the amount of \$10,000,000,
18 to the unappropriated surplus balance of the State Fund, General
19 Revenue, to be available for appropriation during the fiscal year
20 ending June 30, 2012.

21 And, That the total appropriation for the fiscal year ending
22 June 30, 2012, to fund 0105, fiscal year 2012, organization 0100,
23 be supplemented and amended by adding a new item of appropriation
24 as follows:

17 of fiscal year 2012 is hereby reappropriated for expenditure during
18 the fiscal year 2013.

20 expire, supplement, amend and add an item of appropriation in the
21 aforesaid account for the designated spending unit for expenditure
22 during the fiscal year 2012.
