- (a) The Water Development Authority shall create and establish a special revolving fund of moneys made available by appropriation, grant, contribution or loan to be known as the "West Virginia Infrastructure Fund for Broadband Middle Mile Development". This fund shall be governed, administered and accounted for by the Water Development Authority as a special purpose account separate and distinct from any other moneys, funds or funds owned and managed by the authority for broadband middle mile development. The Infrastructure Fund for Broadband Middle Mile Development shall consist of subaccounts, as deemed necessary by the authority, for
- 16 <u>(1) Infrastructure revenues for broadband middle mile</u>
 17 deployment;

- (2) Any appropriations, grants, gifts, contributions, loan

- 15 application and on whether the application should be approved or
- 16 denied. The public may submit written comments to the committee
- 17 <u>either prior to the hearing, during the hearing, or within thirty</u>
- 18 days after the day of the hearing.
- 19 (f) Anytime after the thirty day public comment period
- 20 expires, the advisor committee may submit its recommendation to the
- 21 Infrastructure and Jobs Development who shall make the final
- 22 decision on whether to approve or reject an application.
- 23 (g) The Infrastructure and Jobs Development council shall
- 24 promulgate legislative rules in accordance with article three,
- 25 chapter twenty-nine-a of this code, it deems necessary to implement

1 §31-15A-10a. Recommendations for expenditures of funds by loan, 2 grant or for engineering assistance.

- 6 (h) In the event that the sum of all reserves pledged to the
- 7 payment of the bonds is less than the minimum reserve requirements

- 23 §31-15A-22a. Refunding broadband middle mile revenue bonds.

Τ	outstanding may at any time and from time to time be refunded by
2	the Water Development Authority by the issuance of its refunding
3	revenue bonds in an amount it deems necessary to refund the
4	principal of the bonds to be refunded, together with any unpaid
5	interest thereon, to provide additional funds for the Water
6	Development Authority to, in its discretion, issue additional
7	revenue bonds, and to pay any premiums and commissions necessary to
8	be paid in connection therewith. Any refunding may be effected
9	whether the broadband middle mile infrastructure revenue bonds to
10	be refunded shall have then matured or shall thereafter mature:
11	Provided, That the holders of any broadband middle mile
12	infrastructure revenue bonds so to be refunded shall not be
13	compelled without their consent to surrender their broadband middle
14	mile infrastructure revenue bonds for payment or exchange prior to
15	the date on which they are payable or, if they are called for
16	redemption, prior to the date on which they are by their terms
17	subject to redemption. Any refunding revenue bonds issued pursuant
18	to this article shall be payable from the West Virginia Broadband
19	Middle Mile Infrastructure Revenue Debt Service Fund, and shall be
20	subject to the provisions contained in section seventeen-c of this
21	article, and shall be secured in accordance with the provisions of
22	sections seventeen-c and eighteen-a of this article.
23	§31-15A-23a. Broadband middle mile infrastructure revenue bonds
24	not debt of state, county, municipality or any

political subdivision.

1 Broadband middle mile infrastructure revenue bonds issued pursuant to the provisions of this article shall not constitute a 3 debt or a pledge of the faith and credit or taxing power of this 4 state or of any county, municipality or any other political 5 subdivision of this state. The holders or owners thereof shall have 6 no right to have taxes levied by the Legislature or the taxing 7 authority of any county, municipality or any other political 8 subdivision of this state for the payment of the principal thereof or interest thereon. The broadband middle mile revenue bonds shall 10 be payable solely from the revenues and funds pledged for their 11 payment as authorized by this article. All such bonds shall contain 12 on the face thereof a statement to the effect that the bonds, as to 13 both principal and interest, are not debts of the state or any 14 county, municipality or political subdivision thereof, but are 15 payable solely from revenues and funds pledged for their payment. 16 §31-15A-24a. Broadband middle mile infrastructure revenue bonds 17 exempt from taxation. 18 The exercise of the powers granted to the Water Development Authority by this article will be in all respects for the benefit 20 of the people of the state, for the improvement of their health, 21 safety, convenience and welfare and for the enhancement of their 22 residential, agricultural, recreational, economic, commercial and 23 industrial opportunities and is for a public purpose. As the 24 construction, acquisition, repair or renovation of broadband middle 25 mile infrastructure projects will constitute the performance of 26 essential governmental functions, the Water Development Authority

- 1 shall not be required to pay any taxes or assessments upon any
- 2 project or upon any property acquired or used by the Water
- 3 Development Authority or upon the income therefrom. The broadband
- 4 middle mile infrastructure revenue bonds and all interest and
- 5 income thereon shall be exempt from all taxation by this state, or
- 6 any county, municipality, political subdivision or agency thereof,
- 7 except estate taxes.
