10 A BILL supplementing, amending, decreasing and increasing items of  
11 the existing appropriations from the State Road Fund to the  
12 Department of Transportation - Division of Highways, fund  
13 9017, fiscal year 2012, organization 0803, for the fiscal year  
14 ending June 30, 2012.

15 WHEREAS, The Governor submitted to the Legislature the  
16 Executive Budget Document, dated January 11, 2012, which included  
17 a statement of the State Road Fund setting forth therein the cash  
18 balances and investments as of July 1, 2011, and further included  
19 the estimate of revenues for the fiscal year 2012, less net  
20 appropriation balances forwarded and regular appropriations for the  
21 fiscal year 2012; and

22 WHEREAS, It appears from the Statement of the State Road Fund  
23 there now remains an unappropriated balance in the State Treasury  
24 which is available for appropriation during the fiscal year ending  
25 June 30, 2012; therefore

26 *Be it enacted by the Legislature of West Virginia:*

27 That the items of the total appropriations from the State Road

3 amended by decreasing existing an item of appropriation as follows:
