13	A BILL to amend and reenact $\$17C-5-2$ of the Code of West Virginia,
14	1931, as amended, relating to making it a felony to drive a
15	vehicle while under the influence of alcohol, controlled
16	substance or other drug and recklessly cause serious bodily
17	injury to another person; and establishing penalties for first
18	and subsequent violations of certain provisions.
19	Be it enacted by the Legislature of West Virginia:
20	That §17C-5-2 of the Code of West Virginia, 1931, as amended,
21	be amended and reenacted to read as follows:
22	ARTICLE 5. SERIOUS TRAFFIC OFFENSES.
23	§17C-5-2. Driving under influence of alcohol, controlled
24	substances or drugs; penalties.
25	(a) Any person who:

- 1 (1) Drives a vehicle in this state while he or she:
- 2 (A) Is under the influence of alcohol;
- 3 (B) Is under the influence of any controlled substance;
- 4 (C) Is under the influence of any other drug;
- 5 (D) Is under the combined influence of alcohol and any 6 controlled substance or any other drug; or
- 7 (E) Has an alcohol concentration in his or her blood of eight 8 hundredths of one percent or more, by weight; and
- 9 (2) While driving does any act forbidden by law or fails to
 10 perform any duty imposed by law in the driving of the vehicle,
 11 which act or failure proximately causes the death of any person
 12 within one year next following the act or failure; and
- (3) Commits the act or failure in reckless disregard of the safety of others and when the influence of alcohol, controlled substances or drugs is shown to be a contributing cause to the death, is guilty of a felony and, upon conviction thereof, shall be imprisoned in a state correctional facility for not less than two years nor more than ten years and shall be fined not less than \$1,000 nor more than \$3,000.
- 20 (b) Any person who:
- 21 (1) Drives a vehicle in this state while he or she:
- 22 (A) Is under the influence of alcohol;
- 23 (B) Is under the influence of any controlled substance;
- 24 (C) Is under the influence of any other drug;
- 25 (D) Is under the combined influence of alcohol and any 26 controlled substance or any other drug; or

- 1 (E) Has an alcohol concentration in his or her blood of eight 2 hundredths of one percent or more, by weight; and
- 3 (2) While driving does any act forbidden by law or fails to 4 perform any duty imposed by law in the driving of the vehicle, 5 which act or failure proximately causes the death of any person 6 within one year next following the act or failure, is guilty of a 7 misdemeanor and, upon conviction thereof, shall be confined in jail 8 for not less than ninety days nor more than one year and shall be
- 10 (c) Any person who:
- 11 (1) Drives a vehicle in this state while he or she:
- 12 (A) Is under the influence of alcohol;

9 fined not less than \$500 nor more than \$1,000.

- 13 (B) Is under the influence of any controlled substance;
- 14 (C) Is under the influence of any other drug;
- 15 (D) Is under the combined influence of alcohol and any 16 controlled substance or any other drug; or
- 17 (E) Has an alcohol concentration in his or her blood of eight 18 hundredths of one percent or more, by weight; and
- 19 (2) While driving does any act forbidden by law or fails to 20 perform any duty imposed by law in the driving of the vehicle, 21 which act or failure proximately causes bodily injury to any person 22 other than himself or herself, is guilty of a misdemeanor and, upon 23 conviction thereof, shall be confined in jail for not less than one 24 day nor more than one year, which jail term is to include actual 25 confinement of not less than twenty-four hours, and shall be fined 26 not less than \$200 nor more than \$1,000.

- 1 (d) Any person who:
- 2 (1) Drives a vehicle in this state while he or she:
- 3 (A) Is under the influence of alcohol;
- 4 (B) Is under the influence of any controlled substance;
- 5 (C) Is under the influence of any other drug;
- 6 (D) Is under the combined influence of alcohol and any
- 7 controlled substance or any other drug; or
- 8 (E) Has an alcohol concentration in his or her blood of eight
- 9 hundredths of one percent or more, by weight; and
- 10 (2) While driving does any act forbidden by law or fails to
- 11 perform any duty imposed by law in the driving of the vehicle,
- 12 which act or failure proximately causes serious bodily injury to
- 13 any person other than himself or herself; and
- 14 (3) Commits the act or failure in reckless disregard of the
- 15 safety of others and when the influence of alcohol, controlled
- 16 substances or drugs is shown to be a contributing cause to the
- 17 serious bodily injury, is guilty of a felony and, upon conviction
- 18 thereof, shall be imprisoned in a state correctional facility for
- 19 not less than one nor more than three years and the court may, in
- 20 its discretion, impose a fine of not less than \$3,000 nor more than
- 21 \$5,000.
- 22 (4) For purposes of this subsection, "serious bodily injury"
- 23 means bodily injury which creates a substantial risk of death,
- 24 which causes serious or prolonged disfigurement, prolonged
- 25 impairment of health or prolonged loss or impairment of the
- 26 function of any bodily organ.

- 1 (5) A person violating this subsection, for the second or any
- 2 subsequent offense of this subsection, is guilty of a felony and,
- 3 upon conviction thereof, shall be imprisoned in a state
- 4 correctional facility for not less than three nor more than five
- 5 years and the court may, in its discretion, impose a fine of not
- 6 less than \$3,000 nor more than \$5,000.
- 7 $\frac{\text{(d)}}{\text{(e)}}$ Any person who:
- 8 (1) Drives a vehicle in this state while he or she:
- 9 (A) Is under the influence of alcohol;
- 10 (B) Is under the influence of any controlled substance;
- 11 (C) Is under the influence of any other drug;
- 12 (D) Is under the combined influence of alcohol and any
- 13 controlled substance or any other drug; or
- 14 (E) Has an alcohol concentration in his or her blood of eight
- 15 hundredths of one percent or more, by weight, but less than fifteen
- 16 hundredths of one percent, by weight;
- 17 (2) Is guilty of a misdemeanor and, upon conviction thereof,
- 18 except as provided in section two-b of this article, shall be
- 19 confined in jail for up to six months and shall be fined not less
- 20 than \$100 nor more than \$500. A person sentenced pursuant to this
- 21 subdivision shall receive credit for any period of actual
- 22 confinement he or she served upon arrest for the subject offense.
- 23 (e) (f) Any person who drives a vehicle in this state while he
- 24 or she has an alcohol concentration in his or her blood of fifteen
- 25 hundredths of one percent or more, by weight, is guilty of a
- 26 misdemeanor and, upon conviction thereof, shall be confined in jail

- 1 for not less than two days nor more than six months, which jail
- 2 term is to include actual confinement of not less than twenty-four
- 3 hours, and shall be fined not less than \$200 nor more than \$1,000.
- 4 A person sentenced pursuant to this subdivision shall receive
- 5 credit for any period of actual confinement he or she served upon
- 6 arrest for the subject offense.
- 7 (f) (g) Any person who, being an habitual user of narcotic
- 8 drugs or amphetamine or any derivative thereof, drives a vehicle in
- 9 this state is guilty of a misdemeanor and, upon conviction thereof,
- 10 shall be confined in jail for not less than one day nor more than
- 11 six months, which jail term is to include actual confinement of not
- 12 less than twenty-four hours, and shall be fined not less than \$100
- 13 nor more than \$500. A person sentenced pursuant to this subdivision
- 14 shall receive credit for any period of actual confinement he or she
- 15 served upon arrest for the subject offense.
- (h) Any person who:
- 17 (1) Knowingly permits his or her vehicle to be driven in this
- 18 state by any other person who:
- 19 (A) Is under the influence of alcohol;
- 20 (B) Is under the influence of any controlled substance;
- 21 (C) Is under the influence of any other drug;
- 22 (D) Is under the combined influence of alcohol and any
- 23 controlled substance or any other drug; or
- 24 (E) Has an alcohol concentration in his or her blood of eight
- 25 hundredths of one percent or more, by weight;
- 26 (2) Is guilty of a misdemeanor and, upon conviction thereof,

- 1 shall be confined in jail for not more than six months and shall be 2 fined not less than \$100 nor more than \$500.
- (h) (I) Any person who knowingly permits his or her vehicle to 4 be driven in this state by any other person who is an habitual user 5 of narcotic drugs or amphetamine or any derivative thereof is 6 guilty of a misdemeanor and, upon conviction thereof, shall be 7 confined in jail for not more than six months and shall be fined 8 not less than \$100 nor more than \$500.
- (I) (j) Any person under the age of twenty-one years who 10 drives a vehicle in this state while he or she has an alcohol 11 concentration in his or her blood of two hundredths of one percent 12 or more, by weight, but less than eight hundredths of one percent, 13 by weight, for a first offense under this subsection is quilty of 14 a misdemeanor and, upon conviction thereof, shall be fined not less 15 than \$25 nor more than \$100. For a second or subsequent offense 16 under this subsection, the person is guilty of a misdemeanor and, 17 upon conviction thereof, shall be confined in jail for twenty-four 18 hours and shall be fined not less than \$100 nor more than \$500. A 19 person who is charged with a first offense under the provisions of 20 this subsection may move for a continuance of the proceedings, from 21 time to time, to allow the person to participate in the Motor 22 Vehicle Alcohol Test and Lock Program as provided in section three-23 a, article five-a of this chapter. Upon successful completion of 24 the program, the court shall dismiss the charge against the person 25 and expunge the person's record as it relates to the alleged 26 offense. In the event the person fails to successfully complete

- 1 the program, the court shall proceed to an adjudication of the
- 2 alleged offense. A motion for a continuance under this subsection
- 3 may not be construed as an admission or be used as evidence. A
- 4 person arrested and charged with an offense under the provisions of
- 5 this subsection or subsection (a), (b), (c), (d), (e), (f), $(g)_L$
- 6 (h) or (h) (I) of this section may not also be charged with an
- 7 offense under this subsection arising out of the same transaction
- 8 or occurrence.
- 9 $\frac{(j)}{(k)}$ (k) Any person who:
- 10 (1) Drives a vehicle in this state while he or she:
- 11 (A) Is under the influence of alcohol;
- 12 (B) Is under the influence of any controlled substance;
- 13 (C) Is under the influence of any other drug;
- 14 (D) Is under the combined influence of alcohol and any
- 15 controlled substance or any other drug; or
- 16 (E) Has an alcohol concentration in his or her blood of eight
- 17 hundredths of one percent or more, by weight; and
- 18 (2) The person while driving has on or within the motor
- 19 vehicle one or more other persons who are unemancipated minors who
- 20 have not reached their sixteenth birthday is guilty of a
- 21 misdemeanor and, upon conviction thereof, shall be confined in jail
- 22 for not less than two days nor more than twelve months, which jail
- 23 term is to include actual confinement of not less than forty-eight
- 24 hours and shall be fined not less than \$200 nor more than \$1,000.
- 25 $\frac{(k)}{(l)}$ A person violating any provision of subsection (b),
- 26 (c), (d), (e), (f), (g), $\underline{\text{(h)}}$ or $\underline{\text{(h)}}$ of this section, for the

- 1 second offense under this section, is guilty of a misdemeanor and,
- 2 upon conviction thereof, shall be confined in jail for not less
- 3 than six months nor more than one year and the court may, in its
- 4 discretion, impose a fine of not less than \$1,000 nor more than
- 5 \$3,000.
- $\frac{\text{(1)}}{\text{(m)}}$ A person violating any provision of subsection (b),
- 7 (c), (d), (e), (f), (g), $\underline{\text{(h)}}$ or $\underline{\text{(h)}}$ (I) of this section, for the
- 8 third or any subsequent offense under this section, is guilty of a
- 9 felony and, upon conviction thereof, shall be imprisoned in a state
- 10 correctional facility for not less than one nor more than three
- 11 years and the court may, in its discretion, impose a fine of not
- 12 less than \$3,000 nor more than \$5,000.
- $\frac{\text{(m)}}{\text{(n)}}$ For purposes of subsections $\frac{\text{(k)}}{\text{(k)}}$ and $\frac{\text{(l)}}{\text{(l)}}$ and $\frac{\text{(m)}}{\text{(m)}}$ of
- 14 this section relating to second, third and subsequent offenses, the
- 15 following events shall be regarded as offenses under this section:
- 16 (1) Any conviction under the provisions of subsection (a),
- 17 (b), (c), (d), (e), (f), (g) or $\frac{(g)}{(g)}$ (h) of this section or under a
- 18 prior enactment of this section for an offense which occurred
- 19 within the ten-year period immediately preceding the date of arrest
- 20 in the current proceeding;
- 21 (2) Any conviction under a municipal ordinance of this state
- 22 or any other state or a statute of the United States or of any
- 23 other state of an offense which has the same elements as an offense
- 24 described in subsection (a), (b), (c), (d), (e), (f), (g), (h) or
- 25 (h) (I) of this section, which offense occurred within the ten-year
- 26 period immediately preceding the date of arrest in the current

- 1 proceeding; and,
- 2 (3) Any period of conditional probation imposed pursuant
- 3 section two-b of this article for violation of subsection (d) of
- 4 this article, which violation occurred within the ten-year period
- 5 immediately preceding the date of arrest in the current proceeding.
- 6 (n) (o) A person may be charged in a warrant or indictment or
- 7 information for a second or subsequent offense under this section
- 8 if the person has been previously arrested for or charged with a
- 9 violation of this section which is alleged to have occurred within
- 10 the applicable time period for prior offenses, notwithstanding the
- 11 fact that there has not been a final adjudication of the charges
- 12 for the alleged previous offense. In that case, the warrant or
- 13 indictment or information must set forth the date, location and
- 14 particulars of the previous offense or offenses. No person may be
- 15 convicted of a second or subsequent offense under this section
- 16 unless the conviction for the previous offense has become final, or
- 17 the person has previously had a period of conditional probation
- 18 imposed pursuant to section two-b of this article.
- 19 (o) (p) The fact that any person charged with a violation of
- 20 subsection (a), (b), (c), (d), (e), $\underline{(f)}$ or $\underline{(f)}$ (g) of this section,
- 21 or any person permitted to drive as described under subsection (g)
- 22 (h) or (h) (I) of this section, is or has been legally entitled to
- 23 use alcohol, a controlled substance or a drug does not constitute
- 24 a defense against any charge of violating subsection (a), (b), (c),
- 25 (d), (e), (f), (g), (h) or $\frac{(h)}{(I)}$ (I) of this section.
- 26 (p) (q) For purposes of this section, the term "controlled

1 substance" has the meaning ascribed to it in chapter sixty-a of 2 this code.

(q) (r) The sentences provided in this section upon conviction 4 for a violation of this article are mandatory and are not subject 5 to suspension or probation: Provided, That the court may apply the 6 provisions of article eleven-a, chapter sixty-two of this code to 7 a person sentenced or committed to a term of one year or less for 8 a first offense under this section: Provided, however, That the 9 court may impose a term of conditional probation pursuant to 10 section two-b of this article to persons adjudicated thereunder. 11 An order for home detention by the court pursuant to the provisions 12 of article eleven-b of said chapter may be used as an alternative 13 sentence to any period of incarceration required by this section 14 for a first or subsequent offense: Provided further, That for any 15 period of home incarceration ordered for a person convicted of 16 second offense under this section, electronic monitoring shall be 17 required for no fewer than five days of the total period of home 18 confinement ordered and the offender may not leave home for those 19 five days notwithstanding the provisions of section five, article 20 eleven-b, chapter sixty-two of this code: And provided further, 21 That for any period of home incarceration ordered for a person 22 convicted of a third or subsequent violation of this section, 23 electronic monitoring shall be included for no fewer than ten days 24 of the total period of home confinement ordered and the offender 25 may not leave home for those ten days notwithstanding section five, 26 article eleven-b, chapter sixty-two of this code.
