L 5	Be it enacted by the Legislature of West Virginia:
L 6	That \$18C-7-3 of the Code of West Virginia, 1931, as amended,
L 7	be amended and reenacted to read as follows:

21	§18C-7-3. Definitions.
22	(a) General For the purposes of this article, terms have
23	the meaning ascribed to them in section two, article one of this
24	chapter, unless the context in which the term is used clearly

- 3 (b) Definitions. --
- 4 (1) "Eligible institution" means:
- 5 (A) A state institution of higher education as defined in 6 section two, article one, chapter eighteen-b of this code;
- 7 (B) Alderson-Broaddus College, Appalachian Bible College,
- 8 Bethany College, Davis and Elkins College, Mountain State
- 9 University, Ohio Valley University, Salem International University,
- 10 the University of Charleston, West Virginia Wesleyan College and
- 11 Wheeling Jesuit University, all in West Virginia. Any institution
- 12 listed in this subdivision ceases to be an eligible institution if
- 13 it loses regional accreditation. meets either of the following
- 14 conditions:
- 15 (i) It loses regional accreditation; or
- 16 (ii) It changes its status as a private, not-for-profit
- 17 institution;
- 18 (C) Any other public or private regionally accredited
- 19 institution in this state approved by the commission.
- 20 (2) "Tuition" means the quarter, semester or term charges
- 21 imposed by an eligible state institution of higher education and,
- 22 additionally, all mandatory fees required as a condition of
- 23 enrollment by all students. For the purposes of this article, the
- 24 following conditions apply:
- 25 (A) West Virginia University, Potomac State College and West

- 1 Virginia University Institute of Technology are considered separate
- 2 institutions for purposes of determining tuition rates; and
- 3 (B) The tuition amount paid by undergraduate health sciences
- 4 students at West Virginia University is considered to be the same
- 5 as the amount of tuition paid by all other West Virginia University
- 6 undergraduate students.
- 7 (3) "Enrolled" means either currently enrolled or in the 8 process of enrolling in an eligible institution.

NOTE: The purpose of this bill is to include Salem International University as an eligible institution and modifies provisions regarding the higher education institutions that are eligible to continue to receive PROMISE scholarship funds.
