13	Be it enacted by the Legislature of West Virginia:
14	That $\$30-1-2a$ of the Code of West Virginia, 1931, as amended
15	be amended and reenacted to read as follows:
16	ARTICLE 1. GENERAL PROVISIONS APPLICABLE TO ALL STATE BOARDS OF
17	EXAMINATION OR REGISTRATION REFERRED TO IN CHAPTER.
18	§30-1-2a. Required orientation session.
19	(a) The Auditor shall provide at least one seminar each year
20	for state licensing boards to inform the boards of the duties and
21	requirements imposed by state law and rules. All state agencies
22	shall cooperate with and assist in providing the seminar if the
23	Auditor requests.
24	(b) The seminar may include the following topics:
25	(1) Powers and duties of the boards and board members;

- 1 (2) The financial procedures for boards;
- 2 (3) Purchasing requirements;
- 3 (4) Open meeting requirements;
- 4 (5) Ethics;
- 5 (6) Rule-making procedures;
- 6 (7) Procedures for the handling of complaints, investigations
- 7 and administrative hearings;
- 8 (8) Disciplinary actions available to boards;
- 9 (9) Records management procedures;
- 10 (10) Annual reports; and
- 11 (11) Any other topics the Auditor determines necessary or
- 12 informative.
- 13 (c) (1) The board members and the executive director or the
- 14 chief financial officer of a board newly created under the
- 15 provisions of this chapter shall attend a seminar provided under
- 16 this section within one year of the creation of the board.
- 17 (2) The chairperson, the executive director or the chief
- 18 financial officer of the board shall annually attend a seminar
- 19 provided under this section.
- 20 <u>(3) Each board member shall attend at least one seminar</u>

- 22 (d) The Auditor may charge a registration fee for the seminar

- 3 (e) Prior to January 1 of each year, the Auditor shall provide

- 6 (1) The names and titles of the persons who attended the

- 8 (2) The boards represented; and
- 9 (3) The number and dates of the seminars offered by the

- 11 (f) Ex officio members who are elected or appointed state
- 12 officers or employees and members of boards that have purely
- 13 advisory functions with respect to a department or agency of the
- 14 state are exempt from the requirements of this section.
