BOARD OF BARBERS AND COSMETOLOGISTS. 18 **§30-27-3**. **Definitions**. 19 As used in this article, the following words and terms have 20 the following meanings, unless the context clearly indicates 21 otherwise: (a) "Aesthetics" or "esthetics" means any one or 22 23 combination of the following acts when done on the human body for

- 1 compensation and not for the treatment of disease:
- 2 (1) Administering cosmetic treatments to enhance or improve
- 3 the appearance of the skin, including cleansing, toning, performing
- 4 effleurage or other related movements, stimulating, exfoliating or
- 5 performing any other similar procedure on the skin of the human
- 6 body or scalp;
- 7 (2) Applying, by hand or with a mechanical or electrical
- 8 apparatus, any cosmetics, makeups, oils, powders, clays,
- 9 antiseptics, tonics, lotions, creams or chemical preparations
- 10 necessary for the practice of aesthetics to another person's face,
- 11 neck, back, shoulders, hands, elbows and feet up to and including
- 12 the knee;
- 13 (3) The rubbing, cleansing, exercising, beautifying or
- 14 grooming of another person's face, neck, back, shoulders, hands,
- 15 elbows and feet up to and including the knee;
- 16 (4) The waxing, tweezing and threading of hair on another

- 21 (1) The bleaching or tinting of hair; and

- 5 (k) "Certificate holder" means a person certified as an 6 instructor to teach in a school under the provisions of this 7 article.
- 8 (1) "Cosmetologist" means a person licensed under the 9 provisions of this article who engages in the practice of 10 cosmetology.
- 11 (m) "Cosmetology" means any one or any combination of the 12 following acts when done on the human body for compensation and not 13 for the treatment of disease:
- (1) Cutting, styling, shaping, arranging, braiding, weaving, 15 dressing, adding extensions, curling, waving, permanent waving, 16 relaxing, straightening, shampooing, cleansing, singeing, 17 bleaching, tinting, coloring, waxing, tweezing, or similarly work 18 on human hair, or a wig or hairpiece, by any means, including 19 hands, mechanical or electrical devices or appliances;

- 21 (3) Applying by hand or with a mechanical or electrical device 22 or appliance, any cosmetics, makeups, oils, powders, clays, 23 antiseptics, tonics, lotions, creams or chemical preparations 24 necessary for the practice of aesthetics to another person's face,

- 1 neck, shoulders, hands, elbows and feet up to and including the 2 knee:
- 3 (4) The rubbing, cleansing, exercising, beautifying or
- 4 grooming of another person's face, neck, shoulders, hands, elbows
- 5 and feet up to and including the knee;
- 6 (5) The wrapping of another person's body in a body wrap; and
- 7 (6) Performing aesthetics.
- 8 (n) "General supervision" means:
- 9 (1) For schools, a master or certified instructor is on the
- 10 premises and is quickly and easily available; or
- 11 (2) For salons, a professional licensee is on the premises and
- 12 is quickly and easily available.
- 13 (o) "Hair braiding" means any one or any combination of the
- 14 following acts when done on the human body for compensation and not
- 15 for the treatment of disease: Braiding, plaiting, twisting,
- 16 wrapping, threading, weaving, extending or locking of natural human
- 17 hair by hand or mechanical device.
- 18 (p) "Hair Styling" means any one or any combination of the
- 19 following acts when done on the human body for compensation and not
- 20 for the treatment of disease:
- 21 (1) Cutting, styling, shaping, arranging, braiding, weaving,
- 22 dressing, adding extensions, curling, waving, permanent waving,
- 23 relaxing, straightening, shampooing, cleansing, singeing,
- 24 bleaching, tinting, coloring, waxing, tweezing, threading or

- 1 similarly work on human hair, or a wig or hairpiece, by any means,
- 2 including hands, mechanical or electrical devices or appliances;

- 6 (q) "Hair Stylist" means a person licensed under the

- 12 a license issued under the provisions of this article.

- 15 for the treatment of disease:
- 16 (1) The cleansing, dressing, or polishing of nails of a

- 18 (2) Performing artificial nail service; and
- 19 (3) The cosmetic treatment of the feet up to the knee and the
- 20 hands up to the elbow.

- 22 licensed under the provisions of this article who engages in the

- 1 (w) "Permitee" means a person holding a work permit.
- (v) (x) "Professional license" means a license to practice as
- 3 a aesthetician, barber, barber crossover, barber permanent wavist,
- 4 cosmetologist, cosmetologist crossover or nail technician.
- 5  $\frac{\text{(w)}}{\text{(y)}}$  "Registration" means a registration issued by the
- 6 board to a person who rents or leases a booth or chair from a
- 7 licensed salon owner and /or operator, or both, or a registration
- 8 issued by the board to a person who is a student in a school.
- 9  $\frac{(x)}{(z)}$  "Registrant" means a person who holds a registration
- 10 under the provisions of this article.
- 11 (y) (aa) "Salon" means a shop or other facility where a person
- 12 practices under a professional license.
- 13  $\frac{(z)}{(z)}$  (bb) "Salon license" means a license to own and operate a
- 14 salon.
- (cc) "School" means a facility to educate persons to be
- 16 licensed with professional licenses under the provisions of this
- 17 article.
- 18 (bb) (dd) "School license" means a license to own and operate
- 19 a school.
- 20 (cc) (ee) "Student registration" means a registration issued
- 21 by the board to a student to study at a school licensed under the

- 23 §30-27-8. Professional license requirements.
- 24 (a) An applicant for a professional license to practice as a

- 1 aesthetician, barber, barber crossover, barber permanent wavist,
- 2 cosmetologist, hair stylist, cosmetologist crossover or nail
- 3 technician shall present satisfactory evidence that he or she:
- 4 (1) Is at least eighteen years of age;
- 5 (2) Is of good moral character;
- 6 (3) Has a high school diploma, a GED, or has passed the
- 7 "ability to benefit test" approved by the United States Department
- 8 of Education;
- 9 (4) Has graduated from a school which has been approved by the 10 board:
- 11 (5) Has passed an examination that tests the applicant's
- 12 knowledge of subjects specified by the board: Provided, That the
- 13 board may recognize a certificate or similar license in lieu of the
- 14 examination or part of the examination that the board requires;
- 15 (6) Has paid the applicable fee;
- 16 (7) Presents a certificate of health from a licensed
- 17 physician;
- 18 (8) Is a citizen of the United States or is eligible for
- 19 employment in the United States; and
- 20 (9) Has fulfilled any other requirement specified by the
- 21 board.
- 22 (b) A license to practice issued by the board prior to July 1,
- 23 2009, shall for all purposes be considered a professional license
- 24 issued under this article: Provided, That a person holding a

- 1 license issued prior to July 1, 2009, must renew the license
- 2 pursuant to the provisions of this article.
