- 2 (c) "State board" means the West Virginia Board of Education;

- (i) "Social worker" means a nonteaching school employee who, 23 at a minimum, possesses an undergraduate degree in social work from 24 an accredited institution of higher learning and who provides

1 board of education who, under the supervision of the school 2 principal and in accordance with the rules of the county board, is 3 responsible for the planning, management, operation and evaluation 4 of the athletic program for the school or schools to which he or 5 she is assigned. The responsibilities of an athletic director may 6 include, but are not limited to: (1) Supervising of athletic games; 7 (2) overseeing the athletic budget; (3) hiring game officials; (4) 8 scheduling athletic contests; (5) knowing and upholding all county, 9 West Virginia Secondary Schools Activities Commission (WVSSAC) and 10 league rules; (6) maintaining proper records as required by West 11 Virginia Secondary Schools Activities Commission (WVSSAC) 12 participation; (7) scheduling transportation for athletic teams; 13 (8) preparing and verifying athletic eligibility lists; (9) 14 supervising coaches and, if appropriately certified, observing and 15 evaluating coaches; (10) securing all needed personnel for basic 16 athletic event operations; (11) procuring and caring for athletic 17 equipment; and (12) performing other duties involving athletics as 18 assigned by the principal or as a part of a county job description 19 for athletic directors.

NOTE: The purpose of this bill is to provide a definition for an athletic director who is employed by a county board of education and is responsible for the planning, management, operation and evaluation of the athletic program for the school or schools to which he or she is assigned.
