- 16 §49-1-3. Definitions relating to abuse and neglect.
- 17 (1) "Abused child" means a child whose health or welfare is
- 18 harmed or threatened by:
- 19 (A) A parent, guardian or custodian who knowingly or
- 20 intentionally inflicts, attempts to inflict or knowingly allows
- 21 another person to inflict, physical injury or mental or emotional
- 22 injury, upon the child or another child in the home; or
- 23 (B) Sexual abuse or sexual exploitation; or
- 24 (C) The sale or attempted sale of a child by a parent,

- 1 quardian or custodian in violation of section sixteen, article
- 2 four, chapter forty-eight of this code; or
- 3 (D) Domestic violence as defined in section two hundred two,
- 4 article twenty-seven, chapter forty-eight of this code.
- 5 In addition to its broader meaning, physical injury may

- 8 (2) "Abusing parent" means a parent, guardian or other

- 12 (3) "Battered parent" means a parent, guardian or other
- 13 custodian who has been judicially determined not to have condoned
- 14 the abuse or neglect and has not been able to stop the abuse or
- 15 neglect of the child or children due to being the victim of
- 16 domestic violence as defined by section two hundred two, article
- 17 twenty-seven, chapter forty-eight of this code, which domestic
- 18 violence was perpetrated by the person or persons determined to
- 19 have abused or neglected the child or children.
- 20 (4) "Child abuse and neglect" or "child abuse or neglect"
- 21 means physical injury, mental or emotional injury, sexual abuse,
- 22 sexual exploitation, sale or attempted sale or negligent treatment
- 23 or maltreatment of a child by a parent, guardian or custodian who
- 24 is responsible for the child's welfare, under circumstances which

- 1 harm or threaten the health and welfare of the child.
- 2 (5) "Child abuse and neglect services" means social services
- 3 which are directed toward:
- 4 (A) Protecting and promoting the welfare of children who are
- 5 abused or neglected;
- 6 (B) Identifying, preventing and remedying conditions which
- 7 cause child abuse and neglect;
- 8 (C) Preventing the unnecessary removal of children from their
- 9 families by identifying family problems and assisting families in
- 10 resolving problems which could lead to a removal of children and a
- 11 breakup of the family;
- 12 (D) In cases where children have been removed from their
- 13 families, providing services to the children and the families so as
- 14 to reunify such children with their families or some portion

- (B) Multidisciplinary team (MDT): A multidisciplinary team for 6 response to child abuse allegations includes representation from 7 the following: Law enforcement; child protective services; 8 prosecution; mental health; medical; victim advocacy;
- 10 (C) Organizational capacity: A designated legal entity 11 responsible for program and fiscal operations has been established 12 and implements basic sound administrative practices.

- (D) Cultural competency and diversity: The CAC promotes 14 policies, practices and procedures that are culturally competent. 15 Cultural competency is defined as the capacity to function in more 16 than one culture, requiring the ability to appreciate, understand 17 and interact with members of diverse populations within the local 18 community.
- (E) Forensic interviews: Forensic interviews are conducted in 19 20 a manner which is of a neutral, fact finding nature and coordinated 21 to avoid duplicative interviewing.
- (F) Medical evaluation: Specialized medical evaluation and 22 23 treatment are to be made available to CAC clients as part of the 24 team response, either at the CAC or through coordination and

- 1 referral with other specialized medical providers.
- 2 (G) Therapeutic intervention: Specialized mental health
- 3 services are to be made available as part of the team response,
- 4 either at the CAC or through coordination and referral with other
- 5 appropriate treatment providers.
- 6 (H) Victim support/advocacy: Victim support and advocacy are
- 7 to be made available as part of the team response, either at the
- 8 CAC or through coordination with other providers, throughout the
- 9 investigation and subsequent legal proceedings.
- 10 (I) Case review: Team discussion and information sharing
- 11 regarding the investigation, case status and services needed by the
- 12 child and family are to occur on a routine basis.
- 13 (J) Case tracking: CACs must develop and implement a system
- 14 for monitoring case progress and tracking case outcomes for team
- 15 components: Provided, That a child advocacy center may establish
- 16 a safe exchange location for children and families who have a
- 17 parenting agreement or an order providing for visitation or custody
- 18 of the children that require a safe exchange location.
- 19 (7) "Court Appointed Special Advocate Program" means a
- 20 community organization that screens, trains and supervises CASA
- 21 volunteers to advocate for the best interests of children who are
- 22 involved in abuse and neglect proceedings. Court Appointed Special
- 23 Advocate Programs will be operated under the following guidelines:
- 24 (A) Standards: CASA Programs shall be members in good standing

- 1 with the West Virginia Court Appointed Special Advocate
- 2 Association, Inc., and the National Court Appointed Special
- 3 Advocates Association and adhere to all standards set forth by
- 4 these entities.
- 5 (B) Organizational capacity: A designated legal entity
- 6 responsible for program and fiscal operations has been established
- 7 and implements basic sound administrative practice.
- 8 (C) Cultural competency and diversity: CASA programs promote
- 9 policies, practices and procedures that are culturally competent.
- 10 Cultural competency is defined as the capacity to function in more
- 11 than one culture, requiring the ability to appreciate, understand
- 12 and interact with members of diverse populations within the local
- 13 community.
- 14 (D) Case management: CASA programs must utilize a uniform case
- 15 management system to monitor case progress and track outcomes.
- 16 (E) Case review: CASA volunteers meet with CASA staff on a
- 17 routine basis to discuss case status and outcomes.
- 18 (F) Training: Court Appointed Special Advocates shall serve as
- 19 volunteers without compensation and shall receive training
- 20 consistent with state and nationally developed standards.
- 21 (G) Volunteer Immunity: A court appointed special advocate
- 22 volunteer is immune from civil liability to the full extent
- 23 provided in the federal Volunteer Protection Act of 1997.
- (7) (8) "Imminent danger to the physical well-being of the

- 1 child" means an emergency situation in which the welfare or the
- 2 life of the child is threatened. Such emergency situation exists
- 3 when there is reasonable cause to believe that any child in the
- 4 home is or has been sexually abused or sexually exploited, or
- 5 reasonable cause to believe that the following conditions threaten
- 6 the health or life of any child in the home:
- 7 (A) Nonaccidental trauma inflicted by a parent, guardian,
- 8 custodian, sibling or a babysitter or other caretaker;
- 9 (B) A combination of physical and other signs indicating a

- 24 (8) (9) "Legal guardianship" means the permanent relationship

- 1 between a child and caretaker, established by order of the circuit

- 4 (9) (10) "Multidisciplinary team" means a group of professionals
- 5 and paraprofessionals representing a variety of disciplines who
- 6 interact and coordinate their efforts to identify, diagnose and
- 7 treat specific cases of child abuse and neglect. Multidisciplinary
- 8 teams may include, but are not limited to, medical, educational,
- 9 child care and law-enforcement personnel, social workers,

- 1 (A) A parent, custodian or guardian, whether for financial
- 2 gain or not, persuades, induces, entices or coerces a child to

- 19 foster home, group home or other facility or residence.
- 20 (21) "Serious physical abuse" means bodily injury which
- 21 creates a substantial risk of death, which causes serious or
- 22 prolonged disfigurement, prolonged impairment of health or
- 23 prolonged loss or impairment of the function of any bodily organ.
- 24 (21) (22) "Siblings" means children who have at least one

- 1 biological parent in common or who have been legally adopted by the 2 same parents or parent.
- 3 (22) (23) "Time-limited reunification services" means
  4 individual, group and family counseling, inpatient, residential or
  5 outpatient substance abuse treatment services, mental health
  6 services, assistance to address domestic violence, services
  7 designed to provide temporary child care and therapeutic services
  8 for families, including crisis nurseries and transportation to or
  9 from any such services, provided during fifteen of the most recent
  10 twenty-two months a child has been in foster care, as determined by
  11 the earlier date of the first judicial finding that the child is
  12 subjected to abuse or neglect, or the date which is sixty days
  13 after the child is removed from home.
- 14 ARTICLE 5. JUVENILE PROCEEDINGS.
- 15 §49-5-13. Disposition of juvenile delinquents; appeal.
- (a) In aid of disposition of juvenile delinquents, the juvenile probation officer assigned to the court shall, upon request of the court, make an investigation of the environment of the juvenile and the alternative dispositions possible. The court, upon its own motion, or upon request of counsel, may order a psychological examination of the juvenile. The report of such examination and other investigative and social reports shall not be made available to the court until after the adjudicatory hearing. Unless waived, copies of the report shall be provided to counsel

- 1 for the petitioner and counsel for the juvenile no later than 2 seventy-two hours prior to the dispositional hearing.
- 3 (b) Following the adjudication, the court shall conduct the 4 dispositional proceeding, giving all parties an opportunity to be 5 heard. In disposition the court shall not be limited to the relief 6 sought in the petition and shall, in electing from the following 7 alternatives, consider the best interests of the juvenile and the 8 welfare of the public:
- 9 (1) Dismiss the petition;
- 10 (2) Refer the juvenile and the juvenile's parent or custodian 11 to a community agency for needed assistance and dismiss the 12 petition;
- (3) Upon a finding that the juvenile is in need of extra14 parental supervision: (A) Place the juvenile under the supervision
  15 of a probation officer of the court or of the court of the county
  16 where the juvenile has his or her usual place of abode or other
  17 person while leaving the juvenile in custody of his or her parent
  18 or custodian; and (B) prescribe a program of treatment or therapy
  19 or limit the juvenile's activities under terms which are reasonable
  20 and within the child's ability to perform, including participation
  21 in the litter control program established pursuant to section
  22 three, article fifteen-a, chapter twenty-two of this code or other
  23 appropriate programs of community service;
- 24 (4) Upon a finding that a parent or custodian is not willing

1 or able to take custody of the juvenile, that a juvenile is not 2 willing to reside in the custody of his parent or custodian or that 3 a parent or custodian cannot provide the necessary supervision and 4 care of the juvenile, the court may place the juvenile in temporary 5 foster care or temporarily commit the juvenile to the department or 6 a child welfare agency. The court order shall state that 7 continuation in the home is contrary to the best interest of the 8 juvenile and why; and whether or not the department made a 9 reasonable effort to prevent the placement or that the emergency 10 situation made such efforts unreasonable or impossible. Whenever 11 the court transfers custody of a youth to the department, an 12 appropriate order of financial support by the parents or guardians 13 shall be entered in accordance with section five, article seven of 14 this chapter and guidelines promulgated by the Supreme Court of 15 Appeals;

(5) Upon a finding that the best interests of the juvenile or the welfare of the public require it, and upon an adjudication of delinquency pursuant to subdivision (1), section four, article one of this chapter, the court may commit the juvenile to the custody of the Director of the Division of Juvenile Services for placement in a juvenile services facility for the treatment, instruction and rehabilitation of juveniles: *Provided*, That the court maintains discretion to consider alternative sentencing arrangements.

1 event that the court determines that it is in the juvenile's best 2 interests or required by the public welfare to place the juvenile 3 in the custody of the Division of Juvenile Services, the court 4 shall provide the Division of Juvenile Services with access to all 5 relevant court orders and records involving the underlying offense 6 or offenses for which the juvenile was adjudicated delinquent, 7 including sentencing and presentencing reports and evaluations, and 8 provide the Division with access to school records, psychological 9 reports and evaluations, medical reports and evaluations or any 10 other such records as may be in the court's possession as would 11 enable the Division of Juvenile Services to better assess and 12 determine the appropriate counseling, education and placement needs 13 for the juvenile offender. Commitments shall not exceed the maximum 14 term for which an adult could have been sentenced for the same 15 offense and any such maximum allowable sentence to be served in a 16 juvenile correctional facility may take into account any time 17 served by the juvenile in a detention center pending adjudication, 18 disposition or transfer. The order shall state that continuation in 19 the home is contrary to the best interests of the juvenile and why; 20 and whether or not the state department made a reasonable effort to 21 prevent the placement or that the emergency situation made such 22 efforts unreasonable or impossible; or

(6) After a hearing conducted under the procedures set out in

- twenty-seven of this code, commit the juvenile to a mental health facility in accordance with the juvenile's treatment plan; the Director of the mental health facility may release a juvenile and return him or her to the court for further disposition. The order shall state that continuation in the home is contrary to the best interests of the juvenile and why; and whether or not the state department made a reasonable effort to prevent the placement or that the emergency situation made such efforts unreasonable or impossible.
- 10 <u>(c) In any case in which the court decides to order the</u>
  11 juvenile placed in an out-of-state facility or program, it shall
  12 set forth in the order directing the placement the reasons the
  13 juvenile was not placed in an in-state facility or program.
- (c) (d) The disposition of the juvenile shall not be affected
  by the fact that the juvenile demanded a trial by jury or made a
  le plea of denial. Any dispositional order is subject to appeal to the
  Supreme Court of Appeals.
- (d) (e) Following disposition, the court shall inquire whether the juvenile wishes to appeal and the response shall be transcribed; a negative response shall not be construed as a waiver. The evidence shall be transcribed as soon as practicable and made available to the juvenile or his or her counsel, if the same is requested for purposes of further proceedings. A judge may grant a stay of execution pending further proceedings.

- 1 (e) (f) Notwithstanding any other provision of this code to
- 2 the contrary, if a juvenile charged with delinquency under this
- 3 chapter is transferred to adult jurisdiction and there tried and

- 6 ARTICLE 5D. MULTIDISCIPLINARY TEAMS.
- 7 §49-5D-3. Multidisciplinary treatment planning process.
- 8 (a) (1) A multidisciplinary treatment planning process for
- 9 cases initiated pursuant to articles five and six of this chapter
- 10 shall be established within each county of the state, either
- 11 separately or in conjunction with a contiguous county, by the
- 12 secretary of the department with advice and assistance from the
- 13 prosecutor's advisory council as set forth in section four, article
- 14 four, chapter seven of this code. The Division of Juvenile Services
- 15 shall establish a similar treatment planning process for

Treatment teams shall assess, plan and implement a 6 comprehensive, individualized service plan for children who are 7 victims of abuse or neglect and their families when a judicial 8 proceeding has been initiated involving the child or children for 9 <del>juveniles and their families involved in status offense or</del> 10 delinquency proceedings when, in a status offense proceeding, the 11 court refers the juvenile for services pursuant to sections eleven 12 and eleven-a, article five of this chapter and when, in a 13 delinquency proceeding, the court is considering placing the 14 juvenile in the department's custody or placing the juvenile out of 15 home at the department's expense pursuant to the provisions of 16 section thirteen of said article. In any such status offense or 17 delinquency case, the juvenile probation officer shall notify the 18 local office of the Department of Health and Human Resources and 19 the Division of Juvenile Services at least five working days before 20 the court proceeding in order to allow the multidisciplinary 21 treatment team to convene and develop a comprehensive 22 individualized service plan for the child: Provided, That such 23 notice is not required in cases where the child is already in state 24 custody or there exist exigent circumstances which justify taking

- 1 the child immediately into custody without a judicial proceeding.
- 2 In developing an individualized service plan for a child, the team
- 3 shall utilize a uniform comprehensive assessment of the child. The
- 4 department shall adopt a standard uniform comprehensive assessment
- 5 instrument or protocol to be used by treatment teams.
- 7 Prior to disposition, in each case in which a treatment planning team has been convened, the team shall advise the court as to the types of services the team has determined are needed and the type of placement, if any, which will best serve the needs of the child. If the team determines that an out-of-home placement will best serve the needs of the child, the team shall first consider placement at facilities or programs located within the state. The team may only recommend placement in an out-of-state facility if it concludes, after considering the best interests and overall needs of the child, that there are no available and suitable in-state facilities which can satisfactorily meet the specific needs of the child.
- (b) Each treatment team shall be convened by the child's or

  family's case manager in the Department of Health and Human

  Resources or the Division of Juvenile Services if the juvenile has

  been ordered into its custody for examination and diagnosis

  pursuant to section thirteen, article five of this chapter. The

  treatment team shall consist of the child's custodial parent or

  parents, guardian or guardians, other immediate family members, the

1 attorney or attorneys representing the child, the parent or parents 2 of the child, the child's attorney, the guardian ad litem, if any, 3 the prosecuting attorney or his or her designee, a member of a 4 child advocacy center when the child has been processed through the 5 child advocacy center program(s) and, where appropriate to the 6 particular case under consideration and available, a court-7 appointed special advocate, a member of a child advocacy center, an 8 appropriate school official and any other person or an agency 9 representative who may assist in providing recommendations for the 10 particular needs of the child and family. The child may participate 11 in multidisciplinary treatment team meetings if such is deemed 12 appropriate by the multidisciplinary treatment team. For purposes 13 of delinquency proceedings, the juvenile probation officer shall be 14 a member of the treatment team. Any person authorized by the 15 provisions of this chapter to convene a multidisciplinary team 16 meeting may seek and receive an order of the circuit court setting 17 such meeting and directing attendance. Members 18 multidisciplinary team may participate in team meetings by 19 telephone or video conferencing: Provided, That a member of a child 20 advocacy center should participate in any case when appropriate to 21 the particular case under consideration. Provided, That the 22 provisions of this subsection do not prevent the respective 23 agencies from designating a person other than the case manager as 24 a facilitator for treatment team meetings.

- 1 (c) The treatment team shall coordinate its activities and 2 membership with local family resource networks and coordinate with 3 other local and regional child and family service planning 4 committees to assure the efficient planning and delivery of child 5 and family services on a local and regional level.
- (d) State, county and local agencies shall provide the 7 multidisciplinary treatment teams with any information requested in 8 writing by the team as allowable by law or upon receipt of a 9 certified copy of the circuit court's order directing said agencies 10 to release information in its possession relating to the child. The 11 team shall assure that all information received and developed in 12 connection with the provisions of this article remain confidential. 13 For purposes of this section, the term "confidential" shall be 14 construed in accordance with the provisions of section one, article 15 seven of this chapter. The multidisciplinary treatment team shall 16 be afforded access to information in the possession of the 17 Department of Health and Human Services, Division of Juvenile 18 Services, law-enforcement agencies, and other state, county, and 19 local agencies; and the agencies shall cooperate in the sharing of 20 information, as may be provided in sections three(d) and six, 21 article five-D and section one, article seven, all of chapter 22 forty-nine, and any other relevant provision of law. - 2 (e) Nothing in this section may be construed to require a
- 3 multidisciplinary team meeting to be held prior to temporarily
- 4 placing a child out-of-home under exigent circumstances or upon a
- 5 court order placing the juvenile in a juvenile facility operated by
- 6 the Division of Juvenile Services.
- 7 §49-5D-3a. Recommendation of team to the court; hearing
- 8 requirement; required findings.
- (a) In any case in which a multidisciplinary treatment team
  develops an individualized service plan for a child or family
  pursuant to the provisions of section three of this article, the
  court shall review the proposed service plan to determine if
  implementation of the plan is in the child's best interests. If the
  multidisciplinary team cannot agree on a plan or if the court
  determines not to adopt the team's recommendations, it shall, upon
  motion or sua sponte, schedule and hold within ten days of such
  determination, and prior to the entry of an order placing the child
  in the custody of the department or in an out-of-home setting, a
  hearing to consider evidence from the team as to its rationale for

Unless otherwise ordered by the 20 court, a party whose parental rights have been terminated and his or her attorney shall not be given notice of a multidisciplinary 22 treatment team meeting and does not have the right to participate 23 <u>in any treatment team meeting.</u>

(a) (1) When a juvenile is adjudicated as a status offender 2 3 pursuant to section eleven-d, article five of this chapter, the 4 Department of Health and Human Resources shall promptly convene a 5 multidisciplinary treatment team and conduct an assessment, 6 utilizing a standard uniform comprehensive assessment instrument or 7 protocol, to determine the juvenile's mental and physical 8 condition, maturity and education level, home and family 9 environment, rehabilitative needs and recommended service plan. 10 Upon completion of the assessment, the treatment team shall prepare 11 and implement a comprehensive, individualized service plan for the 12 juvenile. (2) When a juvenile is adjudicated as a delinquent or has been 13 14 granted an improvement period pursuant to section nine, article 15 five of this chapter, the court, either upon its own motion or motion of a party, may require the Department of Health and Human Resources to convene a multidisciplinary treatment team and conduct 18 an assessment, utilizing a standard uniform comprehensive 19 assessment instrument or protocol, to determine the juvenile's 20 mental and physical condition, maturity and education level, home 21 and family environment, rehabilitative needs and recommended 22 service plan. A referral to the Department of Health and Human 23 Resources to convene a multidisciplinary treatment team and to 24 conduct such an assessment shall be made when the court is

1 considering placing the juvenile in the department's custody or 2 placing the juvenile out-of-home at the department's expense 3 pursuant to section thirteen, article five of this chapter. In any 4 delinquency proceeding in which the court requires the Department 5 of Health and Human Resources to convene a multidisciplinary 6 treatment team, the probation officer shall notify the department 7 at least fifteen working days before the court proceeding in order 8 to allow the department sufficient time to convene and develop an 9 individualized service plan for the juvenile. 10 (3) When a juvenile has been adjudicated and committed to the 11 custody of the director of the Division of Juvenile Services, 12 including those cases in which the juvenile has been committed for 13 examination and diagnosis, the Division of Juvenile Services shall, 14 promptly convene a multidisciplinary treatment team and conduct an 15 assessment, utilizing a standard uniform comprehensive assessment 16 instrument or protocol, to determine the juvenile's mental and physical condition, maturity and education level, home and family 18 environment, rehabilitative needs and recommended service plan. 19 Upon completion of the assessment, the treatment team shall prepare 20 and implement a comprehensive, individualized service plan for the 21 juvenile. 22 (4) (a) The rules of juvenile procedure shall govern the 23 procedure for obtaining an assessment of a juvenile, preparing an

24 individualized service plan and submitting the plan and assessment

1 to the court.

2 (b) In juvenile proceedings conducted pursuant to article five 3 of this chapter, the treatment team shall consist of the juvenile, 4 the juvenile's case manager in the Department of Health and Human 5 Resources or the Division of Juvenile Services, the juvenile's 6 parent or parents, quardian or quardians or custodial relatives, 7 the juvenile's attorney, any attorney representing a member of the 8 treatment team, the prosecuting attorney or his or her designee, an 9 appropriate school official and any other person or agency 10 representative who may assist in providing recommendations for the 11 particular needs of the juvenile and family, including domestic 12 violence service providers. In delinquency proceedings, the 13 probation officer shall be a member of a treatment team. When 14 appropriate, the juvenile case manager in the Department of Health 15 and Human Resources and the Division of Juvenile Services shall 16 cooperate in conducting multidisciplinary treatment team meetings when it is in the juvenile's best interest. (c) Prior to disposition, in each case in which a treatment 18 19 planning team has been convened, the team shall advise the court as 20 to the types of services the team has determined are needed and 21 type of placement, if any, which will best serve the needs of the 22 child. If the team determines that an out-of-home placement will 23 best serve the needs of the child, the team shall first consider 24 placement at facilities or programs located within the state. The

- 1 team may only recommend placement in an out-of-state facility if it
- 2 concludes, after considering the best interests and overall needs
- 3 of the child, that there are no available and suitable in-state
- 4 facilities which can satisfactorily meet the specific needs of the
- 5 child.
- 6 (d) The multidisciplinary treatment team shall submit written

- 16 placed to develop an after-care plan. The rules of juvenile
- 17 procedure and section twenty, article five, chapter forty-nine of
- 18 the code shall govern the development of an after-care plan for a
- 19 juvenile, the submission of the plan to the court and any objection
- 20 to the after-care plan.
- 21 (f) If a juvenile respondent admits the underlying allegations
- 22 of the case initiated pursuant to article five, chapter forty-nine
- 23 of this code in the multidisciplinary treatment planning process,
- 24 his or her statements shall not be used in any juvenile or criminal

- 1 proceedings against the juvenile, except for perjury or false
- 2 swearing.
- 3 §49-6-2. Petition to court when child believed neglected or abused
- 4 -- Right to counsel; improvement period; hearing;
- 5 priority of proceeding; transcript;
- (a) In any proceeding under the provisions of this article, 6 7 the child, his or her or parents and his or her legally established 8 custodian or other persons standing in loco parentis to him or her 9 shall have the right to be represented by counsel at every stage of 10 the proceedings and shall be informed by the court of their right 11 to be so represented and that if they cannot pay for the services 12 of counsel, that counsel will be appointed. Counsel of the child 13 shall be appointed in the initial order. If the order gives 14 physical custody of the child to the state, the initial order shall 15 appoint counsel for the parents or, if the parents are separated or 16 divorced, the parents or parent or other person or persons standing 17 in loco parentis who had physical custody of the child for the 18 majority of the time in the period immediately preceding the 19 petition: Provided, That such representation shall only continue 20 after the first appearance if the parent or other persons standing 21 in loco parentis cannot pay for the services of counsel. Counsel 22 for other parties shall only be appointed upon request for 23 appointment of counsel. If the requesting parties have not retained 24 counsel and cannot pay for the services of counsel, the court

1 shall, by order entered of record, appoint an attorney or attorneys 2 to represent the other party or parties and so inform the parties. 3 Under no circumstances may the same attorney represent both the 4 child and the other party or parties, nor shall the same attorney 5 represent both parents or custodians. - 9 duties required as an attorney licensed to practice law in the

- 11 (b) In any proceeding brought pursuant to the provisions of
- 12 this article, the court may grant any respondent an improvement
- 13 period in accord with the provisions of this article. During such
- 14 period, the court may require temporary custody with a responsible
- 15 person which has been found to be a fit and proper person for the
- 16 temporary custody of the child or children or the state department

12 must be based upon conditions existing at the time of the filing of
13 the petition and proven by clear and convincing proof.

(d) Any petition filed and any proceeding held under the provisions of this article shall, to the extent practicable, be given priority over any other civil action before the court, except proceedings under article two-a, chapter forty-eight of this code and actions in which trial is in progress. Any petition filed under the provisions of this article shall be docketed immediately upon filing. Any hearing to be held at the end of an improvement period and any other hearing to be held during any proceedings under the provisions of this article shall be held as nearly as practicable on successive days and, with respect to said hearing to be held at the end of an improvement period, shall be held as close in time as

- 1 possible after the end of said improvement period and shall be held
- 2 within sixty days of the termination of such improvement period.
- 3 (e) Following the court's determination, it shall be inquired
- 4 of the parents or custodians whether or not appeal is desired and
- 5 the response transcribed. A negative response shall not be
- 6 construed as a waiver. The evidence shall be transcribed and made
- 7 available to the parties or their counsel as soon as practicable,
- 8 if the same is required for purposes of further proceedings. If an
- 9 indigent person intends to pursue further proceedings, the court
- 10 reporter shall furnish a transcript of the hearing without cost to
- 11 the indigent person if an affidavit is filed stating that he or she
- 12 cannot pay therefor.

- 14 -- Temporary custody;
- 15 (a) Upon the filing of a petition, the court may order that
- 16 the child alleged to be an abused or neglected child be delivered
- 17 for not more than ten days into the custody of the state department
- 18 or a responsible person found by the court to be a fit and proper
- 19 person for the temporary care of the child pending a preliminary
- 20 hearing, if it finds that:
- 21 (1) There exists imminent danger to the physical well-being of
- 22 the child; and
- 23 (2) There are no reasonably available alternatives to removal
- 24 of the child, including, but not limited to, the provision of

1 medical, psychiatric, psychological or homemaking services in the 2 child's present custody: Provided, That where the alleged abusing 3 person, if known, is a member of a household, the court shall not 4 allow placement pursuant to this section of the child or children 5 in said home unless the alleged abusing person is or has been 6 precluded from visiting or residing in said home by judicial order. 7 In a case where there is more than one child in the home, or in the 8 temporary care, custody or control of the alleged offending parent, 9 the petition shall so state, and notwithstanding the fact that the 10 allegations of abuse or neglect may pertain to less than all of 11 such children, each child in the home for whom relief is sought 12 shall be made a party to the proceeding. Even though the acts of 13 abuse or neglect alleged in the petition were not directed against 14 a specific child who is named in the petition, the court shall 15 order the removal of such child, pending final disposition, if it 16 finds that there exists imminent danger to the physical well-being 17 of the child and a lack of reasonable available alternatives to 18 removal. The initial order directing such custody shall contain an 19 order appointing counsel and scheduling the preliminary hearing, 20 and upon its service shall require the immediate transfer of 21 custody of such child or children to the department 22 responsible relative which may include any parent, guardian, or 23 other custodian. The court order shall state:

(A) That continuation in the home is contrary to the best

24

- 1 interests of the child and why; and
- 2 (B) Whether or not the department made reasonable efforts to
- 3 preserve the family and prevent the placement or that the emergency
- 4 situation made such efforts unreasonable or impossible. The order
- 5 may also direct any party or the department to initiate or become
- 6 involved in services to facilitate reunification of the family.
- 7 (b) Whether or not the court orders immediate transfer of
- 8 custody as provided in subsection (a) of this section, if the facts
- 9 alleged in the petition demonstrate to the court that there exists
- 10 imminent danger to the child, the court may schedule a preliminary
- 11 hearing giving the respondents at least five days' actual notice.
- 12 If the court finds at the preliminary hearing that there are no
- 13 alternatives less drastic than removal of the child and that a
- 14 hearing on the petition cannot be scheduled in the interim period,
- 15 the court may order that the child be delivered into the temporary
- 16 custody of the department or a responsible person or agency found
- 17 by the court to be a fit and proper person for the temporary care
- 18 of the child for a period not exceeding sixty days: Provided, That
- 19 the court order shall state:
- 20 (1) That continuation in the home is contrary to the best
- 21 interests of the child and set forth the reasons therefor;
- 22 (2) whether or not the department made reasonable efforts to
- 23 preserve the family and to prevent the child's removal from his or
- 24 her home:

- 1 (3) Whether or not the department made reasonable efforts to 2 preserve the family and to prevent the placement or that the 3 emergency situation made such efforts unreasonable or impossible; 4 and
- 5 (4) What efforts should be made by the department, if any, to 6 facilitate the child's return home: *Provided, however*, That if the 7 court grants an improvement period as provided in section twelve of 8 this article, the sixty-day limit upon temporary custody is waived.
- (c) If a child or children shall, in the presence of a child 10 protective service worker, be in an emergency situation which 11 constitutes an imminent danger to the physical well-being of the 12 child or children, as that phrase is defined in section three, 13 article one of this chapter, and if such worker has probable cause 14 to believe that the child or children will suffer additional child 15 abuse or neglect or will be removed from the county before a 16 petition can be filed and temporary custody can be ordered, the 17 worker may, prior to the filing of a petition, take the child or 18 children into his or her custody without a court order: Provided, 19 That after taking custody of such child or children prior to the 20 filing of a petition, the worker shall forthwith appear before a 21 circuit judge or a juvenile referee of the county wherein custody 22 was taken, or if no such judge or referee be available, before a 23 circuit judge or a juvenile referee of an adjoining county, and 24 shall immediately apply for an order ratifying the emergency

1 custody of the child pending the filing of a petition. The circuit 2 court of every county in the state shall appoint at least one of 3 the magistrates of the county to act as a juvenile referee, who 4 shall serve at the will and pleasure of the appointing court, and 5 who shall perform the functions prescribed for such position by the 6 provisions of this subsection. The parents, quardians or custodians 7 of the child or children may be present at the time and place of 8 application for an order ratifying custody, and if at the time the 9 child or children are taken into custody by the worker, the worker 10 knows which judge or referee is to receive the application, the 11 worker shall so inform the parents, guardians or custodians. The 12 application for emergency custody may be on forms prescribed by the 13 Supreme Court of Appeals or prepared by the prosecuting attorney or 14 the applicant, and shall set forth facts from which it may be 15 determined that the probable cause described above in this 16 subsection exists. Upon such sworn testimony or other evidence as 17 the judge or referee deems sufficient, the judge or referee may 18 order the emergency taking by the worker to be ratified. If 19 appropriate under the circumstances, the order may include 20 authorization for an examination as provided for in subsection (b), 21 section four of this article. If a referee issues such an order, 22 the referee shall by telephonic communication have such order 23 orally confirmed by a circuit judge of the circuit or an adjoining 24 circuit who shall on the next judicial day enter an order of

- 1 confirmation. If the emergency taking is ratified by the judge or 2 referee, emergency custody of the child or children shall be vested 3 in the department until the expiration of the next two judicial 4 days, at which time any such child taken into emergency custody 5 shall be returned to the custody of his or her parent or guardian 6 or custodian unless a petition has been filed and custody of the 7 child has been transferred under the provisions of section three of 8 this article.
- 9 (d) For purposes of the court's consideration of temporary
  10 custody pursuant to the provisions of subsection (a) or (b) of this
  11 section, the department is not required to make reasonable efforts
  12 to preserve the family if the court determines:
- (1) The parent has subjected the child, another child of the parent, or any other child residing in the same household or under the temporary or permanent custody of the parent to aggravated circumstances which include, but are not limited to, abandonment, torture, chronic abuse and sexual abuse;
- 18 (2) The parent has:
- (A) Committed murder of the child's other parent, guardian or 20 custodian, another child of the parent, or any other child residing 21 in the same household or under the temporary or permanent custody 22 of the parent;
- 23 (B) Committed voluntary manslaughter of the <u>child's</u> other 24 parent, guardian <u>or custodian</u>, another child of the parent, or any

- 1 other child residing in the same household or under the temporary
- 2 or permanent custody of the parent;
- 3 (C) Attempted or conspired to commit such a murder or
- 4 voluntary manslaughter or been an accessory before or after the
- 5 fact to either such crime;
- 6 (D) Committed unlawful or malicious wounding that results in
- 7 serious bodily injury to the child, the child's other parent,
- 8 guardian or custodian, to another child of the parent, or any other
- 9 child residing in the same household or under the temporary or
- 10 permanent custody of the parent; or
- 11 (E) Committed sexual assault or sexual abuse of the child, the
- 12 child's other parent, guardian, or custodian, another child of the
- 13 parent, or any other child residing in the same household or under
- 14 the temporary or permanent custody of the parent; or
- (F) Required by state or federal law to register with a sex
- 16 offender registry.
- 17 (3) The parental rights of the parent to another child have
- 18 been terminated involuntarily.
- 19 §49-6-5. Disposition of neglected or abused children;
- 20 (a) Following a determination pursuant to section two of this
- 21 article wherein the court finds a child to be abused or neglected,
- 22 the department shall file with the court a copy of the child's case
- 23 plan, including the permanency plan for the child. The term case
- 24 plan means a written document that includes, where applicable, the

1 requirements of the family case plan as provided for in section 2 three, article six-d of this chapter and that also includes at 3 least the following: A description of the type of home 4 institution in which the child is to be placed, including a 5 discussion of the appropriateness of the placement and how the 6 agency which is responsible for the child plans to assure that the 7 child receives proper care and that services are provided to the 8 parents, child and foster parents in order to improve the 9 conditions in the parent(s) home; facilitate return of the child to 10 his or her own home or the permanent placement of the child; and 11 address the needs of the child while in foster care, including a 12 discussion of the appropriateness of the services that have been 13 provided to the child. The term "permanency plan" refers to that 14 part of the case plan which is designed to achieve a permanent home 15 for the child in the least restrictive setting available. The plan 16 must document efforts to ensure that the child is returned home 17 within approximate time lines for reunification as set out in the 18 plan. Reasonable efforts to place a child for adoption or with a 19 legal guardian may be made at the same time reasonable efforts are 20 made to prevent removal or to make it possible for a child to 21 safely return home. If reunification is not the permanency plan for 22 the child, the plan must state why reunification is not appropriate 23 and detail the alternative placement for the child to include 24 approximate time lines for when such placement is expected to

- 1 become a permanent placement. This case plan shall serve as the
- 2 family case plan for parents of abused or neglected children.
- 3 Copies of the child's case plan shall be sent to the child's
- 4 attorney and parent, guardian or custodian or their counsel at
- 5 least five days prior to the dispositional hearing. The court shall
- 6 forthwith proceed to disposition giving both the petitioner and
- 7 respondents an opportunity to be heard. The court shall give
- 8 precedence to dispositions in the following sequence:
- 9 (1) Dismiss the petition;
- 10 (2) Refer the child, the abusing parent, the battered parent
- 11 or other family members to a community agency for needed assistance
- 12 and dismiss the petition;
- 13 (3) Return the child to his or her own home under supervision
- 14 of the department;
- 15 (4) Order terms of supervision calculated to assist the child
- 16 and any abusing parent or battered parent or parents or custodian
- 17 which prescribe the manner of supervision and care of the child and
- 18 which are within the ability of any parent or parents or custodian
- 19 to perform;
- 20 (5) Upon a finding that the abusing parent or battered parent
- 21 or parents are presently unwilling or unable to provide adequately
- 22 for the child's needs, commit the child temporarily to the custody
- 23 of the state department, a licensed private child welfare agency or
- 24 a suitable person who may be appointed guardian by the court. The

- 1 court order shall state:
- 2 (A) That continuation in the home is contrary to the best
- 3 interests of the child and why;
- 4 (B) Whether or not the department has made reasonable efforts,
- 5 with the child's health and safety being the paramount concern, to
- 6 preserve the family, or some portion thereof, and to prevent or
- 7 eliminate the need for removing the child from the child's home and
- 8 to make it possible for the child to safely return home;
- 9 (C) What efforts were made or that the emergency situation
- 10 made such efforts unreasonable or impossible; and
- 11 (D) The specific circumstances of the situation which made
- 12 such efforts unreasonable if services were not offered by the
- 13 department. The court order shall also determine under what
- 14 circumstances the child's commitment to the department shall
- 15 continue. Considerations pertinent to the determination include
- 16 whether the child should:
- 17 (i) Be continued in foster care for a specified period;
- 18 (ii) Be considered for adoption;
- 19 (iii) Be considered for legal guardianship;
- 20 (iv) Be considered for permanent placement with a fit and
- 21 willing relative; or
- (v) Be placed in another planned permanent living arrangement,
- 23 but only in cases where the department has documented to the
- 24 circuit court a compelling reason for determining that it would not

1 be in the best interests of the child to follow one of the options
2 set forth in subparagraphs (i), (ii), (iii) or (iv) of this
3 paragraph. The court may order services to meet the special needs
4 of the child. Whenever the court transfers custody of a youth to
5 the department, an appropriate order of financial support by the
6 parents or guardians shall be entered in accordance with section

7 five, article seven of this chapter; or

- 8 (6) Upon a finding that there is no reasonable likelihood that
  9 the conditions of neglect or abuse can be substantially corrected
  10 in the near future and, when necessary for the welfare of the
  11 child, terminate the parental, custodial and guardianship rights
  12 and responsibilities of the abusing parent and commit the child to
  13 the permanent sole custody of the nonabusing parent, if there be
  14 one, or, if not, to either the permanent guardianship of the
  15 department or a licensed child welfare agency. The court may award
  16 sole custody of the child to a nonabusing battered parent. If the
  17 court shall so find, then in fixing its dispositional order the
  18 court shall consider the following factors:
- 19 (A) The child's need for continuity of care and caretakers;
- 20 (B) The amount of time required for the child to be integrated 21 into a stable and permanent home environment; and
- (C) Other factors as the court considers necessary and proper.
- 23 Notwithstanding any other provision of this article, the court
- 24 shall give consideration to the wishes of a child fourteen years of

- 1 age or older or otherwise of an age of discretion as determined by
- 2 the court regarding the permanent termination of parental rights.
- 3 No adoption of a child shall take place until all proceedings for
- 4 termination of parental rights under this article and appeals
- 5 thereof are final. In determining whether or not parental rights
- 6 should be terminated, the court shall consider the efforts made by
- 7 the department to provide remedial and reunification services to
- 8 the parent. The court order shall state:
- 9 (i) That continuation in the home is not in the best interest 10 of the child and why;
- 11 (ii) Why reunification is not in the best interests of the 12 child:
- (iii) Whether or not the department made reasonable efforts,
- 14 with the child's health and safety being the paramount concern, to
- 15 preserve the family, or some portion thereof, and to prevent the
- 16 placement or to eliminate the need for removing the child from the
- 17 child's home and to make it possible for the child to safely return
- 18 home, or that the emergency situation made such efforts
- 19 unreasonable or impossible; and
- 20 (iv) Whether or not the department made reasonable efforts to
- 21 preserve and reunify the family, or some portion thereof, including
- 22 a description of what efforts were made or that such efforts were
- 23 unreasonable due to specific circumstances.
- 24 (7) For purposes of the court's consideration of the

- 1 disposition custody of a child pursuant to the provisions of this
- 2 subsection, the department is not required to make reasonable
- 3 efforts to preserve the family if the court determines:
- 4 (A) The parent has subjected the child, another child of the
- 5 parent, or any other child residing in the same household or under
- 6 the temporary or permanent custody of the parent to aggravated
- 7 circumstances which include, but are not limited to, abandonment,
- 8 torture, chronic abuse and sexual abuse;
- 9 (B) The parent has:
- 10 (i) Committed murder of the child's other parent, guardian or
- 11 custodian, another child of the parent or any other child residing
- 12 in the same household or under the temporary or permanent custody
- 13 of the parent;
- 14 (ii) Committed voluntary manslaughter of the child's other
- 15 parent, guardian or custodian, another child of the parent, or any
- 16 other child residing in the same household or under the temporary
- 17 or permanent custody of the parent;
- 18 (iii) Attempted or conspired to commit such a murder or
- 19 voluntary manslaughter or been an accessory before or after the
- 20 fact to either such crime;
- 21 (iv) Committed a felonious assault that results in serious
- 22 bodily injury to the child, the child's other parent, guardian or
- 23 custodian, to another child of the parent, or any other child
- 24 residing in the same household or under the temporary or permanent

- 1 custody of the parent; or
- 2 (v) Committed sexual assault or sexual abuse of the child, the
- 3 child's other parent, guardian, or custodian, another child of the
- 4 parent, or any other child residing in the same household or under
- 5 the temporary or permanent custody of the parent; or
- 6 (vi) Required by state or federal law to register with a sex
- 7 <u>offender registry.</u>
- 8 (C) The parental rights of the parent to another child have
- 9 been terminated involuntarily.
- 10 (b) As used in this section, "no reasonable likelihood that
- 11 conditions of neglect or abuse can be substantially corrected"
- 12 shall mean that, based upon the evidence before the court, the
- 13 abusing adult or adults have demonstrated an inadequate capacity to
- 14 solve the problems of abuse or neglect on their own or with help.
- 15 Such conditions shall be considered to exist in the following
- 16 circumstances, which shall not be exclusive:
- 17 (1) The abusing parent or parents have habitually abused or
- 18 are addicted to alcohol, controlled substances or drugs, to the
- 19 extent that proper parenting skills have been seriously impaired
- 20 and such person or persons have not responded to or followed
- 21 through the recommended and appropriate treatment which could have
- 22 improved the capacity for adequate parental functioning;
- 23 (2) The abusing parent or parents have willfully refused or
- 24 are presently unwilling to cooperate in the development of a

- 1 reasonable family case plan designed to lead to the child's return
  2 to their care, custody and control;
- 3 (3) The abusing parent or parents have not responded to or 4 followed through with a reasonable family case plan or other 5 rehabilitative efforts of social, medical, mental health or other 6 rehabilitative agencies designed to reduce or prevent the abuse or 7 neglect of the child, as evidenced by the continuation or 8 insubstantial diminution of conditions which threatened the health, 9 welfare or life of the child;
- 10 (4) The abusing parent or parents have abandoned the child;
- 11 (5) The abusing parent or parents have repeatedly or seriously
  12 injured the child physically or emotionally, or have sexually
  13 abused or sexually exploited the child, and the degree of family
  14 stress and the potential for further abuse and neglect are so great
  15 as to preclude the use of resources to mitigate or resolve family
  16 problems or assist the abusing parent or parents in fulfilling
  17 their responsibilities to the child;
- 18 (6) The abusing parent or parents have incurred emotional 19 illness, mental illness or mental deficiency of such duration or 20 nature as to render such parent or parents incapable of exercising 21 proper parenting skills or sufficiently improving the adequacy of 22 such skills; or
- 23 (7) The battered parent's parenting skills have been seriously 24 impaired and said person has willfully refused or is presently

- 1 unwilling or unable to cooperate in the development of a reasonable
- 2 treatment plan or has not adequately responded to or followed
- 3 through with the recommended and appropriate treatment plan.
- 4 (c) The court may, as an alternative disposition, allow the 5 parents or custodians an improvement period not to exceed six 6 months. During this period the court shall require the parent to 7 rectify the conditions upon which the determination was based. The 8 court may order the child to be placed with the parents, or any 9 person found to be a fit and proper person, for the temporary care 10 of the child during the period. At the end of the period, the court 11 shall hold a hearing to determine whether the conditions have been 12 adequately improved and at the conclusion of the hearing shall make 13 a further dispositional order in accordance with this section.

### 14 §49-6-6. Modification of dispositional orders.

(a) Upon motion of a child, a child's parent or custodian, or 16 the State Department of Health and Human Resources alleging a change 17 of circumstances requiring a different disposition, the court shall 18 conduct a hearing pursuant to section two of this article and may 19 modify a dispositional order if the court finds by clear and 20 convincing evidence a material change of circumstances and that such 21 modification is in the child's best interests: Provided, That a 22 dispositional order pursuant to subdivision (6), subsection (a) of 23 section five shall not be modified after the child has been adopted, 24 except as provided in subsections (b) and (c) of this section.

1 Adequate and timely notice of any motion for modification shall be 2 given to the child's counsel, counsel for the child's parent or 3 custodian and, to the state department and any person entitled to 4 notice and the right to be heard. The circuit court of origin has 5 exclusive jurisdiction over placement of the child, and such 6 placement shall not be disrupted or delayed by any administrative 7 process of the department.

- (b) If the child is removed or relinquished from an adoptive

  home or other permanent placement after the case has been

  dismissed, any party with notice thereof and the receiving agency

  shall promptly report the matter to the circuit court of origin,

  the department, and the child's counsel, and the court shall

  schedule a permanency hearing within sixty days, with notice given

  to any appropriate parties and persons entitled to notice and the

  right to be heard. The department shall convene a multidisciplinary

  treatment team meeting within thirty days of the receipt of notice

  of permanent placement disruption.
- (c) If a child has not been adopted, the child or department
  may move the court to place the child with a parent or custodian
  whose rights have been terminated and/or restore such parent's or
  guardian's rights. Under these circumstances, the court may order
  such placement and/or restoration of a parent's or quardian's
  rights if it finds by clear and convincing evidence a material
  change of circumstances and that such placement and/or restoration

- 1 is in the child's best interests.
- 2 §49-6-8. Foster care review; annual reports to the court
- 3 Permanency Hearing and Permanent Placement Review.
- 4 (a) If the court finds, pursuant to any provision of this
- 5 article, that the department is not required to make reasonable
- 6 efforts to preserve the family, then, notwithstanding any other
- 7 provision, a permanency hearing must be held within thirty days
- 8 following the entry of the court order so finding, and a permanent
- 9 placement review hearing must be conducted at least once every
- 10 three calendar months thereafter until a permanent placement is
- 11 achieved.
- 12 <u>(b)</u> If, twelve months after receipt by the department or its
  13 authorized agent of physical custody of a child either by a court
  14 ordered placement or by a voluntary agreement, the department has
  15 not placed a child in an adoptive home or placed the child with a
  16 natural parent or placed the child in legal guardianship or
  17 permanently placed the child with a fit and willing relative, the
  18 department shall file with the court a petition for review of the
  19 case court shall hold a permanency hearing. The department shall
  20 also file a report with the court with the court a report detailing

21 the efforts that have been made to place the child in a permanent

22 home and copies of the child's case plan, including the permanency

23 plan as defined in section five, article six of this chapter.

24 Copies of the report shall be sent to the child's attorney and be

1 made available to the child's parent(s) or guardian parties and 2 all persons entitled to notice and the right to be heard. The court 3 shall schedule a hearing in chambers, giving notice and the right 4 to be present to: The child's attorney; the child, if twelve years 5 of age or older; the child's parents; the child's guardians; the 6 child's foster parents; any preadoptive parent or any relative 7 providing care for the child; any person entitled to notice and the 8 right to be heard; and such other persons as the court may, in its 9 discretion, direct. The child's presence may be waived by the 10 child's attorney at the request of the child or if the child would 11 suffer emotional harm. The purpose of the hearing is to review the 12 child's case, to determine whether and under what conditions the 13 child's commitment to the department shall continue and to 14 determine what efforts are necessary to provide the child with a 15 permanent home. In the case of a child who will not be returned to 16 his or her parent, the court shall consider in-state and out-of-17 state placement options, and, if the court considers an out-of-18 state placement, the court shall determine whether such placement 19 is in the best interests of the child; in the case of a child who 20 has attained the sixteen years of age, the court shall determine 21 the services needed to assist the child to make the transition from 22 foster care to independent living. In any case in which the court 23 decides to order the child placed in an out-of-state facility or 24 program it shall set forth in the order directing the placement the

1 reasons why the child was not placed in an in-state facility or 2 program. At the conclusion of the hearing the court shall, in 3 accordance with the best interests of the child, enter 4 appropriate order containing all such appropriate findings. of 5 disposition. The court order shall state: (1) Whether or not the 6 department made reasonable efforts to preserve the family and to 7 prevent out-of-home placement or that the specific situation made 8 such effort unreasonable; (2) whether or not the department made 9 reasonable efforts to finalize the permanency plan for the child; 10 and (3) identify services required to meet the child's needs. 11 needs: Provided, That the department is not required to make 12 reasonable efforts to preserve the family if the court determines 13 any of the conditions set forth in subdivision (7), subsection (a), 14 section five of this article exist. The court shall possess 15 continuing jurisdiction over cases reviewed under this section for 16 so long as a child remains in temporary foster care or, when a 17 child is returned to his or her natural parents subject to 18 conditions imposed by the court, for so long as the conditions are 19 effective. (b) (c) The state department court shall file a supplementary 20 21 petition for review with the court shall conduct another permanency 22 <u>hearing</u> within <del>twelve months and every</del> twelve months thereafter for 23 every each child that who remains in the physical or legal custody 24 of the State Department of Health and Human Resources until the

1 child is placed in an adoptive home or returned to his or her 2 parents or placed in legal guardianship or permanently placed with 3 a fit and willing relative.

(c) (d) The state department shall annually report to the court the current status of the placements of children in permanent care and custody of the state department who have not been adopted.

(d) (e) The state department shall file a report with the

8 court in any case where any child in the temporary or permanent 9 custody of the state receives more than three placements in one 10 year no later than thirty days after the third placement. This 11 report shall be provided to all parties and persons entitled to 12 notice and the right to be heard. and their counsel. Upon motion by 13 any party, the court shall review these placements and determine 14 what efforts are necessary to provide the child with a stable 15 foster or temporary permanent home: Provided, That no report shall 16 be provided to any parent or parent's attorney whose parental

(e) (f) The state department shall notify, in writing, the court, the child, if over the age of twelve, the child's attorney, the parents and the parents' attorney forty-eight hours prior to the move if this is a planned move, or within forty-eight hours of the next business day after the move if this is an emergency move, except where such notification would endanger the child or the foster family. This notice shall not be required in any case where

17 rights have been terminated pursuant to this article.

- 1 the child is in imminent danger in the child's current placement.
- 2 The location of the child need not be disclosed, but the purpose of

- 16 §49-6-9a. Custody Ordered from Family Court in emergency
- situations.
- 18 (a) Where any child in a family court proceeding is in
- 19 circumstances constituting imminent danger in the presence of a
- 20 family court judge, and the family court judge finds the child to
- 21 be neglected or abused as defined in section three, article one of
- 22 this chapter, the judge may order the child to be taken into the
- 23 emergency custody of the Department of Health and Human Resources
- 24 without the court order otherwise required by section three of this

- 1 article, if the judge finds that: (1) There exists an imminent
- 2 danger to the physical well-being of the child as defined in
- 3 section three, article one of this chapter; and (2) there are no
- 4 reasonable, available alternatives to the emergency custody order.
- 5 Upon notification by the family court judge that there exists an
- 6 imminent danger to the physical well-being of the child, the

- 18 (c) The family court shall, within two judicial days of its

- 23 transmitted forthwith to the department, the circuit court and

The 10 scheduled hearing may be mooted by the department's earlier 11 submission of the investigative report or, in the alternative, the 12 filing of a child abuse and neglect petition under section three of this article. The family court shall retain full jurisdiction of 14 the child custody proceedings or protective order proceedings, or 15 both, until a child abuse and neglect petition is filed. 16 (d) Any worker for the department assuming custody of a child pursuant to the provisions of this section shall immediately notify the child's parents, parent, quardian or custodian of the taking of 19 custody of the child and the underlying reasons for taking custody, if the whereabouts of the parents, parent, quardian or custodian are known or can be discovered with due diligence; and if not, 22 notice and explanation shall be given to the child's closest 23 relative, if his or her whereabouts are known or can be discovered 24 with due diligence within a reasonable time. An inquiry shall be

- 1 made of relatives and neighbors, and if an appropriate relative or
- 2 neighbor is willing to assume custody of such child, such child
- 3 shall temporarily be placed in such custody.
- 4 (e) No child may be taken into custody under circumstances not
- 5 justified by this section or pursuant to section three of this
- 6 article without appropriate process. Any retention of a child or
- 7 order for retention of a child not complying with the time limits
- 8 and other requirements specified in this article is void by
- 9 operation of law.

### 10 §49-6-12. Improvement period in cases of child neglect or abuse

- 11 (a) A court may grant a respondent an improvement period of a
- 12 period not to exceed three months prior to making a finding that a

- 2 a report as to the respondents progress in the improvement period

# 1 \$49-6D-3. Family Unified child and family case plans for parents

- 2 of abused or neglected children.
- 3 (a) The Department of Health and Human Resources shall develop 4 a unified child and family case plan for every family wherein a 5 person has been referred to the department after being allowed an 6 improvement period or where the child is placed in foster care under 7 the provisions of section twelve, article six of this chapter. The 8 case plan must be filed within sixty days of the child coming into 9 foster care or within thirty days of the inception of the 10 improvement period, whichever occurs first. The department may also 11 prepare a family case plan for any person who voluntarily seeks 12 child abuse and neglect services from the department, or who is 13 referred to the department by another public agency or private 14 organization. The family case plan is to clearly set forth an 15 organized, realistic method of identifying family problems and the 16 <del>logical steps to be used in resolving or lessening those problems.</del> 17 The case plan provisions shall comply with federal law and the rules 18 of procedure for child abuse and neglect proceedings. Every family 19 case plan prepared by the department shall contain the following:
- 20 (1) A listing of specific, measurable, realistic goals to be
- 21 achieved;
- 22 (2) An arrangement of goals into an order of priority;
- 23 (3) A listing of the problems that will be addressed by each 24 qoal;

- 1 (4) A specific description of how the assigned caseworker or
- 2 caseworkers and the abusing parent, guardian or custodian will
- 3 <del>achieve each goal;</del>
- 4 (5) A description of the departmental and community resources
- 5 to be used in implementing the proposed actions and services;
- 6 (6) A list of the services, including time-limited
- 7 reunification services as defined in section three, article one of
- 8 this chapter, which will be provided;
- 9 (7) Time targets for the achievement of goals or portions of
- 10 <del>goals;</del>
- 11 (8) An assignment of tasks to the abusing or neglecting parent,
- 12 guardian or custodian, to the caseworker or caseworkers and to other
- 13 participants in the planning process;
- 14 (9) A designation of when and how often tasks will be
- 15 performed; and
- 16 (10) The safety of the placement of the child and plans for
- 17 returning the child safely home.
- 18 (b) In cases where the family has been referred to the

The family case plan may be modified from time to time by the 11 department to allow for flexibility in goal development, and in each 12 such case the modifications shall be submitted to the court in 13 writing. Reasonable efforts to place a child for adoption or with 14 a legal guardian may be made at the same time as reasonable efforts 15 are being made to prevent removal or to make it possible for a child 16 to return safely home. The court shall examine the proposed family 17 case plan or any modification thereof, and upon a finding by the 18 court that the plan or modified plan can be easily communicated, 19 explained and discussed so as to make the participants accountable 20 and able to understand the reasons for any success or failure under 21 the plan, the court shall inform the participants of the probable 22 action of the court if goals are met or not met.

(c) (1) In addition to the family case plan provided for under
the provisions of subsection (b) of this section, the department

- 1 shall prepare, as an appendix to the family case plan, an expanded
- 2 "worker's case plan". As utilized by the department under the
- 3 provisions of this section, the worker's case plan shall consist of
- 4 the following:
- 5 (A) All of the information contained in the family case plan

- 7 (B) A prognosis for each of the goals projected in the family
- 8 case plan, assessing the capacity of the parent, guardian or

- 12 medicine, law, education, social work and other relevant fields who

- 7 (4) For other innovative programs and projects that show 8 promise of successfully identifying, preventing or remedying the 9 causes of child abuse and neglect, including, but not limited to, 10 programs and services designed to improve and maintain parenting 11 skills, programs and projects for parent self-help, and for 12 prevention and treatment of drug-related child abuse and neglect; 13 and
- 14 (5) Assisting public agencies or nonprofit private
  15 organizations or combinations thereof in making applications for
  16 grants from, or in entering into contracts with, the secretary of
  17 the federal department of health and human services for
  18 demonstration programs and projects designed to identify, prevent
  19 and treat child abuse and neglect.
- (e) (d) Agencies, organizations and programs funded to carry out the purposes of this section shall be structured so as to comply with any applicable federal law, any regulation of the federal department of health and human services or the secretary thereof, and any final comprehensive plan of the federal advisory board on

- 1 child abuse and neglect. In funding organizations, the department
- 2 shall, to the extent feasible, ensure that parental organizations
- 3 combating child abuse and neglect receive preferential treatment.

## 5 §49-7-1. Confidentiality of records

- 6 (a) Except as otherwise provided in this chapter or by order
- 7 of the court, all records and information concerning a child or

- 18 (1) Where otherwise authorized by this chapter;
- 19 (2) To:
- 20 (A) The child;
- 21 (B) A parent whose parental rights have not been terminated;
- 22 or
- 23 (C) The attorney of the child or parent;
- 24 (3) With the written consent of the child or of someone

1 authorized to act on the child's behalf; or

- 2 (4) Pursuant to an order of a court of record: *Provided*, That
  3 the court shall review such record or records for relevancy and
  4 materiality to the issues in the proceeding <u>and safety</u>, and may
  5 issue an order to limit the examination and use of the records or
  6 any part thereof.
- 7 (c) In addition to those persons or entities to whom 8 information may be disclosed under subsection (b) of this section, 9 information related to child abuse or neglect proceedings, except 10 information relating to the identity of the person reporting or 11 making a complaint of child abuse or neglect, shall be made 12 available, upon request, to:
- 13 (1) Federal, state or local government entities, or any agent 14 of such entities, including law-enforcement agencies and prosecuting 15 attorneys, having a need for such information in order to carry out 16 its responsibilities under law to protect children from abuse and 17 neglect;
- 18 (2) The child fatality review team;
- 19 (3) Child abuse citizen review panels;
- 20 (4) Multidisciplinary investigative and treatment teams; or
- 21 (5) A grand jury, circuit court or family <del>law master</del> court, 22 upon a finding that information in the records is necessary for the
- 23 determination of an issue before the grand jury, circuit court or
- 24 family <del>law master</del> court.

- (d) In the event of a child fatality or near fatality due to child abuse and neglect, information relating to such fatality or near fatality shall be made public by the Department of Health and Human Resources and to the entities described in subsection © of this section, all under the circumstances described in that subsection: Provided, That information released by the Department of Health and Human Resources pursuant to this subsection shall not include the identity of a person reporting or making a complaint of child abuse or neglect. For purposes of this subsection, "near fatality" means any medical condition of the child which is certified by the attending physician to be life-threatening.
- (e) Except in juvenile proceedings which are transferred to criminal proceedings, law-enforcement records and files concerning a child or juvenile shall be kept separate from the records and files of adults and not included within the court files. Law- enforcement records and files concerning a child or juvenile shall only be open to inspection pursuant to the provisions of sections seventeen and eighteen, article five of this chapter.
- (f) Any person who willfully violates the provisions of this 20 section is guilty of a misdemeanor and, upon conviction thereof, 21 shall be fined not more than one thousand dollars, or confined in 22 the county or regional jail for not more than six months, or be both 23 fined and confined. A person convicted of violating the provisions 24 of this section shall also be liable for damages in the amount of

- 1 \$300 or actual damages, whichever is greater.
- 2 (g) Notwithstanding the provisions of this section, or any
- 3 other provision of this code to the contrary, the name and identity
- 4 of any juvenile adjudicated or convicted of a violent or felonious
- 5 crime shall be made available to the public.

### 6 §49-7-36. Quarterly status review and yearly permanency hearings.

- 7 (a) For each child who remains in foster care as a result of
- 8 a juvenile proceeding or as a result of a child abuse and neglect
- 9 proceeding, the circuit court with the assistance of the
- 10 multidisciplinary treatment team shall conduct quarterly status
- 11 reviews in order to determine the safety of the child, the
- 12 continuing necessity for and appropriateness of the placement, the
- 13 extent of compliance with the case plan, and the extent of progress
- 14 which has been made toward alleviating or mitigating the causes
- 15 necessitating placement in foster care, and to project a likely date
- 16 by which the child may be returned to and safety maintained in the
- 17 home or placed for adoption or legal quardianship.
- 18 (b) For each transitioning adult as that term is defined in
- 19 §49-2B-2(x) who remains in foster care, the circuit court shall
- 20 conduct status review hearings as described in subsection (a) of
- 21 this section once every three months until permanency is achieved.
- (c) For each child or transitioning adult who continues to
- 23 remain in foster care, the circuit court shall conduct a permanency
- 24 hearing no later that twelve months after the date the child or

- 1 transitioning adult is considered to have entered foster care, and
- 2 at least once every twelve months thereafter until permanency is
- 3 achieved. For purposes of permanency planning for transitioning
- 4 adults, the circuit court shall make factual findings and
- 5 conclusions of law as to whether the department made reasonable
- 6 efforts to finalize a permanency plan to prepare a transitioning
- 7 adult for emancipation or independence or another approved
- 8 permanency option such as, but not limited to, adoption or legal
- 9 guardianship pursuant to the West Virginia Guardianship and
- 10 Conservatorship Act.
- 11 (d) Nothing in this section shall be construed to abrogate the
- 12 responsibilities of the circuit court from conducting required
- 13 hearings as provided in other provisions of this code, procedural
- 14 court rules, or setting required hearings at the same time.

NOTE: This bill is requested by the Supreme Court of Appeal's Court Improvement Program Oversight Board. The purpose of this legislation is to promote the safety, well-being and timely permanency of children in child abuse and neglect, family court and/or juvenile cases. This bill also makes necessary amendments to the West Virginia code for compliance with federal law or consistency with the West Virginia Rules of Procedure for Child Abuse and Neglect Proceedings or the Rules of Juvenile Procedure. This bill defines "court appointed special advocate program" and outlines the standards for the program. The bill also requires judges to provide in the court order the reasons why a child is being placed out-of-state as opposed to in-state. The bill clarifies the multidisciplinary treatment planning process for everyone and establishes a process specific to child abuse and neglect cases as well as status offenders and delinquents. The bill also requires attorneys appointed in child abuse and neglect cases to have eight hours of training annually. This bill provides that

reasonable efforts to preserve the family is not required when the person is required by law to register as a sex offender. It also provides when a dispositional order may be modified. The bill clarifies that the circuit court has exclusive jurisdiction over child abuse and neglect matters. The bill provides a process for permanency hearings and permanent placement reviews. The bill authorizes family court to order a child be taken into emergency custody under certain circumstances. The bill also provides guidelines for unified child and family case plans and requires quarterly status review hearings and yearly permanency hearings for transitioning adults.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.

\$49-5d-3b, \$49-5D-3c, \$49-6-9a and \$49-7-36 are new; therefore, they have been completely underscored.
