L O	A BILL to amend and reenact $\$17B-2B-5$ and $\$17B-2B-7$ of the Code of
L1	West Virginia, 1931, as amended, all relating to license to

L 9	Be it enacted by the Legislature of West Virginia:

1 §17B-2B-5. Restrictions on Class G driver's license; removal of

- daytime driving restriction; waiver.
- 3 (a) A Class G driver's license authorizes the licensee to 4 operate a Class A passenger motor vehicle, weighing eight thousand
- 5 pounds or less, subject to the following restrictions:
- 6 (1) The applicant may drive only while using a bioptic 7 telescopic device;
- 8 (2) Daytime driving restriction; and
- 9 (3) Any other conditions or restrictions the commissioner 10 considers necessary to insure the safe operation of the motor 11 vehicle.
- 12 (b) An applicant to whom a Class G driver's license has been 13 issued may apply to the commissioner for removal of the daytime 14 driving restriction if the applicant has:
- 15 (1) Operated a motor vehicle for thirty-six months without an 16 at-fault accident, moving violation or license suspension;
- (2) Submitted a report of a vision examination, conducted not 18 more than six months prior to the application, by a vision 19 specialist showing that the licensee's visual impairment is stable 20 and that he or she can see well enough to operate a vehicle at 21 night;
- (3) Successfully completed additional evaluation and training,
 23 in an approved driver training program, specifically designed for
 24 night driving;

- 1 (4) Passed a comprehensive night driving examination.
- 2 (c) Waiver: If upon admission to the program a Class G
- 3 applicant presents a valid Class E driver's license and proof to
- 4 the commissioner of a stable vision condition and no at-fault
- 5 accidents and no moving violations for the past three years, the
- 6 applicant shall be permitted to participate in an individualized,
- 7 competency-based program of instruction that will also include
- 8 ancillary classroom, passenger-in-car and behind-the-wheel
- 9 instruction and applicable road testing dealing with and requiring
- 10 passage of night driving practices, prior to issuance of Class G
- 11 driver licensure without daytime only driving restriction.
- 12 §17B-2B-7. Renewal of license.
- 13 (a) A Class G driver's license is valid for no more than two 14 years.
- 15 (b) To renew a Class G driver's license, the licensee must
- 16 submit a report of a comprehensive vision examination by a vision
- 17 specialist at least ninety-days prior to expiration of the license
- 18 unless an identical report has already been submitted to the
- 19 commissioner by a vision specialist on the same licensee within the
- 20 past twelve months as part of the requirement for annual
- 21 anniversary of driver licensure under the provisions of section
- 22 four(d) of this article.
- 23 (c) If the vision specialist certifies that the conditions
- 24 causing the licensee's visual impairment are stable, and the

- 1 licensee continues to satisfy the commissioner's minimum visual
- 2 acuity and visual field standards for licensure, the division shall
- 3 may renew the license for a period of one year longer than
- 4 initially granted, up to a maximum of five years.
- 5 (d) If the vision specialist certifies that the conditions
- 6 causing the licensee's visual impairment are unstable or
- 7 deteriorating, the commissioner may require the licensee to undergo
- 8 additional testing or training before deciding whether to renew the
- 9 license.
- 10 (e) If any comprehensive vision examination by a vision
- 11 specialist determines that the licensee no longer satisfies the
- 12 minimum visual acuity or visual field standards for licensure, the
- 13 division shall not renew the license.

NOTE: The purpose of this bill is to provide that renewal of a Class G license to operate a motor vehicle with bioptic telescope device vision report requirement may be waived when a report has already been submitted to the commissioner by a vision specialist on the same licensee within the past twelve months as part of the requirement for annual anniversary of driver licensure. It also provides that the renewal period may then be extended.
