- 4 That §31-17-11 of the Code of West Virginia, 1931, as amended,

- 8 §31-17-11. Records and reports; examination of records; analysis.
- 9 (a) Every lender and broker licensee shall maintain at his or
  10 her place of business in this state, if any, or if he or she has no
  11 place of business in this state, at his or her principal place of
  12 business outside this state, such books, accounts and records
  13 relating to all transactions within this article as are necessary
  14 to enable the commissioner to enforce the provisions of this
  15 article. All the books, accounts and records shall be preserved,
  16 exhibited to the commissioner and kept available as provided herein
  17 for the reasonable period of time as the commissioner may by rules
  18 require. The commissioner is hereby authorized to prescribe by
  19 rules the minimum information to be shown in the books, accounts
- 21 (b) Each licensee shall file with the commissioner a report
- 22 through the Nationwide Mortgage Licensing System and Registry under
- 23 oath or affirmation concerning his or her business and operations

1 in this state for the preceding license year upon participation in 2 <u>defined reporting period established by</u> the Nationwide Mortgage 3 Licensing System and Registry and on a date established by the 4 Nationwide Mortgage Licensing System and Registry. For license 5 years 2008 and 2009, all licensees shall submit an annual report to 6 the Division of Banking on or before March 15, 2009, and March 15, 7 2010, respectively, on a form prescribed by the commissioner. 8 These reports are not public records and may not be open to public 9 inspection. The commissioner may direct that the reports required 10 by this subsection be filed directly with the Division of Banking. 11 (c) The commissioner may, at his or her discretion, make or 12 cause to be made an examination of the books, accounts and records 13 of every lender or broker licensee pertaining to primary and 14 subordinate mortgage loans made in this state under the provisions 15 of this article, for the purpose of determining whether each lender 16 and broker licensee is complying with the provisions hereof and for 17 the purpose of verifying each lender or broker licensee's annual 18 report. If the examination is made outside this state, the licensee 19 shall pay the cost thereof in like manner as applicants are 20 required to pay the cost of investigations outside this state. 21 (d) The commissioner shall publish annually a list of the 22 licenses issued under this chapter and shall direct consumers to 23 public information available through the Nationwide Mortgage

- 1 Licensing System and Registry. an aggregate analysis of the
- 2 information furnished in accordance with the provisions of
- 3 subsection (b) or (c) of this section, but the individual reports
- 4 are not public records and may not be open to public inspection.
- 5 (e) The commissioner may enter into cooperative and
- 6 information-sharing agreements with regulators in other states or
- 7 with federal authorities to discharge his or her responsibilities
- 8 under this article.

NOTE: The purpose of this bill is to require the electronic submission of reports relating to the business and operations of licensed mortgage lenders, brokers and servicers as established through the Nationwide Mortgage Licensing System and to release the Commissioner of Banking from the duty to publish an aggregate analysis of the information contained in said reports annually.
