10	A BILL to amend and reenact $\$6-7-2a$ of the Code of West Virginia,
11	1931, as amended, relating to the compensation of the
12	Secretary of the Department of Veterans' Assistance.
13	Be it enacted by the Legislature of West Virginia:
14	That $\$6-7-2a$ of the Code of West Virginia, 1931, as amended,
15	be amended and reenacted to read as follows:
16	ARTICLE 7. COMPENSATION AND ALLOWANCES.
17	§6-7-2a. Terms of certain appointive state officers; appointment;
18	qualifications; powers and salaries of such officers.
19	(a) Each of the following appointive state officers named in
20	this subsection shall be appointed by the Governor, by and with the
21	advice and consent of the Senate. Each of the appointive state
22	officers serves at the will and pleasure of the Governor for the
23	term for which the Governor was elected and until the respective

- 1 state officers' successors have been appointed and qualified. Each
- 2 of the appointive state officers are subject to the existing
- 3 qualifications for holding each respective office and each has and
- 4 is hereby granted all of the powers and authority and shall perform
- 5 all of the functions and services heretofore vested in and
- 6 performed by virtue of existing law respecting each office.
- 7 The annual salary of each named appointive state officer is as 8 follows:
- 9 Commissioner, Division of Highways, \$92,500; Commissioner,
- 10 Division of Corrections, \$80,000; Director, Division of Natural
- 11 Resources, \$75,000; Superintendent, State Police, \$85,000;
- 12 Commissioner, Division of Banking, \$75,000; Commissioner, Division

- 15 Vehicles, \$75,000; Chairman, Health Care Authority, \$80,000;

- 18 prior to July 1, 2011, Director, Division of Veterans Affairs,

 10 fiscal year beginning July 1, 2011, up to the maximum salary
 11 provided in this subsection: Provided further, That effective July
 12 1, 2012, the Secretary of the Department Veterans' Assistance shall
 13 be paid an annual salary of \$95,000.
- 14 (b) Each of the state officers named in this subsection shall 15 continue to be appointed in the manner prescribed in this code, and 16 shall be paid an annual salary as follows:
- Director, Board of Risk and Insurance Management, \$80,000;

(d) No increase in the salary of any appointive state officer pursuant to this section may be paid until and unless the appointive state officer has first filed with the State Auditor and the Legislative Auditor a sworn statement, on a form to be prescribed by the Attorney General, certifying that his or her spending unit is in compliance with any general law providing for a salary increase for his or her employees. The Attorney General shall prepare and distribute the form to the affected spending units.

NOTE: The purpose of this bill is to provide that the Secretary of the Department of Veterans' Assistance is paid the same salary as the secretaries of the other departments of state government.
