10	A BILL to amend and reenact §17C-13A-3 of the Code of West
11	Virginia, 1931, as amended, relating to Diesel-Powered Motor
12	Vehicle Idling Act; regulating the idling time of a diesel-
13	powered motor vehicle; exceptions; and extending the
14	expiration date of exemptions for occupied vehicles with
15	sleeper-berth compartments from May 1, 2012, to May 1, 2017.
16	Be it enacted by the Legislature of West Virginia:
17	That §17C-13A-3 of the Code of West Virginia, 1931, as
18	amended, be amended and reenacted to read as follows:
19	ARTICLE 13A. DIESEL-POWERED MOTOR VEHICLE IDLING ACT.
20	§17C-13A-3. Exceptions.
21	(a) The idling restrictions set forth in section two of this
22	article do not apply to motor homes, commercial implements of
23	husbandry, implements of husbandry or farm tractors.

24 (b) The idling restrictions set forth in section two of this

1 article do not apply to construction equipment that cannot be 2 licensed for on-road driving or construction equipment that is not 3 designed primarily for on-road driving, notwithstanding that such 4 equipment may be operated or driven on road from time to time and 5 in the course of performing its primary functions: *Provided*, That 6 idling is necessary to power work-related mechanical, safety or 7 electrical operations related to construction operations other than 8 propulsion.

9 (c) A diesel-powered motor vehicle with a gross weight of ten 10 thousand one pounds or more may idle beyond the time allowed in 11 subsection (a) for one or more of the following reasons:

12 (1) When a vehicle idles while forced to remain motionless 13 because of on-highway traffic, an official traffic control device 14 or signal or at the direction of a law-enforcement official.

15 (2) When a vehicle must idle to operate defrosters, heaters, 16 air conditioners or cargo refrigeration equipment, or to install 17 equipment, in order to prevent a safety or health emergency, and 18 not for the purpose of a rest period, or as otherwise necessary to 19 comply with manufacturers' operating requirements, specifications 20 and warranties in accordance with federal or state motor carrier 21 safety regulations or local requirements.

(3) When a police, fire, ambulance, public safety, military, utility service vehicle or other emergency or law-enforcement vehicle or any vehicle being used in an emergency or public safety

1 capacity shall idle while in an emergency or training mode and not 2 for the convenience of the driver.

3 (4) When the primary propulsion engine idles for maintenance, 4 particulate matter trap regeneration, servicing or repair of the 5 vehicle, or for vehicle diagnostic purposes, if idling is required 6 for that activity.

7 (5) When a vehicle idles as part of a federal or state
8 inspection to verify that all equipment is in good working order,
9 if idling is required as part of the inspection.

10 (6) When idling of a primary propulsion engine is necessary to 11 power work-related mechanical, safety or electrical operations 12 other than propulsion. This exemption does not apply when idling 13 is done for cabin comfort or to operate nonessential onboard 14 equipment.

15 (7) When idling of a primary propulsion engine is necessary as 16 part of a security inspection either entering or exiting a 17 facility.

18 (8) When an armored vehicle must idle when a person remains 19 inside the vehicle to guard contents or while the vehicle is being 20 loaded or unloaded.

(9) When a vehicle must idle due to mechanical difficulties ver which the driver has no control, if the vehicle owner submits the repair paperwork or product repair verifying that the mechanical problem has been fixed, by mail to the commission within

1 thirty days of the repair.

2 (10) When a bus or school bus must idle to provide heating or 3 air conditioning when nondriver passengers are onboard. For the 4 purposes of this exemption, the bus or school bus may idle for no 5 more than a total of fifteen minutes in a continuous sixty-minute 6 period, except when idling is necessary to maintain a safe 7 temperature for bus passengers.

8 (11) An occupied vehicle with a sleeper-berth compartment that 9 idles for purposes of air conditioning or heating during a rest or 10 sleep period and the outside temperature at the location of the 11 vehicle is less than forty degrees or greater than seventy-five 12 degrees Fahrenheit at any time during the rest or sleep period. 13 This applies to a motor vehicle subject to this article parked in 14 any place that the vehicle is legally permitted to park, including, 15 but not limited to, a fleet trucking terminal, commercial truck 16 stop or designed rest area. This exemption expires May 1, 2012 17 <u>2017</u>. This exemption does not apply if the vehicle is parked at a 18 location equipped with stationary idle reduction technology that is 19 available for use at the start of the rest period.

20 (12) When idling is necessary for sampling, weighing, active 21 loading or active unloading or for an attended motor vehicle 22 waiting for sampling, weighing, loading or unloading. For the 23 purposes of this exemption, the vehicle may idle for up to a total 24 of fifteen minutes in any continuous sixty-minute period.

1 (13) When idling by a school bus off school grounds during 2 queuing for the sequential discharge or pickup of students is 3 necessary because the physical configuration of a school or the 4 school's surrounding streets does not allow for stopping.

5 (14) When idling is necessary for maintaining safe operating 6 conditions while waiting for a police escort when transporting a 7 load that requires the issuance of a permit in accordance with 8 section eleven, article seventeen of this chapter.

9 (15) When actively engaged in solid waste collection or the 10 collection of source-separated recyclable materials. This 11 exemption does not apply when a vehicle is not actively engaged in 12 solid waste collection or the collection of source-separated 13 recyclable materials.

14 (16) When a diesel-powered motor vehicle exhibits a label 15 issued by the California Air Resources Board under 13 CCR 16 §1956.8(a)(6)(C) (relating to exhaust emissions standards and test 17 procedures - 1985 and subsequent model heavy-duty engines and 18 vehicles) showing that the vehicle's engine meets the optional NOx 19 idling emission standard.

(17) When a diesel-powered motor vehicle is powered by clean21 diesel technology or bio-diesel fuels.

(NOTE: The purpose of this bill is relating to extend the

expiration date of exemptions for occupied vehicles with sleeperberth compartments from May 1, 2012 to May 1, 2017, in the Diesel-Powered Motor Vehicle Idling Act which regulates the idling time of a diesel-powered motor vehicle, subject to certain exceptions.
