14 *Be it enacted by the Legislature of West Virginia:*

15 **CLAIMS AGAINST THE STATE.**

16 **§1. Finding and declaring certain claims against the Board of Coal**
17 **Mine Health and Safety; Department of Administration/Office**
18 **of Technology; Department of Education; Division of**
19 **Corrections; Division of Highways; Division of Tourism;**
20 **Insurance Commission; Regional Jail Authority; State Fire**
21 **Marshal; Tax Department and West Virginia State Senate to**
22 **be moral obligations of the state and directing payment**
23 **thereof.**

1 The Legislature has considered the findings of fact and
2 recommendations reported to it by the Court of Claims concerning
3 various claims against the state and agencies thereof and in
4 respect to each of the following claims, the Legislature adopts
5 those findings of fact as its own and in respect of certain claims
6 herein, the Legislature has independently made findings of fact and
7 determinations of award and hereby declares it to be the moral
8 obligation of the state to pay each such claim in the amount
9 specified below and directs the Auditor to issue warrants for the

2 The Legislature finds that the above moral obligations and the
3 appropriations made in satisfaction thereof shall be the full
4 compensation for all claimants and that prior to the payments to
5 any claimant provided in this bill, the Court of Claims shall
6 receive a release from said claimant releasing any and all claims
7 for moral obligations arising from the matters considered by the
8 Legislature in the finding of the moral obligations and the making
9 of the appropriations for said claimant. The Court of Claims shall
10 deliver all releases obtained from claimants to the department
11 against which the claim was allowed.

NOTE: The purpose of this bill is for the Legislature to find and declare the existence of a moral obligation to pay, with public moneys, each of the claims herein against specified state agencies and the State of West Virginia, by the named claimants, payable from the specified funds, and in the amounts of the awards made.

A second and separate bill (either supplementary appropriation bill or a section of the budget bill) will actually appropriate the moneys herein awarded and permit payment in current fiscal year 2012 and through 2013.

The totals, as to type of funds and amounts of awards in the bill, are:

- (1) General Revenue Funds of \$6,057,142.34
- (2) Special Revenue Funds of \$366,854.40
- (3) State Road Funds of \$2,092,001.45
