

# Adopted by House 4-12-2013

SB527 H JUD AM 4-10 #1

The Judiciary Committee moves to amend the bill on page three, following the enacting clause, by striking out the remainder of the bill and inserting in lieu thereof, the following language:

1 That §3-10-4a of the Code of West Virginia, 1931, as amended,  
2 be repealed; and that §3-10-1, §3-10-2, §3-10-3, §3-10-3a, §3-10-4,  
3 §3-10-5, §3-10-6, §3-10-7 and §3-10-8 of said code be amended and  
4 reenacted; and that said code be amended by adding thereto a new  
5 section, designated §3-10-9, all to read as follows:

6 **ARTICLE 10. FILLING VACANCIES.**

7 **§3-10-1. Elections to fill vacancies.**

8 ~~Except as provided in sections three and four of this article,~~  
9 ~~elections to fill vacancies shall be conducted to fill any~~  
10 ~~unexpired term when more than one year of the term of office~~  
11 ~~remains at the time of such election. When less than one year of~~  
12 ~~the term of office remains at the time of the election, the person~~  
13 ~~appointed to fill the vacancy shall continue in office until the~~  
14 ~~completion of the term.~~

15 (a) When a vacancy occurs in an elected office of the state or  
16 county, it shall be filled according to the processes set forth in  
17 this article. As used in this article, unless otherwise indicated  
18 by the context:

1       (1) "General cutoff date" means the eighty-fourth day before  
2 the general election that immediately precedes the general election  
3 where the office would be on the ballot for election if there were  
4 not a vacancy; and

5       (2) "Primary cutoff date" means the eighty-fourth day before  
6 the primary election that immediately precedes the general cutoff  
7 date.

8       (b) When this article requires an appointment to fill a  
9 vacancy in an elected office, the appointment shall be made within  
10 thirty days of the vacancy, unless this code specifically states a  
11 different time period for the specific office. The term that the  
12 appointee holds the office shall depend on when the vacancy occurs,  
13 as follows:

14       (1) If the vacancy occurs after the primary cutoff date, then  
15 that appointee shall hold the office until the end of the term of  
16 office: *Provided*, That if the vacancy for any county office or  
17 United States Senate occurs during the window after the primary  
18 cutoff date, but before the general cutoff date, the process  
19 contained in sections four, six, seven and eight of this article,  
20 depending on the specific office vacated, shall be followed; or

21       (2) If the vacancy occurs on or before the primary cutoff  
22 date, then the office shall be filled at the following regular  
23 primary and subsequent general election pursuant to this article  
24 and the appointee shall hold the office until a qualified

1 replacement is elected and certified at that general election. The  
2 elected replacement shall hold the office until the end of the  
3 original term of office.

4 (c) If an election is required to fill the vacancy by  
5 subsection (b) of this section and the other provisions of this  
6 article, the election shall proceed depending on when the vacancy  
7 occurs and in which office it occurs. Elections to fill vacancies  
8 shall be held at the same places, and superintended, conducted and  
9 returned, and the result ascertained, certified and declared, in  
10 the same manner, and by the same officers, as in general elections,  
11 unless otherwise stated in this article.

12 (1) For a vacancy in the Office of Governor, the times for the  
13 special elections contained in section two of this article shall  
14 control. The proclamation entered pursuant to section two of this  
15 article by the person acting as Governor, shall include the dates  
16 for the special candidate filing period, if necessary, and shall  
17 follow the requirements set forth in this section. All aspects of  
18 this section, where not in conflict with section two of this  
19 article, shall also be followed. If a regularly scheduled primary  
20 or general election fits within the times for the special elections  
21 contained in section two of this article, the special elections  
22 shall be conducted in conjunction with the regularly scheduled  
23 election or elections. If an special election is required by  
24 section two of this article and it cannot be held in conjunction

1 with the regular election dates, then the compensation of election  
2 officers shall be reimbursed pursuant to section nine of this  
3 article.

4 (2) For a vacancy in the offices of United States House of  
5 Representatives or United States Senate, the times for the special  
6 election, if necessary, contained in section four of this article  
7 shall control. All aspects of this section, where not in conflict  
8 with section four of this article, shall also be followed.

9 (A) With regard to United States House of Representatives, the  
10 proclamation entered pursuant to section four of this article by  
11 the Governor, shall include the dates for the special candidate  
12 filing period, if necessary, and shall follow the requirements set  
13 forth in this section. If a regularly scheduled primary or general  
14 election fits within the times for the special elections contained  
15 in section four of this article, the special elections shall be  
16 conducted in conjunction with the regularly scheduled election or  
17 elections. If an special election is required by section two of  
18 this article and it cannot be held in conjunction with the regular  
19 election dates, then the compensation of election officers shall be  
20 reimbursed pursuant to section nine of this article.

21 (B) With regard to United States Senate, if a special general  
22 election following the regular general election is required by  
23 section four of this article, and it cannot be held in conjunction  
24 with the regular election dates, then the compensation of election

1 officers shall be reimbursed pursuant to section nine of this  
2 article.

3 (3) For all other offices, the Governor, or other person  
4 granted authority by this article, shall issue a proclamation  
5 stating that the office will appear on the next regular primary  
6 election and subsequent general election, in order to fill the  
7 vacancy: Provided, That if the vacancy for any county office  
8 occurs during the window after the primary cutoff date, but before  
9 the general cutoff date, the process contained in sections six,  
10 seven and eight of this article shall be followed. If the  
11 candidate filing period for the next regular primary election has  
12 closed or has less than one week remaining, the proclamation shall  
13 provide for a special primary candidate filing period. If there  
14 are less than eighty-four days between the vacancy and the next  
15 regular primary election, then the proclamation shall state that  
16 the office will appear on the subsequent regular primary election  
17 and corresponding general election following the next regular  
18 primary election.

19 (d) (1) If a special candidate filing period is necessary, it  
20 shall begin no sooner than the day after the proclamation and shall  
21 close no earlier than close of business on the fourteenth day  
22 following the proclamation. A notarized declaration of candidacy  
23 and filing fee provided by section seven, article five of this  
24 chapter, shall be filed either in person, by United States mail,

1 electronic means or any other means authorized by the Secretary of  
2 State and received by the appropriate office before the close of  
3 the filing period. For petition in lieu of payment of filing fees,  
4 a candidate seeking nomination for the vacancy may utilize the  
5 process set forth in section eight-a, article five of this chapter:  
6 Provided, That the minimum number of signatures required is  
7 equivalent to one qualified signature per one whole dollar of the  
8 filing fee for that office.

9 (2) If a primary election is required by the provisions of  
10 this article:

11 (A) For all statewide, multicounty and legislative elections,  
12 drawing for the primary election ballot position will take place at  
13 the Secretary of State's office twenty-four hours after the end of  
14 the filing period. For each major political party on the ballot, a  
15 single drawing by lot shall determine the candidate ballot position  
16 for ballots statewide. This drawing shall be witnessed by four  
17 clerks of the county commission chosen by the West Virginia  
18 Association of County Clerks, with no more than two clerks  
19 representing a single political party.

20 (B) For county elections, drawing for the primary election  
21 ballot position will take place at the county clerk's office  
22 twenty-four hours after the end of the filing period. For each  
23 major political party on the ballot, a single drawing by lot shall  
24 determine the candidate ballot position for ballots statewide.

1 This drawing shall be witnessed by the chairperson of the county  
2 democratic and republican executive committees or their designee,  
3 and the president of the county commission or his or her designee.

4 (3) Ballot position for a general election required by this  
5 article shall be determined pursuant to subdivision (3), subsection  
6 (c), section two, article six of this chapter. If a general  
7 election required by this article occurs in conjunction with a  
8 regularly scheduled primary election, the general election shall be  
9 listed along with the nonpartisan portion of each ballot in the  
10 order of offices provided for regular ballots in this chapter.

11 (e) When an election is required to fill a vacancy, the date  
12 of the election and offices to be elected, as well as any other  
13 information required in the proclamation, shall be published prior  
14 to such election as a Class I-0 legal advertisement in compliance  
15 with the provisions of article three, chapter fifty-nine of this  
16 code, and the publication area for such publication shall be each  
17 county of the state that is eligible to vote in the election for  
18 those offices.

19 (f) If an election is required by this article, the Secretary  
20 of State may issue emergency administrative orders to undertake  
21 other ministerial actions that are otherwise authorized pursuant to  
22 this code when necessary to assure the preservation of the voting  
23 rights of the citizens of this state and avoid fraudulent voting  
24 and election activities and otherwise assure the orderly and

1 efficient conduct of the new election provided in this subsection:  
2 Provided, That emergency administrative orders may not contravene  
3 the provisions of this article.

4 (g) If an election is required by this article, citizens  
5 having no party organization or affiliation may nominate candidates  
6 as provided by sections twenty-three and twenty-four of article  
7 five of this chapter: Provided, That when a election is required by  
8 the provisions of this article to be held at some time other than  
9 with a regularly scheduled election, all certificates nominating  
10 candidates shall be filed with the appropriate official no later  
11 than 90 days before the election.

12 (h) The persons elected, having first duly qualified, shall enter  
13 upon the duties of their respective offices. The elected  
14 replacement shall hold the office until the end of the original  
15 term of office.

16 **§3-10-2. Vacancy in Office of Governor.**

17 (a) In case of the death, conviction on impeachment, failure  
18 to qualify, resignation or other disability of the Governor, the  
19 President of the Senate shall act as Governor until the vacancy is  
20 filled or the disability removed; and if the President of the  
21 Senate, for any of the above-named causes, shall be or become  
22 incapable of performing the duties of Governor, the same shall  
23 devolve upon the Speaker of the House of Delegates; and in all  
24 other cases where there is no one to act as Governor, one shall be

1 chosen by the joint vote of the Legislature. Whenever a vacancy  
2 shall occur in the Office of Governor before the first three years  
3 of the term shall have expired, a new election for Governor shall  
4 take place to fill the vacancy.

5 (b) The new election shall consist of a special primary  
6 election and a special general election, and shall occur at such  
7 time as will permit the person elected as Governor in the new  
8 election to assume office within one year of the date the vacancy  
9 occurred: *Provided*, That the special general election provided in  
10 this section may not apply to section eight, article one of this  
11 chapter. Within thirty days from the date the vacancy occurs, the  
12 person acting as Governor pursuant to the State Constitution shall  
13 issue a proclamation fixing the time for a ~~new~~ statewide election  
14 to fill the vacancy in the Office of Governor. ~~which shall be~~  
15 ~~published prior to such election as a Class II-O legal~~  
16 ~~advertisement in compliance with the provisions of article three,~~  
17 ~~chapter fifty-nine of this code, and the publication area for such~~  
18 ~~publication shall be each county of the state. The proclamation~~  
19 ~~issued by the person acting as Governor pursuant to the state~~  
20 ~~Constitution shall provide for a special primary election to~~  
21 ~~nominate candidates for the special general election. The special~~  
22 primary election to fill a vacancy in the Office of Governor shall  
23 take place no less than ninety days after the proclamation and no  
24 later than one hundred forty days from the date that the vacancy in

1 the office occurs. The proclamation issued by the person acting as  
2 Governor pursuant to the State Constitution shall also provide for  
3 a special general election to take place no sooner than ninety days  
4 after the special primary election and no later than two hundred  
5 eighty days from the date that the vacancy in the office occurs.

6 ~~(b) The compensation of election officers, cost of printing~~  
7 ~~ballots and all other reasonable and necessary expenses in holding~~  
8 ~~and making the return of the new election provided in this section~~  
9 ~~to fill a vacancy in the office of Governor are obligations of the~~  
10 ~~state incurred by the ballot commissioners, clerks of the county~~  
11 ~~commissions and county commissions of the various counties as~~  
12 ~~agents of the state. All expenses of the new election are to be~~  
13 ~~audited by the Secretary of State. The Secretary of State shall~~  
14 ~~prepare and transmit to the county commissions forms on which the~~  
15 ~~county commissions shall certify all expenses of the new election~~  
16 ~~provided in this section to the Secretary of State. If satisfied~~  
17 ~~that the expenses as certified by the county commissions are~~  
18 ~~reasonable and were necessarily incurred, the Secretary of State~~  
19 ~~shall requisition the necessary warrants from the Auditor of the~~  
20 ~~state to be drawn on the State Treasurer and shall mail the~~  
21 ~~warrants directly to the vendors of the new election services,~~  
22 ~~supplies and facilities.~~

23 ~~(c) Notwithstanding the provisions of subsection (a) of this~~  
24 ~~section to the contrary, for purposes of filling the vacancy that~~

1 ~~occurred in the office of Governor on November 15, 2010, a new~~  
2 ~~election shall occur as follows:~~

3 ~~(1) Upon the effective date of this subsection, the person~~  
4 ~~acting as Governor pursuant to the state Constitution shall~~  
5 ~~immediately issue a proclamation calling for a special primary and~~  
6 ~~general election as provided for in this subsection. For purposes~~  
7 ~~of this subsection, the new elections so provided in the~~  
8 ~~proclamation mean the special primary and general elections as set~~  
9 ~~forth in this subsection.~~

10 ~~(2) The special primary election shall be held on May 14, 2011~~  
11 ~~and the special general election shall be held on October 4, 2011.~~

12 ~~(3) The proclamation for the special primary election and~~  
13 ~~special general election shall be published prior to the special~~  
14 ~~primary election and special general elections, respectively, as a~~  
15 ~~Class II-0 legal advertisement in accordance with article three,~~  
16 ~~chapter fifty-nine of this code and the publication area for the~~  
17 ~~publication is each county of the state. The notice shall be filed~~  
18 ~~with the Secretary of State who shall cause the document to be~~  
19 ~~published within each county in accordance with this section.~~

20 ~~(4) The provisions of this chapter apply to the special primary~~  
21 ~~election and special general election to the extent that those~~  
22 ~~provisions are consistent with the provisions of this section.~~  
23 ~~Statutory time deadlines for the purpose of the new election~~  
24 ~~provided in this subsection are modified as follows:~~

1       ~~(A) A notarized declaration of candidacy and filing fee shall~~  
2 ~~be filed and received in hand by the Secretary of State by 5:00 p.m.~~  
3 ~~on the fifth calendar day following the proclamation of the special~~  
4 ~~primary election. The declaration of candidacy may be filed in~~  
5 ~~person, by United States mail, electronic means or any other means~~  
6 ~~authorized by the Secretary of State;~~

7       ~~(B) The Secretary of State may issue emergency administrative~~  
8 ~~orders to undertake other ministerial actions that are otherwise~~

14 ~~not contravene the provisions of this section;~~

15       ~~(C) For petition in lieu of payment of filing fees, a candidate~~  
16 ~~seeking nomination for the vacancy in the office of Governor may~~  
17 ~~utilize the process set forth in section eight a, article five of~~  
18 ~~this chapter: *Provided*, That the minimum number of signatures~~  
19 ~~required is one thousand five hundred;~~

20       ~~(D) Drawing for special primary election ballot position will~~  
21 ~~take place at the Secretary of State's office twenty-four hours~~  
22 ~~after the end of the filing period. For each major political party~~  
23 ~~on the ballot, a single drawing by lot shall determine the candidate~~  
24 ~~ballot position for ballots statewide. This drawing shall be~~

1 ~~witnessed by four clerks of the county commission chosen by the West~~  
2 ~~Virginia Association of County Clerks, with no more than two clerks~~  
3 ~~representing a single political party. Ballot position for the~~  
4 ~~special general election shall be determined pursuant to subdivision~~  
5 ~~(3), subsection (c), section two, article six of this chapter;~~

6 ~~(E) A registered voter who has not reached eighteen years of~~  
7 ~~age may vote in the May 14, 2011 special primary election:~~  
8 ~~Provided, That the voter will attain eighteen years of age at the~~  
9 ~~time of the special general election provided in this subsection;~~

10 ~~(F) When paper or optical scan ballots are the primary voting~~  
11 ~~method used at any county, the total number of regular official~~  
12 ~~ballots printed shall equal at a minimum fifty percent of the number~~  
13 ~~of registered voters eligible to vote that ballot;~~

14 ~~(G) When paper ballots are used in conjunction with a direct~~  
15 ~~recording electronic voting system, the total number of regular~~  
16 ~~official ballots printed shall equal at a minimum thirty percent of~~  
17 ~~the registered voters eligible to vote that ballot;~~

18 ~~(H) Regularly scheduled locations of polling places may not be~~  
19 ~~changed, except for situations as provided in sections seven e and~~  
20 ~~seven f, article one of this chapter: Provided, That if multiple~~  
21 ~~precincts voted in one polling location for the November 2, 2010,~~  
22 ~~regularly scheduled general election, these precincts may be~~  
23 ~~consolidated into a single precinct. Locations for consolidated~~  
24 ~~precincts shall provide Internet access, insofar as possible, for~~

1 ~~the sole purpose of utilizing the statewide Voter Registration~~  
2 ~~System (SVRS) as an electronic poll book. However, Constitutionally~~  
3 ~~mandated redistricting may not take effect until the special primary~~  
4 ~~election and special general election provided in this subsection~~  
5 ~~are complete; and~~

6 ~~(I) Citizens having no party organization or affiliation may~~  
7 ~~nominate candidates as provided by sections twenty three and twenty~~  
8 ~~four of article five of this chapter: *Provided, That* the number of~~  
9 ~~signatures required to be submitted shall be equal to not less than~~  
10 ~~one quarter of one percent of the entire vote cast at the last~~  
11 ~~preceding general election for Governor. Notwithstanding the~~  
12 ~~provisions of sections twenty three and twenty four of article five~~  
13 ~~of this chapter, the signatures, notarized declaration of candidacy,~~  
14 ~~and filing fee must be submitted no later than seven calendar days~~  
15 ~~following the special primary election provided in this subsection.~~

16 ~~(J) For the special primary election to be held pursuant to~~  
17 ~~this subsection, early voting will also be conducted from 9 a.m. to~~  
18 ~~5 p.m. on the Saturday immediately prior to the end of early voting.~~

19 ~~(5) The provisions of this subsection shall expire upon the~~  
20 ~~election and qualification of the Governor following the October 4,~~  
21 ~~2011 special general election.~~

22 ~~(d) The Secretary of State shall by January 10, 2012 report to~~  
23 ~~the Joint Committee on Government and Finance findings regarding of~~  
24 ~~the operation of the new election undertaken pursuant to subsection~~

1 ~~(c) of this section. This report shall provide analysis of the~~  
2 ~~direct and indirect costs to the state associated with the conduct~~  
3 ~~of the new election.~~

4 (c) The election shall follow the requirements of section one  
5 of this article that are not in conflict with this section.

6 **§3-10-3. Vacancies in offices of state officials, United States**  
7 **senators and judges.**

8 Any vacancy occurring in the offices of Secretary of State,  
9 Auditor, Treasurer, Attorney General, Commissioner of Agriculture,  
10 ~~United States Senator, judge justice~~ of the Supreme Court of Appeals  
11 or in any office created or made elective to be filled by the voters  
12 of the entire state, judge of a circuit court or judge of a family  
13 court is filled by the Governor of the state by appointment ~~if the~~  
14 ~~unexpired term of a judge of the Supreme Court of Appeals, a judge~~  
15 ~~of the circuit court or judge of a family court is for less than two~~  
16 ~~years or if the unexpired term of any other office named in this~~  
17 ~~section is for a period of less than two years and six months, the~~  
18 ~~appointment to fill the vacancy is for the unexpired term. If the~~  
19 ~~unexpired term of any office is for a longer period than above~~  
20 ~~specified, the appointment is until a successor to the office has~~  
21 ~~timely filed a certificate of candidacy, has been nominated at the~~  
22 ~~primary election next following such timely filing and has~~  
23 ~~thereafter been elected and qualified to fill the unexpired term.~~  
24 ~~Proclamation of any election to fill an unexpired term is made by~~

1 ~~the Governor of the state and, in the case of an office to be filled~~  
2 ~~by the voters of the entire state, must be published prior to the~~  
3 ~~election as a Class II-0 legal advertisement in compliance with the~~  
4 ~~provisions of article three, chapter fifty-nine of this code and the~~  
5 ~~publication area for the publication is each county of the state.~~  
6 ~~If the election is to fill a vacancy in the office of judge of a~~  
7 ~~circuit court or judge of a family court, the proclamation must be~~  
8 ~~published prior to the election as a Class II-0 legal advertisement~~  
9 ~~in compliance with the provisions of article three, chapter fifty-~~  
10 ~~nine of this code and the publication area for such publication is~~  
11 ~~each county in the judicial or family court circuit. and subsequent~~  
12 ~~election to fill the remainder of the term, if required by section~~  
13 ~~one of this article.~~

14 **§3-10-3a. Judicial Vacancy Advisory Commission.**

15 (a) The Judicial Vacancy Advisory Commission ~~is hereby~~  
16 ~~established to~~ shall assist the Governor in filling judicial  
17 vacancies. The commission shall meet and submit a list of no more  
18 than five nor less than two best qualified persons to the Governor  
19 within ninety days of the occurrence of a vacancy, or the formal  
20 announcement of the justice or judge by letter to the Governor of  
21 an upcoming resignation or retirement that will result in the  
22 occurrence of a vacancy, in the office of justice of the Supreme  
23 Court of Appeals, judge of an intermediate appellate court, judge  
24 of a circuit court, or judge of a family court. The Governor shall

1 make the appointment to fill the vacancy, as required by this  
2 article, within thirty days following the receipt of the list of  
3 qualified candidates or within thirty days following the vacancy,  
4 whichever occurs later.

5 (b) The commission shall consist of eight appointed members.  
6 Four public members shall be appointed by the Governor for six-year  
7 terms, except for the initial appointments which shall be staggered  
8 in accordance with subsection (c) of this section. Four attorney  
9 members shall be appointed by the Governor for six-year terms,  
10 except as provided in subsection (c) of this section, from a list  
11 of nominees provided by the Board of Governors of the West Virginia  
12 State Bar. The Board of Governors of the West Virginia State Bar  
13 shall nominate no more than twenty nor less than ten best qualified  
14 attorneys for appointment to the commission whenever there is a  
15 vacancy in the membership of the commission reserved for attorney  
16 members. The commission shall choose one of its appointed members  
17 to serve as chair for a three-year term. No more than four  
18 appointed members of the commission shall belong to the same  
19 political party. No more than three appointed members of the  
20 commission shall be residents of the same congressional district.  
21 All members of the commission shall be citizens of this state.  
22 Public members of the commission may not be licensed to practice law  
23 in West Virginia or any other jurisdiction.

1 (c) Of the initial appointments made to the commission, two  
2 public members and two attorney members shall be appointed for a  
3 term ending two years after the effective date of this section, one  
4 public member and one attorney member shall be appointed for a term  
5 ending four years after the effective date of this section, and one  
6 public member and one attorney member shall be appointed for a term  
7 ending six years after the effective date of this section.

8 (d) The Governor, or his or her designee, the President of the  
9 West Virginia State Bar and the Dean of the West Virginia University  
10 College of Law shall serve as *ex officio* members of the commission.

11 (e) Members of the commission shall serve without compensation,  
12 except that commission members are entitled to reimbursement of  
13 travel and other necessary expenses actually incurred while engaged  
14 in official commission activities in accordance with the guidelines  
15 of the Travel Management Office of the Department of Administration,  
16 or its successor entity. The Governor's Office shall cooperate with  
17 the commission to ensure that all resources necessary to carrying  
18 out the official duties of the commission are provided, including  
19 staff assistance, equipment and materials.

20 (f) The commission shall adopt written policies that formalize  
21 and standardize all operating procedures and ethical practices of  
22 its members including, but not limited to, procedures for training  
23 commission members, publishing notice of judicial vacancies,  
24 recruiting qualified individuals for consideration by the

1 commission, receiving applications from qualified individuals,  
2 notifying the public of judicial vacancies, notifying state or local  
3 groups and organizations of judicial vacancies and soliciting public  
4 comment on judicial vacancies. The written policies of the  
5 commission are not subject to the provisions of chapter twenty-nine-  
6 a of this code, but shall be filed with the Secretary of State.

7 (g) A majority of the commission plus one shall constitute a  
8 quorum to do business.

9 (h) All organizational meetings of the commission shall be open  
10 to the public and subject to the requirements of article nine-a,  
11 chapter six of this code. An "organizational meeting" means an  
12 initial meeting to discuss the commission's procedures and  
13 requirements for a judicial vacancy. The commission shall hold at  
14 least one organizational meeting upon the occurrence of a judicial  
15 vacancy. All other meetings of the commission are exempt from  
16 article nine-a, chapter six of this code.

10 **§3-10-4. Vacancies in representation in United States Congress.**

11 (a) If there ~~be~~ is a vacancy in the representation from this  
12 state in the House of Representatives in the Congress of the United  
13 States, the Governor shall, within ~~ten~~ five days after the fact  
14 comes to his or her knowledge, ~~of article three, chapter fifty nine~~  
15 ~~of this code, and the publication area for such publication shall~~  
16 ~~be each county in the congressional district. In such proclamation~~  
17 ~~he the Governor shall appoint some day, issue a proclamation give~~  
18 ~~notice thereof by proclamation, to be published prior to such~~  
19 ~~election as a Class II-O legal advertisement in compliance with the~~  
20 ~~provisions setting dates for a special primary election that is not~~

5 is not less than eighty-four nor more than one hundred twenty days  
6 following the date of the special primary election: *Provided, That*  
7 no such proclamation may be made nor may a special election be held  
8 if the vacancy occurs after the eighty-fourth day prior to the  
9 regularly scheduled primary election for a new full term of the  
10 office. The election shall follow the requirements of section one  
11 of this article that are not in conflict with this section.

12 (b) If there is a vacancy in the representation from this state  
13 in the Senate of the United States Congress, the vacancy shall be  
14 filled by the Governor of the state by appointment and:

15 (1) If the vacancy occurs on or before the primary cutoff date,  
16 then an election shall be held pursuant to section one of this  
17 article; or

18 (2) If the vacancy occurs after the primary cutoff date, but  
19 on or before the general cutoff date, then the Governor shall issue  
20 a proclamation providing for (A) a special filing period, (B) a  
21 special primary election to be held in conjunction with the upcoming  
22 general election and (C) a special general election to be held not  
23 less than eighty-four nor more than one hundred twenty days  
24 following the date of the special primary election. Each election

1 shall follow the requirements of section one of this article that  
2 are not in conflict with this section.

3 **§3-10-5. Vacancies in State Legislature.**

4 (a) Any vacancy in the office of State Senator or member of the  
5 House of Delegates shall be filled by appointment by the Governor,  
6 from a list of three legally qualified persons submitted by the  
7 party executive committee of the party with which the person holding  
8 the office immediately preceding the vacancy was affiliated. ~~Such~~  
9 The list of qualified persons to fill the vacancy shall be submitted  
10 to the Governor within fifteen days after the vacancy occurs and the  
11 Governor shall duly make his or her appointment to fill the vacancy  
12 from the list of legally qualified ~~person~~ persons within five days  
13 after the list is received. If the list is not submitted to the  
14 Governor within the fifteen day period, the Governor shall appoint  
15 within five days thereafter a legally qualified person of the same  
16 political party as the person vacating the office.

17 (b) In the case of a member of the House of Delegates, the list  
18 shall be submitted by the party executive committee of the delegate  
19 district in which the vacating member resided at the time of his or  
20 her election or appointment. The appointment to fill a vacancy in  
21 the House of Delegates is for the unexpired term.

22 (c) In the case of a State Senator, the list shall be submitted  
23 by the party executive committee of the state senatorial district  
24 in which the vacating senator resided at the time of his or her

1 election or appointment. ~~If the unexpired term in the office of the~~  
2 ~~state Senator will be for less than two years and two months, the~~  
3 ~~appointment is for the unexpired term. If the unexpired term will~~  
4 ~~be for a period equal to or longer than two years and two months,~~  
5 ~~the appointment is until the next general election and until the~~  
6 ~~election and qualification of a successor to the person appointed,~~  
7 ~~at which general election the vacancy shall be filled by election~~  
8 ~~for the unexpired term. Notice of an election to fill a vacancy in~~  
9 ~~the office of State Senator shall be given by the Governor by~~  
10 ~~proclamation and shall be published before the election as a Class~~  
11 ~~II-0 legal advertisement in compliance with the provisions of~~  
12 ~~article three, chapter fifty-nine of this code, and the publication~~  
13 ~~area for the publication shall be each county in the senatorial~~  
14 ~~district. Nominations for candidates to fill a vacancy shall be~~

1    **§3-10-6. Vacancy in office of circuit court clerk.**

2           (a) When a vacancy occurs in the office of clerk of the circuit  
3 court, the circuit court by a majority vote of the judges ~~or the~~  
4 ~~chief judge thereof in vacation,~~ shall fill the same within thirty  
5 days of the vacancy by appointment of a person of the same political  
6 party as the officeholder vacating the office ~~until the next general~~  
7 ~~election, or until the completion of the term if the term ends on~~  
8 ~~December 31, following the next general election. The person so~~  
9 ~~appointed shall hold office until his or her successor is elected~~  
10 ~~and qualified. At the general election, a clerk shall be elected~~

5 **§3-10-8. Vacancies in offices of prosecuting attorney, sheriff,

8 attorney, sheriff, assessor or county surveyor shall be filled by  
9 the county commission within thirty days of the vacancy by  
10 appointment of a person of the same political party as the  
11 officeholder vacating the office. The appointed person shall hold  
12 the office ~~until the next general election is certified, or until~~  
13 ~~the completion of the term if the term ends on December 31,~~  
14 ~~following the next general election~~ Notice of an election to fill  
15 a vacancy in any of the offices named in this section shall be given  
16 by the county commission, or by the president thereof in vacation,  
17 and published or posted in the manner prescribed in section six of  
18 this article. ~~Nomination of candidates to fill any vacancy shall~~  
19 ~~be made in the manner prescribed in section six of this article for~~  
20 ~~nominating candidates to fill a vacancy in the office of the clerk~~

20 If an election as required by sections two or four of this  
21 article cannot be held in conjunction with the regular election  
22 dates, then the cost of printing ballots and all other reasonable  
23 and necessary expenses in holding and making the return of the new  
24 election to fill a vacancy are obligations of the state incurred by

1 the ballot commissioners, clerks of the county commissions and  
2 county commissions of the various counties as agents of the state.  
3 All expenses of the new election are to be audited by the Secretary  
4 of State. The Secretary of State shall prepare and transmit to the  
5 county commissions forms on which the county commissions shall  
6 certify all expenses of the new election to the Secretary of State.  
7 If satisfied that the expenses as certified by the county  
8 commissions are reasonable and were necessarily incurred, the  
9 Secretary of State shall requisition the necessary warrants from the  
10 Auditor of the state to be drawn on the State Treasurer and shall  
11 mail the warrants directly to the vendors of the new election  
12 services, supplies and facilities.
