20	§17A-3-14. Registration plates generally; description of plates;
21	issuance of special numbers and plates;
22	registration fees; special application fees;
23	exemptions; commissioner to promulgate forms;
24	suspension and nonrenewal.
25	(a) The division upon registering a vehicle shall issue to the

- 1 owner one registration plate for a motorcycle, trailer, semitrailer
- 2 or other motor vehicle.
- 3 (b) Registration plates issued by the division shall meet the
- 4 following requirements:
- 5 (1) Every registration plate shall be of reflectorized material
- 6 and have displayed upon it the registration number assigned to the
- 7 vehicle for which it is issued; the name of this state, which may
- 8 be abbreviated; and the year number for which it is issued or the
- 9 date of expiration of the plate.
- 10 (2) Every registration plate and the required letters and
- 11 numerals on the plate shall be of sufficient size to be plainly
- 12 readable from a distance of one hundred feet during daylight:
- 13 Provided, That the requirements of this subdivision shall not apply
- 14 to the year number for which the plate is issued or the date of
- 15 expiration.
- 16 (3) Registration numbering for registration plates shall begin
- 17 with number two.
- 18 (c) The division may not issue, permit to be issued or
- 19 distribute any special registration plates except as follows:
- 20 (1) The Governor shall be issued two registration plates, on
- 21 one of which shall be imprinted the numeral one and on the other
- 22 the word one.
- 23 (2) State officials and judges may be issued special
- 24 registration plates as follows:

- (A) Upon appropriate application, the division shall issue to 1 2 the Secretary of State, State Superintendent of Schools, Auditor, 3 Treasurer, Commissioner of Agriculture and the Attorney General, 4 the members of both houses of the Legislature, including the 5 elected officials of both houses of the Legislature, the justices Supreme Court of Appeals of West Virginia, the the 7 representatives and senators of the state in the Congress of the 8 United States, the judges of the West Virginia circuit courts, 9 active and retired on senior status, the judges of the United 10 States district courts for the State of West Virginia and the 11 judges of the United States Court of Appeals for the fourth 12 circuit, if any of the judges are residents of West Virginia, a 13 special registration plate for a Class A motor vehicle and a 14 special registration plate for a Class G motorcycle owned by the 15 official or his or her spouse: Provided, That the division may 16 issue a Class A special registration plate for each vehicle titled 17 to the official and a Class G special registration plate for each 18 motorcycle titled to the official.
- 19 (B) Each plate issued pursuant to this subdivision shall bear 20 any combination of letters and numbers not to exceed an amount 21 determined by the commissioner and a designation of the office. 22 Each plate shall supersede the regular numbered plate assigned to 23 the official or his or her spouse during the official's term of 24 office and while the motor vehicle is owned by the official or his

1 or her spouse.

- 2 (C) The division shall charge an annual fee of \$15 for every 3 registration plate issued pursuant to this subdivision, which is in 4 addition to all other fees required by this chapter.
- 5 (3) The division may issue members of the National Guard forces 6 special registration plates as follows:
- (A) Upon receipt of an application on a form prescribed by the division and receipt of written evidence from the chief executive officer of the Army National Guard or Air National Guard, as appropriate, or the commanding officer of any United States Armed Forces reserve unit that the applicant is a member thereof, the division shall issue to any member of the National Guard of this state or a member of any reserve unit of the United States Armed Forces a special registration plate designed by the commissioner for any number of Class A motor vehicles owned by the member. Upon presentation of written evidence of retirement status, retired members of this state's Army or Air National Guard, or retired members of any reserve unit of the United States Armed Forces, are eligible to purchase the special registration plate issued pursuant to this subdivision.
- 21 (B) The division shall charge an initial application fee of \$10 22 for each special registration plate issued pursuant to this 23 subdivision, which is in addition to all other fees required by 24 this chapter. Except as otherwise provided herein, effective July

- 1 1, 2007, all fees currently held in the special revolving fund used
- 2 in the administration of this section and all fees collected by the
- 3 division shall be deposited in the State Road Fund.
- 4 (C) A surviving spouse may continue to use his or her deceased
- 5 spouse's National Guard forces license plate until the surviving
- 6 spouse dies, remarries or does not renew the license plate.
- 7 (4) Specially arranged registration plates may be issued as 8 follows:
- 9 (A) Upon appropriate application, any owner of a motor vehicle
- 10 subject to Class A registration, or a motorcycle subject to Class
- 11 G registration, as defined by this article, may request that the
- 12 division issue a registration plate bearing specially arranged
- 13 letters or numbers with the maximum number of letters or numbers to
- 14 be determined by the commissioner. The division shall attempt to
- 15 comply with the request wherever possible.
- 16 (B) The commissioner shall propose rules for legislative
- 17 approval in accordance with the provisions of chapter twenty-nine-a

- 1 (5) The division may issue honorably discharged veterans 2 special registration plates as follows:
- 3 (A) Upon appropriate application, the division shall issue to 4 any honorably discharged veteran of any branch of the armed 5 services of the United States a special registration plate for any 6 number of vehicles titled in the name of the qualified applicant 7 with an insignia designed by the Commissioner of the Division of 8 Motor Vehicles.
- 9 (B) The division shall charge a special initial application fee 10 of \$10 in addition to all other fees required by law. This special 11 fee is to compensate the Division of Motor Vehicles for additional 12 costs and services required in the issuing of the special 13 registration. All fees collected by the division shall be 14 deposited in the State Road Fund: *Provided*, That nothing in this 15 section may be construed to exempt any veteran from any other 16 provision of this chapter.
- 17 (C) A surviving spouse may continue to use his or her deceased 18 spouse's honorably discharged veterans license plate until the 19 surviving spouse dies, remarries or does not renew the license 20 plate.
- 21 (6) The division may issue disabled veterans special 22 registration plates as follows:
- 23 (A) Upon appropriate application, the division shall issue to 24 any disabled veteran who is exempt from the payment of registration

- 1 fees under the provisions of this chapter a registration plate for
- 2 a vehicle titled in the name of the qualified applicant which bears
- 3 the letters "DV" in red and also the regular identification
- 4 numerals in red.
- 5 (B) A surviving spouse may continue to use his or her deceased
- 6 spouse's disabled veterans license plate until the surviving spouse
- 7 dies, remarries or does not renew the license plate.
- 8 (C) A qualified disabled veteran may obtain a second disabled
- 9 veterans license plate as described in this section for use on a
- 10 passenger vehicle titled in the name of the qualified applicant.
- 11 The division shall charge a one-time fee of \$10 to be deposited
- 12 into the State Road Fund, in addition to all other fees required by
- 13 this chapter, for the second plate.
- 14 (7) The division may issue recipients of the distinguished
- 15 Purple Heart medal special registration plates as follows:
- 16 (A) Upon appropriate application, there shall be issued to any
- 17 armed service person holding the distinguished Purple Heart medal
- 18 for persons wounded in combat a registration plate for a vehicle
- 19 titled in the name of the qualified applicant bearing letters or
- 20 numbers. The registration plate shall be designed by the
- 21 Commissioner of Motor Vehicles and shall denote that those
- 22 individuals who are granted this special registration plate are
- 23 recipients of the Purple Heart. All letterings shall be in purple
- 24 where practical.

- 1 (B) Registration plates issued pursuant to this subdivision are
- 2 exempt from all registration fees otherwise required by the
- 3 provisions of this chapter.
- 4 (C) A surviving spouse may continue to use his or her deceased
- 5 spouse's Purple Heart medal license plate until the surviving
- 6 spouse dies, remarries or does not renew the license plate.
- 7 (D) A recipient of the Purple Heart medal may obtain a second
- 8 Purple Heart medal license plate as described in this section for
- 9 use on a passenger vehicle titled in the name of the qualified
- 10 applicant. The division shall charge a one-time fee of \$10 to be
- 11 deposited into the State Road Fund, in addition to all other fees
- 12 required by this chapter, for the second plate.
- 13 (8) The division may issue survivors of the attack on Pearl
- 14 Harbor special registration plates as follows:
- 15 (A) Upon appropriate application, the owner of a motor vehicle
- 16 who was enlisted in any branch of the armed services that
- 17 participated in and survived the attack on Pearl Harbor on December
- 18 7, 1941, the division shall issue a special registration plate for
- 19 a vehicle titled in the name of the qualified applicant. The
- 20 registration plate shall be designed by the Commissioner of Motor
- 21 Vehicles.
- 22 (B) Registration plates issued pursuant to this subdivision are
- 23 exempt from the payment of all registration fees otherwise required
- 24 by the provisions of this chapter.

- 1 (C) A surviving spouse may continue to use his or her deceased 2 spouse's survivors of the attack on Pearl Harbor license plate 3 until the surviving spouse dies, remarries or does not renew the 4 license plate.
- 5 (D) A survivor of the attack on Pearl Harbor may obtain a 6 second survivors of the attack on Pearl Harbor license plate as 7 described in this section for use on a passenger vehicle titled in 8 the name of the qualified applicant. The division shall charge a 9 one-time fee of \$10 to be deposited into the State Road Fund, in 10 addition to all other fees required by this chapter, for the second 11 plate.
- 12 (9) The division may issue special registration plates to 13 nonprofit charitable and educational organizations authorized under 14 prior enactment of this subdivision as follows:
- (A) Approved nonprofit charitable and educational organizations previously authorized under the prior enactment of this subdivision may accept and collect applications for special registration plates from owners of Class A motor vehicles together with a special annual fee of \$15, which is in addition to all other fees required by this chapter. The applications and fees shall be submitted to the Division of Motor Vehicles with the request that the division issue a registration plate bearing a combination of letters or numbers with the organizations' logo or emblem, with the maximum number of letters or numbers to be determined by the commissioner.

- 1 (B) The commissioner shall propose rules for legislative
- 2 approval in accordance with the provisions of article three,
- 3 chapter twenty-nine-a of this code regarding the procedures for and
- 4 approval of special registration plates issued pursuant to this
- 5 subdivision.
- 6 (C) The commissioner shall set an appropriate fee to defray the
- 7 administrative costs associated with designing and manufacturing

The firefighter certification department, section 11 or division of the West Virginia University fire service extension 12 shall notify the commissioner in writing immediately when a 13 firefighter loses his or her certification. If a firefighter loses 14 his or her certification, the commissioner may not issue him or her 15 a license plate under this subsection.
- (C) Each application submitted pursuant to this subdivision shall be accompanied by payment of a special initial application the second second
- 21 (12) The division may issue special scenic registration plates 22 as follows:
- 23 (A) Upon appropriate application, the commissioner shall issue 24 a special registration plate displaying a scenic design of West

- 1 Virginia which displays the words "Wild Wonderful" as a slogan.
- 2 (B) The division shall charge a special one-time initial
- 3 application fee of \$10 in addition to all other fees required by
- 4 this chapter. All initial application fees collected by the
- 5 division shall be deposited into the State Road Fund.
- 6 (13) The division may issue honorably discharged Marine Corps
- 7 league members special registration plates as follows:
- 8 (A) Upon appropriate application, the division shall issue to
- 9 any honorably discharged Marine Corps league member a special
- 10 registration plate for any number of vehicles titled in the name of
- 11 the qualified applicant with an insignia designed by the
- 12 Commissioner of the Division of Motor Vehicles.
- 13 (B) The division may charge a special one-time initial
- 14 application fee of \$10 in addition to all other fees required by
- 15 this chapter. This special fee is to compensate the Division of
- 16 Motor Vehicles for additional costs and services required in the
- 17 issuing of the special registration and shall be collected by the
- 18 division and deposited in the State Road Fund: Provided, That
- 19 nothing in this section may be construed to exempt any veteran from
- 20 any other provision of this chapter.
- 21 (C) A surviving spouse may continue to use his or her deceased
- 22 spouse's honorably discharged Marine Corps League license plate
- 23 until the surviving spouse dies, remarries or does not renew the
- 24 license plate.

- 1 (14) The division may issue military organization registration 2 plates as follows:
- 3 (A) The division may issue a special registration plate for the 4 members of any military organization chartered by the United States 5 Congress upon receipt of a guarantee from the organization of a 6 minimum of one hundred applicants. The insignia on the plate shall 7 be designed by the commissioner.
- 8 (B) Upon appropriate application, the division may issue 9 members of the chartered organization in good standing, as 10 determined by the governing body of the chartered organization, a 11 special registration plate for any number of vehicles titled in the 12 name of the qualified applicant.
- (C) The division shall charge a special one-time initial application fee of \$10 for each special license plate in addition to all other fees required by this chapter. All initial application fees collected by the division shall be deposited into the State Road Fund: *Provided*, That nothing in this section may be construed to exempt any veteran from any other provision of this chapter.
- 20 (D) A surviving spouse may continue to use his or her deceased 21 spouse's military organization registration plate until the 22 surviving spouse dies, remarries or does not renew the special 23 military organization registration plate.

- 12 registration plates and wildlife registration plates shall be
- 13 deposited in a special revenue account designated the Nongame

- 13 (B) An annual fee of \$25 shall be charged for each special
- 14 racing theme registration plate in addition to all other fees
- 15 required by this chapter. All annual fees collected for each
- 16 special racing theme registration plate shall be deposited into the
- 17 State Road Fund.
- 18 (C) A special application fee of \$10 shall be charged at the
- 19 time of initial application as well as upon application for any
- 20 duplicate or replacement registration plate, in addition to all
- 21 other fees required by this chapter. All application fees shall be
- 22 deposited into the State Road Fund.
- 23 (20) The division may issue recipients of the Navy Cross,
- 24 Distinguished Service Cross, Distinguished Flying Cross, Air Force

- 1 Cross, Bronze Star, Silver Star or Air Medal special registration 2 plates as follows:
- (A) Upon appropriate application, the division shall issue to 4 any recipient of the Navy Cross, Distinguished Service Cross, 5 Distinguished Flying Cross, Air Force Cross, Silver Star, Bronze 6 Star or Air Medal, a registration plate for any number of vehicles 7 titled in the name of the qualified applicant bearing letters or 8 numbers. A separate registration plate shall be designed by the 9 Commissioner of Motor Vehicles for each award that denotes that 10 those individuals who are granted this special registration plate 11 are recipients of the Navy Cross, Distinguished Service Cross, 12 Distinguished Flying Cross, Air Force Cross, Silver Star or Bronze 13 Star, or Air Medal as applicable.
- 14 (B) The division shall charge a special initial application fee 15 of \$10 in addition to all other fees required by law. This special 16 fee shall be collected by the division and deposited in the State 17 Road Fund: *Provided*, That nothing in this section exempts the 18 applicant for a special registration plate under this subdivision 19 from any other provision of this chapter.
- 20 (C) A surviving spouse may continue to use his or her deceased 21 spouse's Navy Cross, Distinguished Service Cross, Distinguished 22 Flying Cross, Air Force Cross, Silver Star, Bronze Star or Air 23 Medal special registration plate until the surviving spouse dies, 24 remarries or does not renew the special registration plate.

- 1 (21) The division may issue honorably discharged veterans 2 special registration plates as follows:
- 3 (A) Upon appropriate application, the division shall issue to 4 any honorably discharged veteran of any branch of the armed 5 services of the United States with verifiable service during World 6 War II, the Korean War, the Vietnam War, the Persian Gulf War or 7 the War Against Terrorism a special registration plate for any 8 number of vehicles titled in the name of the qualified applicant 9 with an insignia designed by the commissioner denoting service in 10 the applicable conflict.
- 11 (B) The division shall charge a special one-time initial 12 application fee of \$10 in addition to all other fees required by 13 law. This special fee shall be collected by the division and 14 deposited in the State Road Fund: *Provided*, That nothing contained 15 in this section may be construed to exempt any veteran from any 16 other provision of this chapter.
- 17 (C) A surviving spouse may continue to use his or her deceased 18 spouse's honorably discharged veterans registration plate until the 19 surviving spouse dies, remarries or does not renew the special 20 registration plate.
- 21 (22) The division may issue special volunteer firefighter 22 registration plates as follows:
- 23 (A) Any owner of a motor vehicle who is a resident of West 24 Virginia and who is a volunteer firefighter may apply for a special

- 1 license plate for any Class A vehicle titled in the name of the
- 2 qualified applicant which bears the insignia of the profession in
- 3 white letters on a red background. The insignia shall be designed
- 4 by the commissioner and shall contain a fireman's helmet insignia
- 5 on the left side of the license plate.
- (B) Each application submitted pursuant to this subdivision
- 7 shall be accompanied by an affidavit signed by the applicant's fire
- 8 chief, stating that the applicant is a volunteer firefighter and
- 9 justified in having a registration plate with the requested
- 10 insignia. The applicant must comply with all other laws of this
- 11 state regarding registration and licensure of motor vehicles and
- 12 must pay all required fees.
- 13 (C) Each application submitted pursuant to this subdivision
- 14 shall be accompanied by payment of a special one-time initial
- 15 application fee of \$10, which is in addition to any other
- 16 registration or license fee required by this chapter. All
- 17 application fees shall be deposited into the State Road Fund.
- 18 (23) The division may issue special registration plates which
- 19 reflect patriotic themes, including the display of any United
- 20 States symbol, icon, phrase or expression which evokes patriotic
- 21 pride or recognition.
- 22 (A) Upon appropriate application, the division shall issue to
- 23 an applicant a registration plate of the applicant's choice,
- 24 displaying a patriotic theme as provided in this subdivision, for

- 1 a vehicle titled in the name of the applicant. A series of
- 2 registration plates displaying patriotic themes shall be designed
- 3 by the Commissioner of Motor Vehicles for distribution to
- 4 applicants.
- 5 (B) The division shall charge a special one-time initial
- 6 application fee of \$10 in addition to all other fees required by
- 7 law. This special fee shall be collected by the division and
- 8 deposited in the State Road Fund.
- 9 (24) Special license plates bearing the American flag and the
- 10 logo "9/11/01".
- 11 (A) Upon appropriate application, the division shall issue
- 12 special registration plates which shall display the American flag

If the commissioner fails to receive the required number of applications within six months of the effective date of the original authorizing legislation, the plate will not be produced and will require legislative reauthorization: *Provided*, That if the minimum number of applications is not satisfied within the six months of the

- 2 may not request reconsideration of a special plate until at least

(i) Any license plate issued or renewed pursuant to this
13 chapter which is paid for by a check that is returned for
14 nonsufficient funds is void without further notice to the
15 applicant. The applicant may not reinstate the registration until
16 the returned check is paid by the applicant in cash, money order or
17 certified check and all applicable fees assessed as a result

NOTE: The purpose of this bill is to provide for the issuance of special license plates for the hearing impaired. The bill also exempts this plate from the minimum number of applications requirements.
