10	A BILL to amend and reenact $\$49-6-1a$ of the Code of West Virginia,
11	1931, as amended, relating to increasing the number of child
12	protective service workers at the Department of Health and
13	Human Resources.
14	Be it enacted by the Legislature of West Virginia:
15	That \$49-6-1a of the Code of West Virginia, 1931, as amended,
16	be amended and reenacted to read as follows:
17	ARTICLE 6. PROCEDURE IN CASES OF CHILD NEGLECT OR ABUSE.
18	§49-6-1a. Minimum staffing complement for child protective
19	services.
20	On or before June 30, 2014, the Secretary of the Department of
21	Health and Human Resources shall increase For the sole purpose of
22	increasing the number of full-time front line child protective
23	service case workers and investigators by twenty percent in each
24	regional office. The Secretary of the Department of Health and
25	Human Resources shall have the authority to transfer funds between

1 all general revenue accounts under the secretary's authority and/or 2 between personnel and nonpersonnel lines within each account under 3 the secretary's authority. Provided, That nothing in this section 4 shall be construed to require the department to hire additional 5 child protective service workers at any time if the department 6 determines that funds are not available for such workers. 7 Additionally, the secretary shall prepare a plan to allow the 8 department to progressively reduce caseload standards in West 9 Virginia for child protective services workers, which if adopted by 10 the Legislature during the 1995 regular session, shall require 11 implementation no later than July 1, 1996, with said plan to be 12 submitted to the Joint Committee on Government and Finance by 13 September 30, 1994, and a final report to be submitted to the 14 Legislature by January 1, 1995. Additionally, the secretary shall 15 revise the department's plan for progressively reducing caseload 16 standards in West Virginia for child protective services workers in 17 order to further reduce caseloads. If this revised plan is adopted 18 by the Legislature during the 2014 regular session, the secretary 19 shall implement the plan no later than July 1, 2015. The secretary 20 shall submit the revised plan to the Joint Committee on Government 21 and Finance by September, 2013, and a final report shall be 22 submitted to the Legislature by January 1, 2014.

NOTE: The purpose of this bill is to increase the number of child protective service workers and to reduce the caseloads of child protective service workers.
