10	A BILL to amend and reenact $\$17C-5-2$ of the Code of West Virginia,
11	1931, as amended, relating to increasing the penalty for
12	driving under the influence causing death.
13	Be it enacted by the Legislature of West Virginia:
14	That §17C-5-2 of the Code of West Virginia, 1931, as amended,
15	be amended and reenacted to read as follows:
16	ARTICLE 5. SERIOUS TRAFFIC OFFENSES.
17	§17C-5-2. Driving under influence of alcohol, controlled
18	substances or drugs; penalties.
19	(a) Any person who:
20	(1) Drives a vehicle in this state while he or she:
21	(A) Is under the influence of alcohol;
22	(B) Is under the influence of any controlled substance;
23	(C) Is under the influence of any other drug;

- 1 (D) Is under the combined influence of alcohol and any 2 controlled substance or any other drug; or
- 3 (E) Has an alcohol concentration in his or her blood of eight
- 4 hundredths of one percent or more, by weight; and
- 5 (2) While driving does any act forbidden by law or fails to
- 6 perform any duty imposed by law in the driving of the vehicle,
- 7 which act or failure proximately causes the death of any person
- 8 within one year next following the act or failure; and
- 9 (3) Commits the act or failure in reckless disregard of the
- 10 safety of others and when the influence of alcohol, controlled
- 11 substances or drugs is shown to be a contributing cause to the
- 12 death, is guilty of a felony and, upon conviction thereof, shall be
- 13 imprisoned in a state correctional facility for not less than two
- 14 <u>five</u> years nor more than ten <u>fifteen</u> years and shall be fined not
- 15 less than \$1,000 nor more than \$3,000.
- 16 (b) Any person who:
- 17 (1) Drives a vehicle in this state while he or she:
- 18 (A) Is under the influence of alcohol;
- 19 (B) Is under the influence of any controlled substance;
- 20 (C) Is under the influence of any other drug;
- 21 (D) Is under the combined influence of alcohol and any
- 22 controlled substance or any other drug;
- 23 (E) Has an alcohol concentration in his or her blood of eight
- 24 hundredths of one percent or more, by weight; and

- 1 (2) While driving does any act forbidden by law or fails to 2 perform any duty imposed by law in the driving of the vehicle, 3 which act or failure proximately causes the death of any person 4 within one year next following the act or failure, is guilty of a 5 misdemeanor and, upon conviction thereof, shall be confined in jail 6 for not less than ninety days nor more than one year and shall be 7 fined not less than \$500 nor more than \$1,000.
- 8 (c) Any person who:
- 9 (1) Drives a vehicle in this state while he or she:
- 10 (A) Is under the influence of alcohol;
- 11 (B) Is under the influence of any controlled substance;
- 12 (C) Is under the influence of any other drug;
- 13 (D) Is under the combined influence of alcohol and any 14 controlled substance or any other drug; or
- 15 (E) Has an alcohol concentration in his or her blood of eight 16 hundredths of one percent or more, by weight; and
- (2) While driving does any act forbidden by law or fails to 18 perform any duty imposed by law in the driving of the vehicle, 19 which act or failure proximately causes bodily injury to any person 20 other than himself or herself, is guilty of a misdemeanor and, upon 21 conviction thereof, shall be confined in jail for not less than one 22 day nor more than one year, which jail term is to include actual 23 confinement of not less than twenty-four hours, and shall be fined 24 not less than \$200 nor more than \$1,000.

- 1 (d) Any person who:
- 2 (1) Drives a vehicle in this state while he or she:
- 3 (A) Is under the influence of alcohol;
- 4 (B) Is under the influence of any controlled substance;
- 5 (C) Is under the influence of any other drug;
- 6 (D) Is under the combined influence of alcohol and any 7 controlled substance or any other drug; or
- 8 (E) Has an alcohol concentration in his or her blood of eight 9 hundredths of one percent or more, by weight, but less than fifteen 10 hundredths of one percent, by weight;
- (2) Is guilty of a misdemeanor and, upon conviction thereof, 2 except as provided in section two-b of this article, shall be 3 confined in jail for up to six months and shall be fined not less 4 than \$100 nor more than \$500. A person sentenced pursuant to this 4 subdivision shall receive credit for any period of actual 4 confinement he or she served upon arrest for the subject offense.
- (e) Any person who drives a vehicle in this state while he or 18 she has an alcohol concentration in his or her blood of fifteen 19 hundredths of one percent or more, by weight, is guilty of a 20 misdemeanor and, upon conviction thereof, shall be confined in jail 21 for not less than two days nor more than six months, which jail 22 term is to include actual confinement of not less than twenty-four 23 hours, and shall be fined not less than \$200 nor more than \$1,000.
- 24 A person sentenced pursuant to this subdivision shall receive

- 1 credit for any period of actual confinement he or she served upon 2 arrest for the subject offense.
- (f) Any person who, being an habitual user of narcotic drugs 4 or amphetamine or any derivative thereof, drives a vehicle in this 5 state is guilty of a misdemeanor and, upon conviction thereof, 6 shall be confined in jail for not less than one day nor more than 7 six months, which jail term is to include actual confinement of not 8 less than twenty-four hours, and shall be fined not less than \$100 9 nor more than \$500. A person sentenced pursuant to this 10 subdivision shall receive credit for any period of actual 11 confinement he or she served upon arrest for the subject offense.
- 12 (g) Any person who:
- 13 (1) Knowingly permits his or her vehicle to be driven in this 14 state by any other person who:
- 15 (A) Is under the influence of alcohol;
- 16 (B) Is under the influence of any controlled substance;
- 17 (C) Is under the influence of any other drug;
- 18 (D) Is under the combined influence of alcohol and any 19 controlled substance or any other drug;
- 20 (E) Has an alcohol concentration in his or her blood of eight 21 hundredths of one percent or more, by weight;
- 22 (2) Is guilty of a misdemeanor and, upon conviction thereof, 23 shall be confined in jail for not more than six months and shall be
- 24 fined not less than \$100 nor more than \$500.

- (h) Any person who knowingly permits his or her vehicle to be driven in this state by any other person who is an habitual user of narcotic drugs or amphetamine or any derivative thereof is guilty of a misdemeanor and, upon conviction thereof, shall be confined in jail for not more than six months and shall be fined not less than \$100 nor more than \$500.
- (i) Any person under the age of twenty-one years who drives a 8 vehicle in this state while he or she has an alcohol concentration 9 in his or her blood of two hundredths of one percent or more, by 10 weight, but less than eight hundredths of one percent, by weight, 11 for a first offense under this subsection is quilty of a 12 misdemeanor and, upon conviction thereof, shall be fined not less 13 than \$25 nor more than \$100. For a second or subsequent offense 14 under this subsection, the person is quilty of a misdemeanor and, 15 upon conviction thereof, shall be confined in jail for twenty-four 16 hours and shall be fined not less than \$100 nor more than \$500. A 17 person who is charged with a first offense under the provisions of 18 this subsection may move for a continuance of the proceedings, from 19 time to time, to allow the person to participate in the Motor 20 Vehicle Alcohol Test and Lock Program as provided in section three-21 a, article five-a of this chapter. Upon successful completion of 22 the program, the court shall dismiss the charge against the person 23 and expunge the person's record as it relates to the alleged 24 offense. In the event the person fails to successfully complete

- 1 the program, the court shall proceed to an adjudication of the
- 2 alleged offense. A motion for a continuance under this subsection
- 3 may not be construed as an admission or be used as evidence. A
- 4 person arrested and charged with an offense under the provisions of
- 5 this subsection or subsection (a), (b), (c), (d), (e), (f), (g) or
- 6 (h) of this section may not also be charged with an offense under
- 7 this subsection arising out of the same transaction or occurrence.
- 8 (j) Any person who:
- 9 (1) Drives a vehicle in this state while he or she:
- 10 (A) Is under the influence of alcohol;
- 11 (B) Is under the influence of any controlled substance;
- 12 (C) Is under the influence of any other drug;
- 13 (D) Is under the combined influence of alcohol and any
- 14 controlled substance or any other drug; or
- 15 (E) Has an alcohol concentration in his or her blood of eight
- 16 hundredths of one percent or more, by weight; and
- 17 (2) The person while driving has on or within the motor
- 18 vehicle one or more other persons who are unemancipated minors who
- 19 have not reached their sixteenth birthday is guilty of a
- 20 misdemeanor and, upon conviction thereof, shall be confined in jail
- 21 for not less than two days nor more than twelve months, which jail
- 22 term is to include actual confinement of not less than forty-eight
- 23 hours and shall be fined not less than \$200 nor more than \$1,000.
- 24 (k) A person violating any provision of subsection (b), (c),

- 1 (d), (e), (f), (g) or (I) of this section, for the second offense
- 2 under this section, is quilty of a misdemeanor and, upon conviction
- 3 thereof, shall be confined in jail for not less than six months nor
- 4 more than one year and the court may, in its discretion, impose a
- 5 fine of not less than \$1,000 nor more than \$3,000.
- 6 (1) A person violating any provision of subsection (b), (c),
- 7 (d), (e), (f), (g) or (I) of this section, for the third or any
- 8 subsequent offense under this section, is guilty of a felony and,
- 9 upon conviction thereof, shall be imprisoned in a state
- 10 correctional facility for not less than one nor more than three
- 11 years and the court may, in its discretion, impose a fine of not
- 12 less than \$3,000 nor more than \$5,000.
- (m) For purposes of subsections (k) and (l) of this section
- 14 relating to second, third and subsequent offenses, the following
- 15 events shall be regarded as offenses under this section:
- 16 (1) Any conviction under the provisions of subsection (a),
- 17 (b), (c), (d), (e), (f) or (g) of this section or under a prior
- 18 enactment of this section for an offense which occurred within the
- 19 ten-year period immediately preceding the date of arrest in the
- 20 current proceeding;
- 21 (2) Any conviction under a municipal ordinance of this state
- 22 or any other state or a statute of the United States or of any
- 23 other state of an offense which has the same elements as an offense
- 24 described in subsection (a), (b), (c), (d), (e), (f), (g) or (h) of

- 1 this section, which offense occurred within the ten-year period
- 2 immediately preceding the date of arrest in the current proceeding;
- 3 and,
- 4 (3) Any period of conditional probation imposed pursuant to 5 section two-b of this article for violation of subsection (d) of 6 this article, which violation occurred within the ten-year period

7 immediately preceding the date of arrest in the current proceeding.

- 8 (n) A person may be charged in a warrant or indictment or 9 information for a second or subsequent offense under this section 10 if the person has been previously arrested for or charged with a 11 violation of this section which is alleged to have occurred within 12 the applicable time period for prior offenses, notwithstanding the 13 fact that there has not been a final adjudication of the charges for 14 the alleged previous offense. In that case, the warrant or 15 indictment or information must set forth the date, location and 16 particulars of the previous offense or offenses. No person may be 17 convicted of a second or subsequent offense under this section 18 unless the conviction for the previous offense has become final, or 19 the person has previously had a period of conditional probation 20 imposed pursuant to section two-b of this article.
- 21 (o) The fact that any person charged with a violation of 22 subsection (a), (b), (c), (d), (e) or (f) of this section, or any 23 person permitted to drive as described under subsection (g) or (h) 24 of this section, is or has been legally entitled to use alcohol, a

1 controlled substance or a drug does not constitute a defense against 2 any charge of violating subsection (a), (b), (c), (d), (e), (f), (g) 3 or (h) of this section.

- 4 (p) For purposes of this section, the term "controlled 5 substance" has the meaning ascribed to it in chapter sixty-a of this 6 code.
- (q) The sentences provided in this section upon conviction for 8 a violation of this article are mandatory and are not subject to 9 suspension or probation: Provided, That the court may apply the 10 provisions of article eleven-a, chapter sixty-two of this code to 11 a person sentenced or committed to a term of one year or less for 12 a first offense under this section: Provided, further however, That 13 the court may impose a term of conditional probation pursuant to 14 section two-b of this article to persons adjudicated thereunder. 15 An order for home detention by the court pursuant to the provisions 16 of article eleven-b of said chapter may be used as an alternative 17 sentence to any period of incarceration required by this section for 18 a first or subsequent offense: Provided, however further, That for 19 any period of home incarceration ordered for a person convicted of 20 second offense under this section, electronic monitoring shall be 21 required for no fewer than five days of the total period of home 22 confinement ordered and the offender may not leave home for those 23 five days notwithstanding the provisions of section five, article 24 eleven-b, chapter sixty-two of this code: And provided further, That

1 for any period of home incarceration ordered for a person convicted 2 of a third or subsequent violation of this section, electronic 3 monitoring shall be included for no fewer than ten days of the total 4 period of home confinement ordered and the offender may not leave 5 home for those ten days notwithstanding section five, article 6 eleven-b, chapter sixty-two of this code.

NOTE: The purpose of this bill is to increase the penalty for driving under the influence causing death from two to ten years to five to fifteen years in prison.
