13	registration of voters.
14	Be it enacted by the Legislature of West Virginia:
15	That §3-2-24 of the Code of West Virginia, 1931, as amended,
16	be repealed; and that $$3-2-5$, $$3-2-6$ $$3-2-7$, $$3-2-10$ and $$3-2-11$ of
17	said code be amended and reenacted, all to read as follows:
18	ARTICLE 2. REGISTRATION OF VOTERS.
19	§3-2-5. Forms for application for registration; information
20	required and requested; types of application forms;
21	notices.
22	(a) (1) All state forms for application for voter registration
23	shall be prescribed by the Secretary of State and shall conform

- 1 with the requirements of 42 U.S.C. §1973gg, et seq., the National 2 Voter Registration Act of 1993 and the requirements of the 3 provisions of this article. Separate application forms may be 4 prescribed for voter registration conducted by the clerk of the 5 county commission, registration by mail, registration in 6 conjunction with an application for motor vehicle driver's license 7 and registration at designated agencies. These forms may consist 8 of one or more parts, may be combined with other forms for use in 9 registration by designated agencies or in conjunction with driver 10 licensing and may be revised and reissued as required by the 11 Secretary of State to provide for the efficient administration of 12 voter registration.
- (2) Notwithstanding any provisions of subdivision (1) of this subsection to the contrary, the federal postcard application for voter registration issued pursuant to 42 U.S.C. §1973, et seq., the Uniformed and Overseas Citizens Absentee Voting Act of 1986 and the mail voter registration application form prescribed by the Federal Election Commission pursuant to 42 U.S.C. §1973gg, et seq., the National Voter Registration Act of 1993, shall be are accepted as a valid form valid forms of application for registration pursuant to the provisions of this article.
- 22 <u>(3) A secure electronic voter registration system is approved</u>
 23 for use in accordance with procedures promulgated by the Secretary

- 2 (b) Each application form for registration shall include:
- 3 (1) A statement specifying the eligibility requirements for
- 4 registration and an attestation that the applicant meets each
- 5 eligibility requirement;
- 6 (2) Any specific notice or notices required for a specific
- 7 type or use of application by 42 U.S.C. §1973gg, et seq., the
- 8 National Voter Registration Act of 1993;
- 9 (3) A notice that a voter may be permitted to vote the
- 10 partisan primary election ballot of a political party only if the
- 11 voter has designated that political party on the application for
- 12 registration unless the political party has determined otherwise;
- 13 (4) The applicant's driver's license number or an
- 14 identification number issued by the Division of Motor Vehicles. If
- 15 the applicant does not have a driver's license or an identification
- 16 card issued by the Division of Motor Vehicles, then the last four
- 17 digits of the applicant's social security number; and
- 18 (5) Any other instructions or information essential to
- 19 complete the application process.
- 20 (c) Each application form shall require that the following be
- 21 provided by the applicant, under oath, and any an application which
- 22 does not contain each of the following shall be considered is

- 6 (e) The Secretary of State shall prescribe the printing
- 7 specifications of each type of voter registration application and

- 10 (f) Application forms prescribed in this section may refer to
- 11 various public officials by title or official position but in no
- 12 case may the actual name of any an officeholder be printed on the
- 13 voter registration application or on any portion of a combined

- 15 (g) No later than July 1 of each odd-numbered year, the
- 16 Secretary of State shall submit the specifications of the voter
- 17 registration application by mail for statewide bidding for a
- 18 contract period beginning September 1 of each odd-numbered year and

Provided, That The clerk of the county commission may 18 correct any an entry upon the request of the applicant provided the 19 request is properly documented and the correction is dated and 20 initialed by the clerk.
- 21 (e) Completed applications shall be mailed or delivered to the 22 clerk of the county commission of the county in which the voter 23 resides. If a clerk receives a completed mail application form

NOTE: The purpose of this bill is to provide an electronic voter registration system allowing for greater utilization of the Statewide Voter Registration System (SVRS), to allow for use of a designated address for voter registration purposes for participants in the Address Confidentiality Program, to establish an offense and related penalty for tampering with or copying voter registration information collected by third-party registration drives, to delete obsolete language related to manual voter registration systems, to shorten the period of time during which county clerks may enter voter history data into the statewide voter registration system, to clarify certain record-keeping requirements related to confirmation mailings required by the National Voter Registration Act of 1993 and to restrict the public release of voter e-mail addresses.

Strike-throughs indicate language that would be stricken from the present law and underscoring indicates new language that would be added.
