| 14 | Be it enacted by the Legislature of West Virginia: |
| 15 | That the Code of West Virginia, 1931, as amended, be amended |
| 16 | by adding thereto a new section, designated $$20-3-3a$, to read as |
| 17 | follows: |
| 18 | ARTICLE 3. FORESTS AND WILDLIFE AREAS |
| 19 | §20-3-3a. Providing special outdoor recreational opportunities for |
| 20 | eligible veterans and members of the Armed Forces. |
| 21 | (a) The Division of Natural Resources shall designate one or |
| 22 | more areas of state wildlife management areas as a "Wounded Warrior |
| 23 | Special Hunt Area" to honor wounded veterans and members of the |
| 24 | Armed Forces. The purpose of such designated areas is to provide |
| 25 | special outdoor recreational opportunities for eligible veterans |

- 2 (b) Guest admittance to such designated areas shall be limited
- 3 to any person who:
- 4 (1) Is an active duty member of any branch of the United
- 5 States Armed Forces and has a combat-related injury as determined
- 6 by his or her branch of the United States Armed Forces; or
- 7 (2) Is an honorably discharged veteran of the United States
- 8 Armed Forces and:
- 9 (A) Has a service-connected disability as determined by the
- 10 <u>United States Department of Veterans Affairs; or</u>
- 11 (B) Was discharged or released from military service because
- 12 of a disability acquired or aggravated while serving on active
- 13 duty.
- 14 (c) The division may grant admittance to such designated areas
- 15 to a person who is not an eligible veteran or member of the Armed
- 16 Forces for purposes of accompanying an eligible veteran or member
- 17 of the Armed Forces who requires the person's assistance to use
- 18 such designated areas.
- 19 (d) The director shall propose rules for legislative approval
- 20 in accordance with the provisions of article three, chapter twenty-
- 21 nine-a of this code to implement the provisions of this section.

NOTE: The purpose of this bill is to designate one or more areas of state wildlife management areas as a "Wounded Warrior Special Hunt Area" to provide special outdoor recreational

opportunities for eligible veterans and members of the Armed Forces who have certain service related injuries or disabilities.
