13	Be it enacted by the Legislature of West Virginia:
14	That §29-3-5b of the Code of West Virginia, 1931, as amended,
15	be amended and reenacted to read as follows:
16	ARTICLE 3. FIRE PREVENTION AND CONTROL ACT.
17	§29-3-5b. Promulgation of rules and statewide building code.
18	(a) The State Fire Commission shall propose rules for
19	legislative approval in accordance with the provisions of article
20	three, chapter twenty-nine-a of this code to safeguard life and
21	property and to ensure the quality of construction of all
22	structures erected or renovated throughout this state through the
23	adoption of a State Building Code. The rules shall be in

- 1 accordance with standard safe practices so embodied in widely
- 2 recognized standards of good practice for building construction and
- 3 all aspects related thereto and have force and effect in those
- 4 counties and municipalities adopting the State Building Code:
- 5 Provided, That each county or municipality may adopt the code to
- 6 the extent that it is only prospective and not retroactive in its
- 7 application.
- 8 (b) The State Fire Commission has authority to propose rules
- 9 for legislative approval in accordance with the provisions of
- 10 article three, chapter twenty-nine-a of this code, regarding
- 11 building construction, renovation and all other aspects as related

- 3 (d) $\underline{\text{(1)}}$ The State Fire Commission has authority to propose
- 4 rules for legislative approval, in accordance with the provisions

- 6 standards and fee schedules for the licensing, registration,
- 7 certification, regulation and continuing education of persons which
- 8 will conduct inspections relating to the State Building Code, which

1 Whenever any other state law, county or municipal ordinance or 2 regulation of any agency thereof is more stringent or imposes a 3 higher standard than is required by the State Building Code, the 4 provisions of the state law, county or municipal ordinance or 5 regulation of any agency thereof governs if they are not 6 inconsistent with the laws of West Virginia and are not contrary to 7 recognized standards and good engineering practices. 8 question, the decision of the State Fire Commission determines the 9 relative priority of any such state law, county or municipal 10 ordinance or regulation of any agency thereof and determines 11 compliance with State Building Code by officials of the state, 12 counties, municipalities and political subdivisions of the state. 13 (g) Enforcement of the provisions of the State Building Code 14 is the responsibility of the respective local jurisdiction. Also, 15 any county or municipality may enter into an agreement with any 16 other county or municipality to provide inspection and enforcement 17 services: Provided, That any county or municipality may adopt the 18 State Building Code with or without adopting the BOCA National 19 Property Maintenance Code.

20 (h) After the State Fire Commission has promulgated rules as 21 provided in this section, each county or municipality intending to 22 adopt the State Building Code shall notify the State Fire 23 Commission of its intent.

- 1 (i) The State Fire Commission may conduct public meetings in 2 each county or municipality adopting the State Building Code to 3 explain the provisions of the rules.
- (j) The provisions of the State Building Code relating to the construction, repair, alteration, restoration and movement of structures are not mandatory for existing buildings and structures identified and classified by the State Register of Historic Places under the provisions of section eight, article one of this chapter or the National Register of Historic Places, pursuant to 16 U.S.C. S470a. Prior to renovations regarding the application of the State Building Code, in relation to historical preservation of structures identified as such, the authority having jurisdiction shall consult with the Division of Culture and History, State Historic Preservation Office. The final decision is vested in the State Fire Commission. Additions constructed on a historic building are not excluded from complying with the State Building Code.

NOTE: The purpose of this bill is to provide for criminal background checks for home inspector applicants.
