11	A BILL to amend and reenact §18B-4-9 of the Code of West Virginia,
12	1931, as amended, relating to providing for the appointment of
13	veterans' advocates at state institutions of higher education
14	for veterans, current members or reserves of the armed forces
15	of the United States or National Guard who are students; and
16	setting forth the responsibilities of those advocates.
17	Be it enacted by the Legislature of West Virginia:
18	That §18B-4-9 of the Code of West Virginia, 1931, as amended,
19	be amended and reenacted to read as follows:
20	ARTICLE 4. GENERAL ADMINISTRATION.
21	§18B-4-9. Development of services and facilities for student
22	veterans.

- 1 (a) Legislative findings. -- The Legislature finds that
  2 veterans of the Armed Forces of the United States that attend
  3 institutions of higher education in this state have many unique
  4 needs, issues and concerns that most traditional students do not
  5 have. Student veterans that are returning to fulfill their needs
  6 for higher education who have been or during their pursuit of
  7 higher education may be deployed to active duty often face unique
  8 issues and concerns that are unprecedented and unique to the
  9 current generation of veterans of the post 9/11 era of service in
  10 the Armed Forces. Many of these veterans have had or will be
  11 subject to multiple deployments to active duty, including overseas
  12 deployment, resulting in many unique issues and challenges in their
  13 pursuit of higher education.
- 14 (b) Legislative intent. -- It is the intent of the Legislature
  15 that state institutions of higher education provide adequate
  16 services and facilities for student veterans in order to better
  17 serve their unique issues and needs and to make West Virginia's
  18 state institutions of higher education veteran-friendly.
- 19 (c) The commission and council each shall establish and 20 implement measures in the state institutions of higher education 21 under their respective jurisdictions to assure that veterans 22 enrolled in the institutions receive services and are provided 23 facilities appropriate for their unique needs, that student

- 1 veterans complete programs of study and earn degrees, and that the
- 2 institutions become veteran-friendly by actively and effectively
- 3 providing academic and social support and assistance to student
- 4 veterans. The measures shall include, but are not limited to, the
- 5 following:
- 6 (1) Establishing veteran-friendly community and technical
- 7 college degree programs which recognize and award academic credit
- 8 toward degrees for various types of technical and vocational
- 9 military training and experience;
- 10 (2) Developing policies for each state institutions of higher
- 11 education to grant academic credit for Armed Forces experiences;
- 12 (3) Developing programs to facilitate student veterans in
- 13 sharing their unique knowledge and experience in the military
- 14 through public school programs and local community organizations;
- 15 (4) Establishing and sponsoring an organization for student
- 16 veterans on campus and encouraging other veteran-friendly
- 17 organizations;
- 18 (5) Appointing and training specific faculty within each
- 19 degree program or major as liaisons and contacts for student
- 20 veterans;
- 21 (6) Providing information about the Regents Bachelor of Arts
- 22 Degree program to student veterans and potential student veterans;
- 23 (7) Coordinating existing disability services on campus with

- 1 veteran disability services available from the United States
- 2 Department of Veterans Affairs, other federal and state agencies,
- 3 and private resources;
- 4 (8) Providing counselors on each campus who are trained to
- 5 effectively respond to the unique needs of veterans and to provide
- 6 services or provide referrals to services to fulfill these needs
- 7 for student veterans;
- 8 (9) Developing training materials on responding to student
- 9 veteran needs to be available for continued professional
- 10 development of counselors to student veterans;
- 11 (10) Facilitating regular statewide meetings for all personnel
- 12 at state institutions of higher education who regularly provide
- 13 specific services to student veterans to discuss and develop best
- 14 practices, exchange ideas and experiences, and hear presentations
- 15 by individuals with generally accepted expertise in areas of the
- 16 various needs of student veterans;
- 17 (11) Establishing a procedure to periodically apprise
- 18 appropriate state and federal agencies of the status of student
- 19 veterans in West Virginia;
- 20 (12) Establishing a program to create a collaborative
- 21 relationship between student veterans and alumni of the
- 22 institution, and with prospective employers to facilitate and
- 23 provide employment as well as social opportunities to graduating

- 1 student veterans; and
- 2 (13) Developing and facilitating communications between state
- 3 institutions of higher education and various veteran organizations
- 4 in the state to advance veteran causes that benefit student
- 5 veterans.
- 6 (d) Veterans Advocates. -- Each state institution of higher
- 7 education shall appoint or designate and train a person to serve as
- 8 a veterans advocate on the campus of that institution. The
- 9 commission and council shall also provide training for veterans
- 10 advocates at each of the institutions under their respective
- 11 jurisdictions. The veterans advocate shall serve as the primary
- 12 point of contact and campus advocate for students and prospective
- 13 students who are veterans of the Armed Forces of the United States
- 14 or are current members of the Armed Forces of the United States,
- 15 <u>including reserve components or the National Guard of this state or</u>
- 16 any other state. The duties and responsibilities of the veterans
- 17 advocate include, but are not limited to the following:
- 18 (1) Assist and facilitate student veterans in the utilization
- 19 of services, resources and facilities available at the institution;
- 20 and
- 21 (2) To the extent resources are available for such purposes,
- 22 provide services, programs and assistance to student veterans and
- 23 prospective student veterans designed to encourage, promote and

- 1 facilitate the recruitment, retention and academic success of
- 2 <u>student veterans.</u>
- 3 (d) (e) The commission and council jointly shall submit a
- 4 report to the Legislature on September 1, annually, on the progress
- 5 toward implementing the provisions of this section.

NOTE: The purpose of this bill is to provide for the appointment of veterans advocates at state institutions of higher education. The bill sets forth their responsibilities.

Strike-throughs indicate language that would be stricken from the present law, and underscoring indicates new language that would be added.

This legislation was recommended for introduction and passage during the 2013 Regular Session of the Legislature by the Legislative Select Committee on Veterans' Affairs.
