15	all relating to making it a felony to drive a vehicle while
16	under the influence of alcohol, controlled substance or other
17	drug and cause serious bodily injury to another person; and
18	establishing penalties for first and subsequent violations of
19	certain provisions.
20	Be it enacted by the Legislature of West Virginia:
21	That §17C-5-2 and §17C-5-2b of the Code of West Virginia,
22	1931, as amended, be amended and reenacted; and that \$17C-5A-1,
23	\$17C-5A-2, $$17C-5A-3$ and $$17C-5A-3a$ of said code be amended and
24	reenacted, all to read as follows:

- 1 ARTICLE 5. SERIOUS TRAFFIC OFFENSES.
- 2 §17C-5-2. Driving under influence of alcohol, controlled
- 3 substances or drugs; penalties.
- 4 (a) Any person who:
- 5 (1) Drives a vehicle in this state while he or she:
- 6 (A) Is under the influence of alcohol;
- 7 (B) Is under the influence of any controlled substance;
- 8 (C) Is under the influence of any other drug;
- 9 (D) Is under the combined influence of alcohol and any 10 controlled substance or any other drug; or
- 11 (E) Has an alcohol concentration in his or her blood of eight 12 hundredths of one percent or more, by weight; and
- (2) While driving does any act forbidden by law or fails to 14 perform any duty imposed by law in the driving of the vehicle, 15 which act or failure proximately causes the death of any person 16 within one year next following the act or failure and

- (f) (e) Any person who, being an habitual user of narcotic drugs or amphetamine or any derivative thereof, drives a vehicle in this state is guilty of a misdemeanor and, upon conviction thereof, shall be confined in jail for not less than one day nor more than six months, which jail term is to include actual confinement of not less than twenty-four hours, and shall be fined not less than \$100 nor more than \$500. A person sentenced pursuant to this subdivision shall receive credit for any period of actual confinement he or she served upon arrest for the subject offense.

- (i) (h) Any person under the age of twenty-one years who drives a vehicle in this state while he or she has an alcohol concentration in his or her blood of two hundredths of one percent or more, by weight, but less than eight hundredths of one percent, by weight, for a first offense under this subsection is guilty of a misdemeanor and, upon conviction thereof, shall be fined not less than \$25 nor more than \$100. For a second or subsequent offense under this subsection, the person is guilty of a misdemeanor and, upon conviction thereof, shall be confined in jail for twenty-four hours and shall be fined not less than \$100 nor more than \$500. A

 21 on charge of violation of conditions.
- 22 (a) Except as provided in subsections <u>subsection</u> (g) of this 23 section, whenever any person who has not previously been convicted

- 1 of any offense under this article or under any statute of the
- 2 United States or of any state relating to driving under the
- 3 influence alcohol, any controlled substance or any other drug:
- 4 (1) Notifies the court within thirty days of his or her arrest
- 5 of his or her intention to participate in a deferral pursuant to
- 6 this section; and
- 7 (2) Pleads guilty to or is found guilty of driving under the
- 8 influence of alcohol under subsection $\frac{d}{d}$ (c), section two of this
- 9 article, the court, without entering a judgment of guilt and with
- 10 the consent of the accused, shall defer further proceedings and,
- 11 notwithstanding any provisions of this code to the contrary, place
- 12 him or her on probation, which conditions shall include, that he or
- 13 she successfully completes the Motor Vehicle Alcohol Test and Lock

A copy of the motion 7 shall be served on the prosecuting attorney who shall within thirty 8 days after service advise the judge of any objections to the 9 motion, serving a copy of such objections on the defendant or the 10 defendant's attorney. If there are no objections filed within the 11 thirty-day period, the court shall thereafter dismiss the charges 12 against the defendant. If there are objections filed with regard 13 to the dismissal of charges, the court shall proceed as set forth 14 in subsection (c) of this section.

(e) Except as provided herein, unless a defendant adjudicated pursuant to this subsection be convicted of a subsequent violation of this article, discharge and dismissal under this section shall be without adjudication of guilt and is not a conviction for purposes of disqualifications or disabilities imposed by law upon conviction of a crime except for those provided in article five-a of this chapter. Except as provided in subsection subsections (k), (1) and (m), (j), (k) and (l), section two of this article regarding subsequent offenses, the effect of the dismissal and discharge shall be to restore the person in contemplation of law to

- 15 (a) Any person who is licensed to operate a motor vehicle in
- 16 this state and who drives a motor vehicle in this state shall be
- 17 deemed considered to have given his or her consent by the operation
- 18 thereof, subject to the provisions of this article, to the
- 19 procedure set forth in this article for the determination of
- 20 whether his or her license to operate a motor vehicle in this state
- 21 should be revoked because he or she did drive a motor vehicle while
- 22 under the influence of alcohol, controlled substances or drugs, or
- 23 combined influence of alcohol or controlled substances or drugs, or

(b) Any law-enforcement officer investigating a person for an 10 offense described in section two, article five of this chapter or 11 for an offense described in a municipal ordinance which has the 12 same elements as an offense described in said that section shall 13 report to the Commissioner of the Division of Motor Vehicles by 14 written statement within forty-eight hours of the conclusion of the 15 investigation the name and address of the person believed to have The report shall include the specific 16 committed the offense. 17 offense with which the person is charged and, if applicable, a copy 18 of the results of any secondary tests of blood, breath or urine. 19 The signing of the statement required to be signed by this 20 subsection constitutes an oath or affirmation by the person signing 21 the statement that the statements contained in the statement are 22 true and that any copy filed is a true copy. The statement shall 23 contain upon its face a warning to the officer signing that to 24 willfully sign a statement containing false information concerning 1 any matter or thing, material or not material, is false swearing 2 and is a misdemeanor.

(c) If, upon examination of the written statement of the 4 officer and the tests results described in subsection (b) of this 5 section, the commissioner determines that a person committed an 6 offense described in section two, article five of this chapter or 7 an offense described in a municipal ordinance which has the same 8 elements as an offense described in said section and that the 9 results of any secondary test or tests indicate that at the time 10 the test or tests were administered the person had, in his or her 11 blood, an alcohol concentration of eight hundredths of one percent 12 or more, by weight, or at the time the person committed the offense 13 he or she was under the influence of alcohol, controlled substances 14 or drugs, the commissioner shall make and enter an order revoking 15 or suspending the person's license to operate a motor vehicle in 16 this state. If the results of the tests indicate that at the time 17 the test or tests were administered the person was under the age of 18 twenty-one years and had an alcohol concentration in his or her 19 blood of two hundredths of one percent or more, by weight, but less 20 than eight hundredths of one percent, by weight, the commissioner 21 shall make and enter an order suspending the person's license to 22 operate a motor vehicle in this state. A copy of the order shall 23 be forwarded to the person by registered or certified mail, return 24 receipt requested, and shall contain the reasons for the revocation

- 1 or suspension and describe the applicable revocation or suspension 2 periods provided in section two of this article. A revocation or 3 suspension shall is not become effective until ten days after

- (d) Any law-enforcement officer taking a child into custody under the provisions of section six-a, article five of this chapter who has reasonable cause to believe that the child, at the time of driving the motor vehicle, had an alcohol concentration in his or her blood of two hundredths of one percent or more, by weight, or that the act of the child in driving the motor vehicle was such that it would provide grounds for arrest for an offense defined under the provisions of section two of said that article if the child were an adult, shall report to the Commissioner of the Division of Motor Vehicles by written statement within forty-eight hours the name and address of the child.
- (e) If applicable, the report shall include a description of the specific offense with which the child could have been charged 18 if the child were an adult and a copy of the results of any 19 secondary tests of blood, breath or urine. The signing of the 20 statement required to be signed by this subsection constitutes an 21 oath or affirmation by the person signing the statement that the 22 statements contained in the statement are true and that any copy 23 filed is a true copy. The statement shall contain upon its face a 24 warning to the officer signing that to willfully sign a statement

1 containing false information concerning any matter or thing, 2 material or not material, is false swearing and is a misdemeanor. 2 §17C-5A-3. Safety and treatment program; reissuance of license.

- 3 (a) The Department of Health and Human Resources, Division of 4 Alcoholism and Drug Abuse shall administer a comprehensive safety 5 and treatment program for persons whose licenses have been revoked 6 under the provisions of this article or section seven, article five 7 of this chapter or subsection (6), section five, article three, 8 chapter seventeen-b of this code and shall also establish the 9 minimum qualifications for mental health facilities, day report 10 centers, community correction centers or other public agencies or 11 private entities conducting the safety and treatment program: 12 Provided, That the Department of Health and Human Resources, 13 Division of Alcoholism and Drug Abuse may establish standards 14 whereby the division will accept or approve participation by 15 violators in another treatment program which provides the same or 16 substantially similar benefits as the safety and treatment program 17 established pursuant to this section.
- 18 (b) The program shall include, but not be limited to,
 19 treatment of alcoholism, alcohol and drug abuse, psychological
 20 counseling, educational courses on the dangers of alcohol and drugs
 21 as they relate to driving, defensive driving or other safety
 22 driving instruction and other programs designed to properly
 23 educate, train and rehabilitate the offender.
- 24 (c) The Department of Health and Human Resources, Division of

- 1 Alcoholism and Drug Abuse shall provide for the preparation of an 2 educational and treatment program for each person whose license has 3 been revoked under the provisions of this article or section seven, 4 article five of this chapter or subsection (6), section five, 5 article three, chapter seventeen-b of this code which shall contain 6 the following: (1) A listing and evaluation of the offender's prior 7 traffic record; (2) the characteristics and history of alcohol or 8 drug use, if any; (3) his or her amenability to rehabilitation 9 through the alcohol safety program; and (4) a recommendation as to 10 treatment or rehabilitation and the terms and conditions of the 11 treatment or rehabilitation. The program shall be prepared by 12 persons knowledgeable in the diagnosis of alcohol or drug abuse and 13 treatment.
- (d) There is hereby created a special revenue account within
 the State Treasury known as the Department of Health and Human
 Resources Safety and Treatment Fund. The account shall be
 administered by the Secretary of the Department of Health and Human
 Resources for the purpose of administering the comprehensive safety
 and treatment program established by subsection (a) of this
 section. The account may be invested, and all earnings and
 interest accruing shall be retained in the account. The Auditor
 shall conduct an audit of the fund at least every three fiscal
 years.
- 24 Effective July 1, 2010, the State Treasurer shall make a

- 1 one-time transfer of \$250,000 from the Motor Vehicle Fees Fund into
- 2 the Department of Health and Human Resources Safety and Treatment
- 3 Fund.
- 4 (e) (1) The program provider shall collect the established fee
- 5 from each participant upon enrollment unless the department has
- 6 determined that the participant is an indigent based upon criteria
- 7 established pursuant to legislative rule authorized in this
- 8 section.
- 9 (2) If the department determined that a participant is an
- 10 indigent based upon criteria established pursuant to the
- 11 legislative rule authorized by this section, the department shall
- 12 provide the applicant with proof of its determination regarding
- 13 indigency, which proof the applicant shall present to the interlock
- 14 provider as part of the application process provided in section
- 15 three-a of this article and/or the rules promulgated pursuant
- 16 thereto.
- 17 (3) Program providers shall remit to the Department of Health
- 18 and Human Resources a portion of the fee collected, which shall be
- 19 deposited by the Secretary of the Department of Health and Human
- 20 Resources into the Department of Health and Human Resources Safety
- 21 and Treatment Fund. The Department of Health and Human Resources
- 22 shall reimburse enrollment fees to program providers for each

- (g) The Commissioner of the Division of Motor Vehicles, after giving due consideration to the program developed for the offender, shall prescribe the necessary terms and conditions for the reissuance of the license to operate a motor vehicle in this state revoked under this article or section seven, article five of this chapter or subsection (6), section five, article three, chapter seventeen-b of this code which shall include successful completion of the educational, treatment or rehabilitation program, subject to the following:
- (1) When the period of revocation is six months, the license 21 to operate a motor vehicle in this state may not be reissued until: 22 (A) At least ninety days have elapsed from the date of the initial 23 revocation, during which time the revocation was actually in 24 effect; (B) the offender has successfully completed the program; (C)

- 1 all costs of the program and administration have been paid; and (D) 2 all costs assessed as a result of a revocation hearing have been 3 paid.
- 4 (2) When the period of revocation is for a period of one year 5 or for more than a year, the license to operate a motor vehicle in 6 this state may not be reissued until: (A) At least one-half of the 7 time period has elapsed from the date of the initial revocation, 8 during which time the revocation was actually in effect; (B) the 9 offender has successfully completed the program; (C) all costs of 10 the program and administration have been paid; and (D) all costs 11 assessed as a result of a revocation hearing have been paid. 12 Notwithstanding any provision in this code, a person whose license 13 is revoked for refusing to take a chemical test as required by 14 section seven, article five of this chapter for a first offense is 15 not eligible to reduce the revocation period by completing the 16 safety and treatment program.
- (3) When the period of revocation is for life, the license to 18 operate a motor vehicle in this state may not be reissued until:
 19 (A) At least ten years have elapsed from the date of the initial 20 revocation, during which time the revocation was actually in 21 effect; (B) the offender has successfully completed the program; 22 (C) all costs of the program and administration have been paid; and 23 (D) all costs assessed as a result of a revocation hearing have 24 been paid.

- (4) Notwithstanding any provision of this code or any rule, any mental health facilities or other public agencies or private entities conducting the safety and treatment program when certifying that a person has successfully completed a safety and treatment program shall only have to certify that the person has successfully completed the program.
- (h) (1) The Department of Health and Human Resources, Division 8 of Alcoholism and Drug Abuse shall provide for the preparation of 9 an educational program for each person whose license has been 10 suspended for sixty days pursuant to the provisions of subsection 11 (n) (m), section two, article five-a of this chapter. The 12 educational program shall consist of not less than twelve nor more 13 than eighteen hours of actual classroom time.
- (2) When a sixty-day period of suspension has been ordered, the license to operate a motor vehicle may not be reinstated until:

 (A) At least sixty days have elapsed from the date of the initial suspension, during which time the suspension was actually in effect; (B) the offender has successfully completed the educational program; (C) all costs of the program and administration have been paid; and (D) all costs assessed as a result of a suspension has been paid.
- (i) A required component of the treatment program provided in 23 subsection (b) of this section and the education program provided 24 for in subsection (c) of this section shall be participation by the

- 1 violator with a victim impact panel program providing a forum for 2 victims of alcohol and drug-related offenses and offenders to share 3 first-hand experiences on the impact of alcohol and drug-related 4 offenses in their lives. The Department of Health and Human 5 Resources, Division of Alcoholism and Drug Abuse shall propose and 6 implement a plan for victim impact panels where appropriate numbers 7 of victims are available and willing to participate and shall 8 establish guidelines for other innovative programs which may be 9 substituted where the victims are not available to assist persons 10 whose licenses have been suspended or revoked for alcohol and 11 drug-related offenses to gain a full understanding of the severity 12 of their offenses in terms of the impact of the offenses on victims 13 and offenders. The plan shall require, at a minimum, discussion 14 and consideration of the following:
- 15 (A) Economic losses suffered by victims or offenders;
- 16 (B) Death or physical injuries suffered by victims or 17 offenders;
- 18 (C) Psychological injuries suffered by victims or offenders;
- 19 (D) Changes in the personal welfare or familial relationships 20 of victims or offenders; and
- 21 (E) Other information relating to the impact of alcohol and
- 22 drug-related offenses upon victims or offenders.
- The Department of Health and Human Resources, Division of Alcoholism and Drug Abuse shall ensure that any meetings between

- 1 victims and offenders shall be nonconfrontational and ensure the 2 physical safety of the persons involved.
- (j)(1) The Secretary of the Department of Health and Human 4 Resources shall promulgate a rule for legislative approval in 5 accordance with article three, chapter twenty-nine-a of this code 6 to administer the provisions of this section and establish a fee to 7 be collected from each offender enrolled in the safety and 8 treatment program. The rule shall include: (A) A reimbursement 9 mechanism to program providers of required fees for the safety and 10 treatment program for indigent offenders, criteria for determining 11 eligibility of indigent offenders, and any necessary application 12 forms; and (B) program standards that encompass provider criteria 13 including minimum professional training requirements for providers, 14 curriculum approval, minimum course length requirements and other 15 items that may be necessary to properly implement the provisions of 16 this section.

- (k) Nothing in this section may be construed to prohibit day 22 report or community correction programs, authorized pursuant to 23 article eleven-c, chapter sixty-two of this code, from 24 administering a comprehensive safety and treatment program pursuant

1 to this section.

- 2 §17C-5A-3a. Establishment of and participation in the Motor
 3 Vehicle Alcohol Test and Lock Program.
- 4 (a) (1) The Division of Motor Vehicles shall control and 5 regulate a Motor Vehicle Alcohol Test and Lock Program for persons 6 whose licenses have been revoked pursuant to this article or the 7 provisions of article five of this chapter or have been convicted 8 under section two, article five of this chapter, or who are serving 9 a term of a conditional probation pursuant to section two-b, 10 article five of this chapter.
- 12 for persons participating in the program which shall be paid in 13 advance and deposited into the Driver's Rehabilitation Fund: 14 Provided, That on and after July 1, 2007, any unexpended balance 15 remaining in the Driver's Rehabilitation Fund shall be transferred 16 to the Motor Vehicle Fees Fund created under the provisions of 17 section twenty-one, article two, chapter seventeen-a of this code 18 and all further fees collected shall be deposited in that fund.
- 19 (3) (A) Except where specified otherwise, the use of the term 20 "program" in this section refers to the Motor Vehicle Alcohol Test 21 and Lock Program.

(i) A person whose license has been suspended pursuant to the 9 provisions of subsection $\frac{(n)}{(m)}$, section two of this article who 10 has completed the educational program and who has not violated the 11 terms required by the commissioner of the person's participation in 12 the program is entitled to the reinstatement of his or her driver's 13 license six months from the date the person is permitted to operate 14 a motor vehicle by the commissioner. When a license has been 15 reinstated pursuant to this subsection, the records ordering the 16 suspension, records of any administrative hearing, records of any 17 blood alcohol test results and all other records pertaining to the 18 suspension shall be expunded by operation of law: Provided, That 19 a person is entitled to expungement under the provisions of this 20 subsection only once. The expungement shall be accomplished by 21 physically marking the records to show that the records have been 22 expunded and by securely sealing and filing the records. 23 Expungement has the legal effect as if the suspension never 24 occurred. The records may not be disclosed or made available for

- (j) In addition to any other penalty imposed by this code, any 7 person who operates a motor vehicle not equipped with an approved 8 motor vehicle alcohol test and lock system during that person's 9 participation in the Motor Vehicle Alcohol Test and Lock Program is 10 guilty of a misdemeanor and, upon conviction thereof, shall be 11 confined in jail for a period not less than one month nor more than 12 six months and fined not less than \$100 nor more than \$500. Any 13 person who attempts to bypass the alcohol test and lock system is 14 quilty of a misdemeanor and, upon conviction thereof, shall be 15 confined in jail not more than six months and fined not less than 16 \$100 nor more than \$1,000: Provided, That notwithstanding any 17 provision of this code to the contrary, a person enrolled and 18 participating in the test and lock program may operate a motor 19 vehicle solely at his or her job site if the operation is a 20 condition of his or her employment. For the purpose of this 21 section, job site does not include any street or highway open to 22 the use of the public for purposes of vehicular traffic.

NOTE: The purpose of this bill is to make it a felony to drive a vehicle while under the influence of alcohol, controlled substance or other drug and proximately cause the death of a person.
