A BILL to transfer land located in the Western District, Taylor County,

West Virginia, from the State of West Virginia to the Taylor

Be it enacted by the Legislature of West Virginia:

## LAND TRANSFER TO TAYLOR COUNTY COMMISSION.

- §1. Transferring land from the State of West Virginia to the Taylor County Commission for the purpose of developing a youth recreational complex.
  - 1 The State of West Virginia is authorized to transfer to the
  - 2 county commission of Taylor County, West Virginia, without

If the property is used for a different purpose or is abandoned by the commission, the ownership of the property shall revert to the State of West Virginia.

NOTE: The purpose of this bill is to transfer certain land located at the institutional farm at Pruntytown from the State of West Virginia to the Taylor County Commission to develop and maintain a youth recreational complex.
