11 AN ACT to amend and reenact article 2, chapter 64 of the Code of  
12 West Virginia, 1931, as amended, relating generally to the  
13 promulgation of administrative rules by the Department of  
14 Administration; legislative mandate or authorization for the  
15 promulgation of certain legislative rules by various executive  
16 or administrative agencies of the state; authorizing certain  
17 of the agencies to promulgate certain legislative rules in the  
18 form that the rules were filed in the State Register;  
19 authorizing certain of the agencies to promulgate certain  
20 legislative rules with various modifications presented to and  
21 recommended by the Legislative Rule-Making Review Committee;  
22 authorizing the Department of Administration to promulgate a  
23 legislative rule relating to state-owned vehicles; and  
24 authorizing the Consolidated Public Retirement Board to

1 promulgate a legislative rule relating to the Public Employees  
2 Retirement System.

3 *Be it enacted by the Legislature of West Virginia:*

4 That article 2, chapter 64 of the Code of West Virginia, 1931,  
5 as amended, be amended and reenacted to read as follows:

6 **ARTICLE 2. AUTHORIZATION FOR DEPARTMENT OF ADMINISTRATION TO**  
7 **PROMULGATE LEGISLATIVE RULES.**

8 **§64-2-1. Department of Administration.**

9 The legislative rule filed in the State Register on July 25,  
10 2013, authorized under the authority of section forty-eight,  
11 article three, chapter five-a of this code, relating to the  
12 Department of Administration (state owned vehicles, 148 CSR 3), is  
13 authorized.

14 **§64-2-2. Consolidated Public Retirement Board.**

15 The legislative rule filed in the State Register on July 25,  
16 2013, authorized under the authority of section one, article ten-d,  
17 chapter five of this code, modified by the Consolidated Public  
18 Retirement Board to meet the objections of the Legislative Rule-  
19 Making Review Committee and refiled in the State Register on August  
20 30, 2013, relating to the Consolidated Public Retirement Board  
21 (Public Employees Retirement System, 162 CSR5), is authorized with  
22 the following amendment:

23 On page three, subsection 8.1, line seventeen, following the  
24 word "System", by inserting a colon and the following: "And

1 provided further, That beginning July 1, 2014, each participating  
2 public employer shall contribute fourteen percent (14%) of each  
3 compensation payment of all its employees who are members of the  
Public Employees Retirement System.".
