11 A BILL to amend the Code of West Virginia, 1931, as amended, by 12 adding thereto a new section, designated §6B-2-5c; to amend said code by adding thereto a new section, designated §19-21A-13 14 4a; and to amend said code by adding thereto a new section, 15 designated §61-10-15a, all relating to elected conservation 16 district supervisors; providing an exemption to qualified 17 elected conservation district supervisors and their immediate family to participate in West Virginia Conservation Agency 18 19 programs from certain provisions of the West Virginia Ethics 20 authorizing emergency and legislative rule-making 21 authority for the State Conservation Committee to establish 22 qualifications for persons, including elected conservation 23 district supervisors and their immediate family, 24 participate in West Virginia Conservation Agency programs; 25 providing that the elected conservation district supervisors cannot participate in establishing the ranking process nor 26
