- 4 (a) During periods when the licensee, certificate holder or 5 registrant is on active duty as a member of the Armed Forces of the 6 United States, the National Guard of this state or any other state, 7 or any other military reserve component and deployed outside of 8 this state, and for six months after discharge from active duty, 9 the license, certification or registration of a person regulated by 10 a board in this chapter shall continue in good standing and shall 11 be renewed without payment of any dues or fees for the maintenance 12 or renewal of the license, certification or registration, and 13 without meeting continuing education requirements for the license, 14 certification or registration, when circumstances associated with 15 military duty prevent the individual from obtaining the required 16 continuing education.
- 17 (b) The licensee shall submit a waiver request to the 18 appropriate board, informing the board of circumstances which 19 include, but are not limited to, deployment outside of the United 20 States or in any combat area. and verify that the individual 21 performs the licensed, certified or registered profession or 22 occupation as part of his or her military duties as annotated in 23 Defense Department Form 214 (DD214).
- 24 (c) During periods when the licensee, certificate holder or

2 as a member of the Armed Forces of the United States, the National
3 Guard of this state or any other state or any other military
4 reserve component and deployed outside of this state, and for six
5 months after discharge from active duty, the license, certification
6 or registration of that person regulated by a board referred to in
7 this chapter, shall continue in good standing and shall be renewed
8 without payment of any dues or fees for the maintenance or renewal
9 of the license, certification or registration, and without meeting
10 continuing education requirements for the license certification or
11 registration when circumstances associated with accompanying a
12 spouse on military duty prevent the individual from obtaining the
13 required continuing education.

14 (d) The licensee shall submit a waiver request to the 15 appropriate board informing the board of these circumstances which 16 include, but are not limited to, deployment outside of the United 17 States or in any combat area.

NOTE: The purpose of this bill is to remove the requirement that a person authorized to practice certain professions verifies that he or she performs the authorized profession as part of his or her military duties as annotated in Defense Department Form 214, in order to be exempt from certain renewal and continuing education requirements.
