12 unappropriated for the fiscal year ending June 30, 2014, to  
13 the Department of Health and Human Resources, Human Rights  
14 Commission, fund 8725, fiscal year 2014, organization 0510, to  
15 the Department of Military Affairs and Public Safety, Adjutant  
16 General - West Virginia National Guard Counterdrug Forfeiture  
17 Fund, fund 8785, fiscal year 2014 organization 0603, to the  
18 Department of Military Affairs and Public Safety, West  
19 Virginia State Police, fund 8741, fiscal year 2014,  
20 organization 0612, and to the Department of Veterans'  
21 Assistance, fund 8858, fiscal year 2014, organization 0613, by  
22 supplementing and amending chapter four, Acts of the  
23 Legislature, regular session, 2013, known as the budget bill.
