10	A BILL to amend and reenact §18-7A-13a of the Code of West
11	Virginia, 1931, as amended, relating to permitting teachers
12	under the State Teachers Retirement System to teach college
13	level courses without loss of retirement annuity or benefits.
14	Be it enacted by the Legislature of West Virginia:
15	That §18-7A-13a of the Code of West Virginia, 1931, as
16	amended, be amended and reenacted to read as follows:
17	ARTICLE 7A. STATE TEACHERS RETIREMENT SYSTEM.
18	§18-7A-13a. Resumption of service by retired teachers.
19	(a) For the purpose of this section, reemployment of a former
20	or retired teacher as a teacher shall in no way impair the
21	teacher's eligibility for a prior service pension or any other
22	benefit provided by this article.
23	(b) Retired teachers who qualified for an annuity because of

1 age or service may not receive prior service allowance from the
2 retirement board when employed as a teacher and when regularly
3 employed by the State of West Virginia. The payment of the
4 allowance shall be discontinued on the first day of the month
5 within which such employment begins and shall be resumed on the
6 first day of the month succeeding the month within which such
7 employment ceases. The annuity paid the teacher on first
8 retirement resulting from the Teachers' Accumulation Fund and the
9 Employers' Accumulation Fund shall continue throughout the
10 governmental service and thereafter according to the option
11 selected by the teacher upon first retirement.

(c) Retired teachers who qualified for an annuity because of disability shall receive no further retirement payments if the retirement board finds that the disability of the teacher no longer exists; payment shall be discontinued on the first day of the month within which the finding is made. If the retired teacher returns to service as a teacher, he or she shall contribute to the Teachers' Accumulation Fund as a member of the system. His or her prior service eligibility, if any, shall not be impaired because of his or her disability retirement. His or her accumulated contributions which were transferred to the benefit fund upon his contributions which were transferred to his or her individual account in the Teachers' Accumulation Fund, minus retirement

- 1 payments received which were not supported by such contributions
- 2 and interest. Upon subsequent retirement, he or she shall receive
- 3 credit for all of his or her contributory experience, anything to
- 4 the contrary in this article notwithstanding.
- 5 (d) Notwithstanding any provision of this code to the
- 6 contrary, a person who retires under the system provided by this
- 7 article may subsequently become employed on either a full-time
- 8 basis, part-time basis or contract basis by any institution of
- 9 higher education without any loss of retirement annuity or
- 10 retirement benefits: if the person's retirement commences between
- 11 the effective date of the enactment of this section in 2002 and
- 12 December 31, 2002: Provided, That the person shall not be eligible
- 13 to participate in any other state retirement system provided by
- 14 this code.
- 15 (e) The retirement board is herewith authorized to require of
- 16 the retired teachers and their employers such reports as it deems
- 17 necessary to effectuate the provisions of this section.

NOTE: The purpose of this bill is to permit retired public school teachers to teach college level courses without loss of retirement benefits.
