24	article, the commission shall transfer all net profits received
25	from the sale of State Parks Benefit Game lottery tickets,

- 1 materials and games to the State Treasurer for deposit into the
- 2 State Parks Lottery Fund established in this section. The
- 3 Legislature may make appropriations from this fund for the
- 4 operational costs of the game. The State Treasurer shall transfer
- 5 funds accrued in the State Parks Lottery Fund to the Division of
- 6 Natural Resources' Parks and Recreation Section upon the written

NOTE: The purpose of this bill is to establish within the West Virginia Lottery the State Parks Benefit Game, and to establish within the State Treasury the State Parks Lottery Fund.
